Land violations committed in May 2023

1 May	0800	In occupied Palestinian territory, opposite the town of Aytarun at points B58/1 and M6/2, an Israeli enemy patrol consisting of a JCB bulldozer, a gravel-spreader, a jackhammer bulldozer, three Defender vehicles and a Humvee approached. Five personnel in military uniform disembarked and engaged in smoothing and clearing work. One of the bulldozers cleared the technical road, and another cleared brush between the technical fence and the withdrawal line (the Blue Line), with its arm crossing the Blue Line. At 1600 hours, the patrol left in the direction of occupied territory.
	1600	In occupied Palestinian territory, opposite the town of Hula, at the Israeli enemy Shaykh Abbad position, a Merkava tank pointed its cannon towards Lebanese territory.
2 May	—	Landmines left behind by the Israeli enemy were detonated as follows: 7 in Yarun, 3 in Naqurah, 7 in Hula and 22 in Amrah.
	0830	In occupied Palestinian territory, opposite the town of Balida, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory.
	1030	In occupied Palestinian territory, near the Israeli enemy position east of Hanitah, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory.
	1820	In occupied Palestinian territory, opposite the town of Wazzani, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory.
3 May	—	Landmines left behind by the Israeli enemy were detonated as follows: 7 in Yarun, 6 in Naqurah, 9 in Hula and 25 in Amrah.
	0630	In occupied Palestinian territory, opposite the town of Wazzani, near pillar No. 40, an Israeli enemy civilian took photographs of the Lebanese side, while a Merkava tank pointed its cannon towards Lebanese territory.
4 May	—	Landmines left behind by the Israeli enemy were detonated as follows: 5 in Yarun, 1 in Naqurah, 1 in Hula and 18 in Amrah.
	2130	In the occupied Shab'a Farms, Israeli enemy personnel fired a flare over the Radar position.
5 May	—	Landmines left behind by the Israeli enemy were detonated as follows: 10 in Arab al-Luwayzah.
6 May	1540	On the outskirts of the town of Kafr Shuba in the locality of Birkat Ba'tha'il, while some individuals were herding livestock, an Israeli enemy foot patrol consisting of eight personnel tried to seize the herd. There were unsuccessful. The individuals fled with the herd towards the

		aforementioned town. At that point, patrol personnel fired in the air towards Lebanese territory above the herd without causing injuries. It later became clear that the Israeli enemy had taken two head of livestock into occupied territory.
8 May	–	Landmines left behind by the Israeli enemy were detonated as follows: 25 in Yarun, 9 in Naqurah and 13 in Amrah.
	0700	In occupied Palestinian territory, opposite the town of Ramiya, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory and a Lebanese army patrol.
9 May	–	Landmines left behind by the Israeli enemy were detonated as follows: 17 in Yarun, 9 in Balida and 9 in Naqurah.
	0700	In occupied Palestinian territory, opposite the town of Ramiya, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory and a Lebanese army patrol.
	0830	In occupied Palestinian territory, opposite the town of Aytarun, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory and a Lebanese army patrol.
	1100	In the occupied Shab'a farms, an Israeli enemy patrol consisting of two Merkava tanks, a black civilian vehicle and twelve infantry personnel approached. They deployed opposite observation post OP2 of the Indian contingent of the United Nations Interim Force in Lebanon (UNIFIL) and threw about 15 smoke bombs, 10 of which landed inside Lebanese territory.
	1200	In occupied Palestinian territory, opposite the town of Aytarun, Israeli enemy soldiers pointed their weapons and the cannon of a Merkava tank towards Lebanese territory.
	1600	In occupied Palestinian territory, opposite the town of Aytarun, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory.
10 May	–	Landmines left behind by the Israeli enemy were detonated as follows: 12 in Yarun, 8 in Balida, 7 in Naqurah, 10 in Arab al-Luwayzah and 12 in Hula.
	0740	In occupied Palestinian territory, opposite the town of Mays al-Jabal, Israeli enemy soldiers pointed their weapons and the cannon of a Merkava tank towards Lebanese territory.
	0800	In occupied Palestinian territory, opposite points B28 and BP10/1, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory.
	0930	In occupied Palestinian territory, opposite the town of Kafr Kila, at the Israeli enemy Jabal al-Tayyarah position, a group of 50 individuals in civilian clothing approached. They scouted the area and photographed the Lebanese side. They left in the direction of occupied territory at 1200 hours.

11 May	–	Landmines left behind by the Israeli enemy were detonated as follows: 7 in Yarun, 15 in Arab al-Luwayzah and 27 in Amrah.
	0800	In occupied Palestinian territory, opposite points B28 and BP10/1, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory.
	1450	In occupied Palestinian territory, opposite the town of Markaba, Israeli enemy soldiers pointed a Humvee-mounted machine gun towards Lebanese territory.
12 May	–	Landmines left behind by the Israeli enemy were detonated as follows: 5 in Yarun, 12 in Balida, 9 in Naqurah and 12 in Amrah.
	1750	In occupied Palestinian territory, opposite the town of Naqurah, Israeli enemy soldiers pointed their weapons towards Lebanese territory.
14 May	0730	In occupied Palestinian territory, opposite the town of Ramiya, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory and a Lebanese army patrol.
	1435	In occupied Palestinian territory, opposite the town of Udaysah, an Israeli enemy group consisting of six personnel in military uniform approached. They scouted the area and photographed the Lebanese side. They left in the direction of occupied territory at 1520 hours.
15 May	–	Landmines left behind by the Israeli enemy were detonated as follows: 20 in Yarun, 12 in Balida, 51 in Amrah and 23 in Hula.
	0720	In occupied Palestinian territory, opposite the town of Mays al-Jabal, Israeli enemy soldiers pointed their weapons and the cannon of a Merkava tank towards Lebanese territory.
	1130	In occupied Palestinian territory, opposite the town of Kafr Kila, at the Israeli enemy Jabal al-Tayyarah position, a group of 60 individuals in civilian clothing approached. They scouted the area and photographed the Lebanese side. They left in the direction of occupied territory at 1200 hours.
	1840	In occupied Palestinian territory, opposite the town of Udaysah, an Israeli enemy group consisting of five personnel in military uniform approached. They scouted the area and photographed the Lebanese side. They left in the direction of occupied territory at 1900 hours.
16 May	–	Landmines left behind by the Israeli enemy were detonated as follows: 13 in Yarun, 3 in Balida, 20 in Arab al-Luwayzah, 9 in Amrah and 10 in Naqurah.
	0800 and 1045	Explosions of unknown origin were heard from inside the occupied Shab'a Farms.
	0800	In occupied Palestinian territory, opposite the town of Ramiya, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory and Lebanese army patrols.
	1500	In occupied Palestinian territory, opposite the town of Udaysah in the area around point TP37, an Israeli enemy group consisting of six personnel in

		military uniform approached. They scouted the area and photographed the Lebanese side. They left in the direction of occupied territory at 1520 hours.
	1830	Inside occupied Palestinian territory, opposite the town of Mays al-Jabal, opposite points B69 and B69(1), a fire broke out. It jumped the withdrawal line (the Blue Line) into Lebanese territory and destroyed an approximately one-dunum area dry brush. It also led to the explosion of a landmine left behind by the Israeli enemy, without injury.
17 May	–	Landmines left behind by the Israeli enemy were detonated as follows: 2 in Balida and 5 in Amrah.
	0800	In occupied Palestinian territory, opposite the town of Ramiya, opposite points B28 and B10/1, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory and Lebanese army patrols.
	1700	In occupied Palestinian territory, opposite the town of Sahl al-Khiyam, Israeli enemy soldiers pointed a Humvee-mounted machine gun towards Lebanese territory.
18 May	–	Landmines left behind by the Israeli enemy were detonated as follows: 6 in Naqurah, 20 in Arab al-Luwayzah, 39 in Amrah and 30 in Hula.
	0800	In occupied Palestinian territory, opposite the town of Ramiya, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory and Lebanese army patrols.
	1200	On the outskirts of the town of Shab'a at Birkat al-Naqqar, opposite observation point OP2 of the UNIFIL Indian contingent, while herder Husayn Zahrah and a Syrian, Yusuf Hamdan, were herding livestock, an Israeli enemy patrol consisting of 15 personnel abducted them and led them about 500 m. towards occupied territory. At 1350 local time, the Israeli enemy released them at the same location.
19 May	–	Landmines left behind by the Israeli enemy were detonated as follows: 8 in Yarun, 6 in Naqurah, 35 in Amrah and 19 in Hula.
21 May	0720	In occupied Palestinian territory, opposite the town of Ramiya, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory and Lebanese army patrols.
	1700	In occupied Palestinian territory, opposite the town of Hula, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory.
22 May	–	Landmines left behind by the Israeli enemy were detonated as follows: 8 in Yarun, 11 in Balida, 7 in Naqurah, 10 in Arab al-Luwayzah and 62 in Amrah.
	0800	In occupied Palestinian territory, opposite the town of Ramiya, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory and Lebanese army patrols.
	0850	In occupied Palestinian territory, opposite the town of Ramiya, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory and Lebanese army patrols.

Eight personnel disembarked and took up combat positions. The digger cleared brush between the technical fence and the withdrawal line (the Blue Line), with its arm crossing the line and operating one metre inside Lebanese territory. The Israeli enemy personnel pointed their weapons at Lebanese army patrols and UNIFIL forces. The work ended at 1620 hours, and the patrol left in the direction of occupied territory.
	1700	In occupied Palestinian territory, opposite the town of Hula, Israeli enemy personnel pointed the cannon of a Merkava tank towards Lebanese territory.
23 May	–	Landmines left behind by the Israeli enemy were detonated as follows: 3 in Yarun, 10 in Balida, 6 in Naqurah, 4 in Amrah and 24 in Hula.
	0800	In occupied Palestinian territory, opposite the town of Hula, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory.
24 May	–	Landmines left behind by the Israeli enemy were detonated as follows: 18 in Yarun, 3 in Hula and 30 in Amrah.
	0800	In occupied Palestinian territory, opposite the town of Hula, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory.
	1130	In occupied Palestinian territory, opposite the town of Kafr Kila in the area around point B82, an Israeli enemy group consisting of 15 personnel in military uniform approached. They scouted the area and photographed the Lebanese side. They left in the direction of occupied territory at 1230 hours.
26 May	–	Landmines left behind by the Israeli enemy were detonated as follows: 6 in Yarun, 18 in Hula and 12 in Amrah.
	1815	In occupied Palestinian territory, opposite the town of Mays al-Jabal, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory and Lebanese army patrols.
27 May	1430	In occupied Palestinian territory, opposite the town of Mays al-Jabal, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory.
	1450	On the outskirts of the town of Shab'a at Jabal al-Shahl, while Isma'il Zahrah was herding livestock, an Israeli enemy foot patrol tried to abduct him. He fled towards the town.
28 May	0800	In occupied Palestinian territory, opposite the town of Ramiya, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory.
	1030	In occupied Palestinian territory, opposite the town of Mays al-Jabal, at points B66 and B66(1), an Israeli enemy patrol consisting of a trench bulldozer and a Defender vehicle approached. The bulldozer smoothed and cleaned the technical road, with its arm crossing the withdrawal line (Blue Line) several times. A Lebanese army topographical team inspected the

		levelling work, and it emerged that there had been a breach of a 580 km ² area (about 100 hundred m. long with a maximum width of 9 m.) inside Lebanese territory.
	1600	On the outskirts of the town of Kafr Shuba at Birkat Ba'tha'il, Israeli enemy diggers crossed the Birkat Ba'tha'il gate and engaged in levelling and the construction of a 1 km road to the areas around of the enemy Summaqah position, escorted by two Merkava tanks and four military vehicles, without violating the withdrawal line (the Blue Line with respect to which Lebanon maintains reservations). The work ended at 1630 hours, and the vehicles left in the direction of occupied territory.
29 May	–	Landmines left behind by the Israeli enemy were detonated as follows: 10 in Naqurah and 16 in Amrah.
	0800	On the outskirts of the town of Kafr Shuba at Birkat Ba'tha'il, the Israeli enemy completed the levelling work with a D9 bulldozer and two diggers. It dug an approximately 300 m long, 3 m deep trench next to the dirt road. It was escorted by two Merkava tanks pointing their cannons towards Lebanese territory, five jeeps and 12 personnel who took up combat positions. The work ended at 1700 hours, and the vehicles left in the direction of occupied territory.
30 May	–	Landmines left behind by the Israeli enemy were detonated as follows: 5 in Yarun, 4 in Balida, 15 in Naqurah, 34 in Amrah and 24 in Hula.
	0800	In occupied Palestinian territory, opposite the town of Ramiya, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory and Lebanese army patrols.
	1145	In occupied Palestinian territory, opposite the town of Kafr Kila in the area around point B82, an Israeli enemy group consisting of 30 personnel in military uniform approached. They scouted the area and photographed the Lebanese side. They left in the direction of occupied territory at 1215 hours.
31 May	–	Landmines left behind by the Israeli enemy were detonated as follows: 7 in Yarun, 11 in Amrah, 11 in Hula, 6 in Balida and 12 in Naqurah.
	0800	In occupied Palestinian territory, opposite the town of Ramiya, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory and Lebanese army patrols.
	1120	In occupied Palestinian territory, on the outskirts of the town of Kafr Shuba, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory and Lebanese army patrols.
