Convinced that the establishment of diplomatic relations corresponds to the interests of both countries and will further strengthen international peace and security,

Have decided to establish diplomatic relations, in accordance with the provisions of the Vienna Convention on Diplomatic Relations of April 18, 1961, as of the date of signing of this Joint Communiqué.
