| 1 August | – | Landmines left behind by the Israeli enemy were detonated as follows: 12 in Blida, 19 in Marun al-Ra's and 6 in Naqurah. |
| | 0800 | In occupied Palestinian territory, opposite the town of Hula, Israeli enemy soldiers pointed their weapons and the cannon of a Merkava tank towards Lebanese territory. They left in the direction of occupied territory at 1700 hours. |
| | 1145 | In occupied Palestinian territory, opposite the town of Markaba, the cannon of a Merkava tank was pointed towards Lebanese territory. |
| | 1340 | In occupied Palestinian territory, opposite the town of Hula, Israeli enemy soldiers pointed their weapons towards Lebanese territory. They left in the direction of occupied territory at 1630 hours. |
| | 1420 | In the occupied Shab'a Farms, an Israeli enemy patrol consisting of a Defender type vehicle arrived at the Birkat al-Naqqar road. Two individuals disembarked and inspected the aforementioned road, proceeding as far as Tallat al-Saddanah, opposite Birkat al-Naqqar, where they surveyed liberated Lebanese territory opposite that location. They left in the direction of occupied territory at 1520 hours. |
| | 1740 | In occupied Palestinian territory, opposite the town of Hula, Israeli enemy soldiers pointed their weapons towards Lebanese territory. They left in the direction of occupied territory at 1800 hours. |
| | 2215 | In occupied Palestinian territory, opposite the town of Sarda, Israeli enemy soldiers pointed a laser towards a civilian who was in Lebanese territory. They left in the direction of occupied territory at 2243 hours. |
| 2 August | – | Landmines left behind by the Israeli enemy were detonated as follows: 6 in Blida, 20 in Marun al-Ra's, 9 in Naqurah, 8 in Amrah, 12 in Arab al-Luwayzah, 38 in Hula and 4 in Mays al-Jabal. |
| | 0800 | In occupied Palestinian territory, opposite the town of Hula, Israeli enemy soldiers pointed their weapons and the cannon of a Merkava tank towards Lebanese territory. They left in the direction of occupied territory at 1700 hours. |
| | 1550 | An Israeli enemy bulldozer that was being used to clear trees opposite the town of Alma al-Sha'b violated the line of withdrawal (Blue Line), crossing some 5 m into Lebanese territory and proceeding on its way for 120 m between points B15(2) and B16. |
| 3 August | – | Landmines left behind by the Israeli enemy were detonated as follows: 10 in Blida, 19 in Marun al-Ra's, 5 in Naqurah, 15 in Amrah and 23 in Hula. |
| | 0800 | In occupied Palestinian territory, opposite point AP184, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory. They left in the direction of occupied territory at 1640 hours. |

| 4 August | – | Landmines left behind by the Israeli enemy were detonated as follows: 9 in Blida, 19 in Marun al-Ra's and 2 in Naqurah. |
| | 2325 | In occupied Palestinian territory, opposite the town of Sarda, Israeli enemy soldiers pointed a laser towards a civilian who was in Lebanese territory. They left in the direction of occupied territory at 2355 hours. |
| 5 August | 1210 | In occupied territory, a bus belonging to the Israeli enemy arrived near the town of Abbasiyat al-Ghajar. Some 20 individuals disembarked and took photographs of the Lebanese side. They left in the direction of occupied territory at 1230 hours. |
| 6 August | 0800 | In occupied Palestinian territory, opposite the town of Hula, an Israeli enemy soldier pointed his weapon towards Lebanese territory. He left in the direction of occupied territory at 1700 hours. |
| 7 August | – | Landmines left behind by the Israeli enemy were detonated as follows: 4 in Yarun, 7 in Blida, 5 in Marun al-Ra's, 7 in Naqurah, 1 in Amrah, 10 in Arab al-Luwayzah, 15 in Hula and 14 in Mays al-Jabal. |
| | 0800 | In occupied Palestinian territory, opposite the town of Hula, an Israeli enemy soldier pointed his weapon towards Lebanese territory. He left in the direction of occupied territory at 1700 hours. |
| 8 August | – | Landmines left behind by the Israeli enemy were detonated as follows: 15 in Yarun, 10 in Blida, 10 in Marun al-Ra's, 6 in Naqurah, 26 in Amrah and 30 in Hula. |
| | 0800 | In occupied Palestinian territory, opposite the town of Hula, an Israeli enemy soldier pointed his weapon towards Lebanese territory. He left in the direction of occupied territory at 1700 hours. |
| | 1720 | As a team of journalists was present on the outskirts of the town of Kafr Shuba, in the Bastra area, enemy soldiers hurled smoke bomb, which fell inside Lebanese territory. No one was harmed. |
| | 2240 | An Israeli enemy patrol comprising two military vehicles approached from occupied Palestinian territory, opposite Sahl al-Khiyam, near point AP5050. Five individuals in military clothing disembarked from the vehicles and inspected the technical fence using searchlights. One of them fired rounds into the air over Lebanese territory, without injuring anyone. The patrol left in the direction of occupied territory at 2320 hours. |
| 9 August | – | Landmines left behind by the Israeli enemy were detonated as follows: 12 in Yarun, 12 in Blida, 15 in Marun al-Ra's, 5 in Naqurah, 5 in Amrah, 15 in Arab al-Luwayzah, 15 in Hula and 10 in Mays al-Jabal. |
| | 0600 | Opposite the town of Aytarun, at the Malikiyah position, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory and Lebanese army patrols. |

| | 0800 | Opposite the town of Aytarun, at the Malikiyah position, 35 Israeli enemy soldiers crossed the technical fence and planted wooden stakes and tied a rope around them. At 0900 hours, the wooden stakes and the rope were removed and soldiers left in the direction of occupied territory. |
| | 0830 | In occupied Palestinian territory, opposite Sahl al-Khiyam, near point 90B, an Israeli enemy soldier pointed his weapon towards Lebanese territory. He left in the direction of occupied territory at 1600 hours. |
| | 1030 | In occupied Palestinian territory, opposite Sahl al-Khiyam, near point B90, an Israeli enemy soldier pointed his weapon towards Lebanese territory. He left in the direction of occupied territory at 1130 hours. |
| 10 August | – | Landmines left behind by the Israeli enemy were detonated as follows: 13 in Blida, 15 in Marun al-Ra's, 3 in Naqurah, 13 in Amrah, 15 in Arab al-Luwayzah, 40 in Hula and 11 in Mays al-Jabal. |
| | 0830 | In occupied Palestinian territory, opposite the town of Hula, Israeli enemy soldiers pointed their weapons towards Lebanese territory. They left in the direction of occupied territory at 1330 hours. |
| | 1100 | In occupied Lebanese territory, opposite R'as al-Naqurah, at point M1, three Israeli enemy civilian workers carried out maintenance work on devices that control the border crossing gate at Ra's al-Naqurah. They left in the direction of occupied territory at 1125 hours. |
| | 1500 | In occupied Palestinian territory, opposite the town of Hula, Israeli enemy soldiers installed three surveillance camera and pointed them towards Lebanese territory. |
| | 1520 | In occupied Palestinian territory, opposite the town of Sahl al-Khiyam, near point B90, an Israeli enemy patrol consisting of one military vehicle and one civilian vehicle approached. Ten individuals in military clothing disembarked and took photographs of the Lebanese side. They left in the direction of occupied territory at 1540 hours. |
| 11 August | – | Landmines left behind by the Israeli enemy were detonated as follows: 9 in Blida, 5 in Marun al-Ra's, 6 in Naqurah, 12 in Amrah, 14 in Arab al-Luwayzah and 48 in Hula. |
| | 1230 | In occupied Palestinian territory, opposite the town of Hula, an Israeli enemy soldier pointed his weapon towards Lebanese territory. He left in the direction of occupied territory at 1255 hours. |
| | 2145 | From occupied Palestinian territory, opposite the town of Alma al-Sha'b, the Israeli enemy fired two flare shells, one of which fell on the outskirts of the town, in Lebanese territory. |
| | 2210 | In occupied Palestinian territory, opposite the town of Bustan, Israeli enemy soldiers conducted a foot patrol between the concrete wall and the technical fence, pointing light sources towards Lebanese territory. The patrol left in the direction of occupied territory at 2230 hours. |
| 12 August | 0732 | In occupied Palestinian territory, opposite the town of Bustan, Israeli enemy soldiers fired towards Lebanese territory. They left in the direction of occupied territory at 0801 hours. |

| 13 August | 0830 | In occupied Palestinian territory, opposite the town of Hula, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory and Lebanese army patrols. |
| | 1300 | In occupied Palestinian territory, opposite the town of Markaba, Israeli enemy soldiers performed maintenance work on surveillance cameras attached to a transmission pole. The cannon of a Merkava tank was pointed towards Lebanese territory during the incident. They left in the direction of occupied territory at 1630 hours. |
| | 1750 | In occupied Palestinian territory, opposite the outskirts of the town of Hula, an Israeli enemy soldier pointed his weapon towards Lebanese territory. He left in the direction of occupied territory at 1805 hours. |
| | 1850 | An Israeli enemy patrol consisting of two Humvee vehicles and a four-wheel drive vehicle approached from occupied territory as a number of Lebanese civilians were present in Lebanese territory on the outskirts of the town of Sardah. Two individuals disembarked, one of whom fired a single round from his weapon towards Lebanese territory, without injuring anyone. The patrol left in the direction of occupied territory at 1920 hours. |
| 14 August | – | Landmines left behind by the Israeli enemy were detonated as follows: 7 in Blida, 8 in Marun al-Ra's and 5 in Naqurah. |
| | 0800 | In occupied Palestinian territory, opposite the town of Markaba, an Israeli enemy soldier pointed the cannon of a Merkava tank towards Lebanese territory. He left in the direction of occupied territory at 1630 hours. |
| | 0830 | In occupied Palestinian territory, opposite the town of Hula, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory. |
| | 1030 | In the occupied Shab'a farms, an Israeli enemy excavator was used to clean the dirt road that runs alongside the technical fence without going across it. The work ended at 1800 hours and the excavator was taken away in the direction of occupied territory. |
| 15 August | – | Landmines left behind by the Israeli enemy were detonated as follows: 10 in Blida, 15 in Marun al-Ra's and 4 in Naqurah. |
| | 0900 | In occupied Palestinian territory, opposite the town of Markaba, an Israeli enemy soldier pointed the cannon of a Merkava tank towards Lebanese territory. He left in the direction of occupied territory at 1630 hours. |
| | 1020 | In the occupied Shab'a farms, an Israeli enemy excavator was used to clean the dirt road that runs alongside the technical fence without going across it. The work ended at 1800 hours and the excavator was taken away in the direction of occupied territory. |
| 16 August | – | Two landmines left behind by the Israeli enemy in the town of Yarun were detonated. |

| | 0800 | In occupied Palestinian territory, opposite the town of Hula, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory. |
| | 0900 | In occupied Palestinian territory, opposite the town of Hula, in the vicinity of the Shaykh Abbad site, an Israeli enemy patrol consisting of two cranes and a truck arrived and engaged in construction work. The work ended at 1600 hours and the patrol left in the direction of occupied territory. |
| | 1130 | An Israeli enemy bulldozer that was being used to level earth opposite the town of Alma al-Sha‘b violated the line of withdrawal (Blue Line), crossing some 5 m into Lebanese territory and proceeding on its way for 30 m in the vicinity of points B14 (1), AP173 and AP174. |
| | 1642 | In occupied Palestinian territory, opposite the town of Hula, Israeli enemy personnel carried out a scouting mission and took photographs of the Lebanese side. |
| | 1655 | On the outskirts of the town of Mays al-Jabal, in the area of Krum al-Marah, opposite point B66, an Israeli enemy patrol arrived as several farmers were ploughing their land. The patrol members hurled a concussion grenade towards the farmers that fell in occupied territory. |
| 17 August | – | Landmines left behind by the Israeli enemy were detonated as follows: 8 in Yarun, 19 in Marun al-Ra’s and 7 in Naqurah. |
| | 0800 | An Israeli enemy patrol consisting of some 20 individuals and several vehicles approached from occupied Palestinian territory, opposite the town of Alma al-Sha‘b, at points AP169 and B14(2). The boom of a Poclain excavator crossed the line of withdrawal (Blue Line) into Lebanese territory opposite point B14(1). Meanwhile, a Merkava tank was positioned opposite the town. The work ended at 1700 hours and all left in the direction of occupied territory. |
| | 0930 | An enemy Israeli patrol consisting of a D9 tracked bulldozer, a Namer armoured vehicle, a Merkava tank and a Defender vehicle approached from occupied Palestinian territory, opposite point 14B. Fifteen individuals disembarked and laid barbed wire (concertina) over a stretch of some 400 m. The bulldozer’s boom violated Lebanese territory at points B14(1) and B14(2). The work ended at 1800 hours and the patrol left in the direction of occupied territory. |
| | 1830 | In occupied Palestinian territory, opposite the town of Markaba, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory. They left in the direction of occupied territory at 1900 hours. |
| 18 August | – | Landmines left behind by the Israeli enemy were detonated as follows: 10 in Yarun, 10 in Marun al-Ra’s and 4 in Naqurah. |
| 20 August | 0900 | In occupied Palestinian territory, opposite the town of Hula, in the vicinity of the Shaykh Abbad site, an Israeli enemy patrol consisting of two cranes and a truck loaded with concrete blocks arrived. The boom of one of the cranes was extended 2 m into Lebanese territory. The patrol left in the direction of occupied territory at 1600 hours. |
| | 1830 | Israeli enemy soldiers at the Abbad position fired at several civilians who were in Lebanese territory on the outskirts of the town of Hula. No one was injured. |

| | 1250 | In occupied Palestinian territory, opposite the town of Kafr Kila, an Israeli enemy group consisting of 12 individuals in military uniform approached. They scouted the area and took photographs of the Lebanese side. They left in the direction of occupied territory at 1315 hours. |
| 22 August | – | Landmines left behind by the Israeli enemy were detonated as follows: 10 in Blida, 4 in Marun al-Ra's, 4 in Naqurah, 57 in Amrah, 10 in Arab al-Luwayzah, 21 in Hula and 2 in Mays al-Jabal. |
| | 1100 | In occupied Palestinian territory, opposite Sahl al-Khiyam, Israeli enemy personnel carried out a scouting mission and took photographs of the Lebanese side. |
| 23 August | – | Landmines left behind by the Israeli enemy were detonated as follows: 8 in Blida, 4 in Marun al-Ra's, 3 in Naqurah, 76 in Amrah, 10 in Arab al-Luwayzah and 4 in Hula. |
| | 1200 | In occupied Palestinian territory, opposite the town of Kafr Kila, an Israeli enemy group consisting of 15 individuals in military uniform approached. They scouted the area and took photographs of the Lebanese side. They left in the direction of occupied territory at 1235 hours. |
| 24 August | – | Landmines left behind by the Israeli enemy were detonated as follows: 9 in Blida, 8 in Marun al-Ra's, 40 in Amrah and 24 in Hula. |
| | 1100 | An Israeli enemy topographic team and a team from the liaison service of the United Nations Interim Force in Lebanon arrived opposite the town of Ayta al-Sha'b, at point BP12. They were accompanied by an enemy patrol consisting of two Merkava tanks and 16 soldiers, who pointed their weapons and the tanks' cannons towards Lebanese territory. In addition, several of the soldiers violated the line of withdrawal (Blue Line). All left in the direction of occupied territory at 1515 hours. |
| 25 August | – | Landmines left behind by the Israeli enemy were detonated as follows: 19 in Yarun, 15 in Blida, 4 in Marun al-Ra's, 8 in Naqurah, 11 in Amrah, 15 in Arab al-Luwayzah, 24 in Hula and 1 in Markaba. |
| 26 August | 1030 | In occupied Palestinian territory, opposite the town of Kafr Shuba, the cannon of a Merkava tank was pointed towards Lebanese territory. The patrol left in the direction of occupied territory at 1258 hours. |
| | 1300 | An enemy Israeli patrol consisting of two vehicles, one of which was a Humvee, approached from occupied Palestinian territory, opposite Sahl al-Khiyam. Two individuals in military uniform disembarked and one of them fired two rounds from his weapon into the air towards Lebanese territory. The patrol left in the direction of occupied territory at 3120 hours. |
| | 1940 | In Lebanese territory, opposite Wadi Hunin, in the vicinity of point B74, a landmine left by the Israeli enemy exploded. |

| 27 August | 1200 | A Humvee vehicle approached from occupied Palestinian territory, opposite points B69(1) and B70. Two Israeli enemy soldiers disembarked, one of whom hurled a percussion grenade that fell and exploded in occupied territory. In addition, they fired into the air in order to intimidate a Lebanese civilian who was on the outskirts of the town, near the line of withdrawal. At 1230 hours, the civilians left and the patrol headed towards occupied territory. |
| | 1730 | As several Lebanese civilians were present in Lebanese territory on the outskirts of the town of Hula, five Israeli enemy soldiers approached from occupied territory and went to the Abbad position, opposite where the Lebanese civilians were located. One of them fired two rounds into the air towards Lebanese territory, without injuring anyone. |
| 28 August | – | Landmines left behind by the Israeli enemy were detonated as follows: 12 in Yarun, 9 in Blida, 5 in Marun al-Ra's, 5 in Naqurah, 6 in Amrah, 15 in Arab al-Luwayzah, 9 in Markaba. |
| | 1230 | In occupied Palestinian territory, opposite Sahl al-Khiyam, near point BP37(2), an Israeli enemy patrol consisting of a Humvee vehicle and a military four-wheel drive vehicle approached from occupied territory. Six individuals in military uniform disembarked and conducted a scouting mission. One of the individuals pointed his weapon towards Lebanese territory. The patrol left in the direction of occupied territory at 1240 hours. |
| 29 August | – | Landmines left behind by the Israeli enemy were detonated as follows: 10 in Marun al-Ra's, 3 in Naqurah, 29 in Blida, 23 in Amrah, 20 in Arab al-Luwayzah, 22 in Hula and 26 in Markaba. |
| | 0800 | In occupied Palestinian territory, opposite the town of Hula, an Israeli enemy patrol monitored the pouring of concrete onto T-wall frames. A patrol member pointed his weapon towards Lebanese territory. The work ended at 1600 hours and the patrol left in the direction of occupied territory. |
| 30 August | – | Landmines left behind by the Israeli enemy were detonated as follows: 8 in Blida, 10 in Marun al-Ra's, 5 in Naqurah, 15 in Amrah, 20 in Arab al-Luwayzah, 36 in Hula and 20 in Markaba. |
| | 1720 | On the outskirts of the town of Hula, in the locality of Abbad, an Israeli enemy patrol approached from occupied territory while several Lebanese civilians were present. The patrol members took photographs of the Lebanese side, and one of them pointed his weapon towards the Lebanese civilians. At 1830 hours, the civilians left and the patrol headed towards occupied territory. |
| 31 August | – | Landmines left behind by the Israeli enemy were detonated as follows: 8 in Blida, 10 in Marun al-Ra's, 3 in Naqurah, 3 in Amrah, 17 in Arab al-Luwayzah, 21 in Hula and 8 in Markaba. |
| | 1100 | On the outskirts of the town of Kafr Shuba, in the locality of Bastra, an Israeli enemy soldier fired a shot into the air in order to intimidate a shepherd who was grazing a herd of livestock. The soldier left in the direction of occupied territory at 1130 hours. |
| | 1815 | In occupied Palestinian territory, opposite the town of Yarun, Israeli enemy soldiers pointed a machine gun mounted on a Humvee vehicle towards Lebanese territory. |

The launch then left in the direction of occupied Palestinian territorial waters. |
| | 0810 | Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for two hours and 10 minutes, proceeding on its way for some 425 m. The launch then left in the direction of occupied Palestinian territorial waters. |
| 4 August | 0620 | Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) of 1 October 2011 for 10 minutes, proceeding on its way for some 465 m. The launch then left in the direction of occupied Palestinian territorial waters. |
| | 0650 | Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for one hour, proceeding on its way for some 388 m. Crew members sounded warning sirens and broadcast over loudspeakers in Hebrew. The launch then left in the direction of occupied Palestinian territorial waters. |
| 5 August | 0635 | Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for one minute, proceeding on its way for some 222 m. The launch then left in the direction of occupied Palestinian territorial waters. |
| | 0715 | Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for 15 minutes, proceeding on its way for some 385 m. The launch then left in the direction of occupied Palestinian territorial waters. |
| 6 August | 0725 | Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for one hour and 50 minutes, proceeding on its way for some 333 m. The launch then left in the direction of occupied Palestinian territorial waters. |
| | 0945 | Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for 25 minutes, proceeding on its way for some 277 m. The launch then left in the direction of occupied Palestinian territorial waters. |
