The Government of the Dominican Republic and the Government of the Republic of Zambia, guided by shared willingness to develop and strengthen the ties of friendship and cooperation between the two countries have agreed to establish diplomatic relations at Ministerial Level.

Both parties wish to manifest their confidence in that the establishment of diplomatic relations will contribute to the development of bilateral cooperation and promotion of international peace and security.

The Government of the Dominican Republic and the Government of the Republic of Zambia reaffirm their will to build their bilateral relations in accordance with the Charter of the United Nations 1945 and the Vienna Convention on Diplomatic Relations, 1961 on the basis of principles of promotion of international peace and security, equality among States, national sovereignty, independence, territorial integrity and non-interference in the internal affairs of others states.

COMUNICADO CONJUNTO SOBRE EL ESTABLECIMIENTO DE RELACIONES DIPLOMÁTICAS ENTRE EL GOBIERNO DE REPÚBLICA DOMINICANA Y EL GOBIERNO DE ZAMBIA

El Gobierno de República Dominicana y el Gobierno de la República de Zambia, guiados por la voluntad común de desarrollar y fortalecer los lazos de amistad y cooperación entre ambos países, han acordado establecer relaciones diplomáticas a nivel Ministerial.

Ambas partes desean manifestar su confianza en que el establecimiento de relaciones diplomáticas contribuirá al desarrollo de la cooperación bilateral y a la promoción de la paz y la seguridad internacionales.
