I. Basis of assessment of Member States’ advances to the Working Capital Fund for 2025

1. Under its resolution [79/261](#) of 24 December 2024, the General Assembly resolved that:

(a) The Working Capital Fund shall be established for 2025 in the amount of 250 million United States dollars;

(b) Member States shall make advances to the Working Capital Fund in accordance with the scale of assessments adopted by the Assembly for contributions of Member States to the budget for 2025;

(c) There shall be set off against this allocation of advances:

(i) Credits to Member States resulting from transfers made in 1959 and 1960 from the surplus account to the Working Capital Fund in an adjusted amount of 1,025,092 dollars;

(ii) Cash advances paid by Member States to the Working Capital Fund for 2024 in accordance with Assembly resolution [78/256](#) of 22 December 2023;

(d) Should the credits and advances paid by any Member State to the Working Capital Fund for 2024 exceed the amount of that Member State’s advance under the provisions of paragraph 1 (b) above, the excess shall be set off against the amount of the contributions payable by the Member State in respect of 2025.

II. Basis of assessment of Member States’ contributions to the United Nations regular budget for 2025

2. Under its resolution [79/259](#) C of 24 December 2024, the General Assembly resolved that the total assessment for 2025 amounted to \$3,754,027,200, and of that amount, \$25,000,000 was to be apportioned in accordance with the scale of assessment for peacekeeping operations of the United Nations for 2025, in line with the decision of the General Assembly reflected in its resolution [78/257](#), in which it decided that the assessment rates applicable to the regular budget were applied to half of the grant to the Peacebuilding Account, while the assessment rates applicable to the financing of United Nations peacekeeping operations were applied to the other half.

III. Basis for credits in respect of the Tax Equalization Fund

3. Under regulation 3.2 (e) of the Financial Regulations and Rules of the United Nations adjustments shall be made to the assessment of Member States in respect of:

Member States’ credits in the Tax Equalization Fund for the financial period estimated to be not required to meet charges for tax refunds during the calendar year and any adjustments in the estimated credits previously taken into account.
