I. Introduction

1. At its 9th plenary meeting, on 11 September 2000, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its fifty-fifth session the item entitled “Report of the Economic and Social Council” and to allocate it to the Second Committee.

2. The Second Committee considered the item at its 32nd, 41st and 42nd meetings, on 8 November and 6 and 8 December 2000. An account of the Committee’s discussion of the item is contained in the relevant summary records (A/C.2/55/SR.32, 41 and 42). Attention is also drawn to the general debate held by the Committee at its 3rd to 7th meetings, on 2, 3 and 5 October (see A/C.2/55/SR.3-7).

II. Consideration of proposals
