Personal profile

The Honourable Chief Justice Richard Allen Banda, SC, is barrister-at-law, having been called to the Bar by the Honourable Society of Gray's Inn in July 1966. After his call to the Bar, he entered the Malawi Government Legal Service where he served in different capacities until 1970, when he was appointed the Director of Public Prosecutions. During this period, he was asked to act as Solicitor General and Secretary for Justice. In April 1972, he was appointed Attorney General, and later in the same year, he was created Senior Counsel and was the first Malawian to be so honoured after independence. The status of Senior Counsel is equivalent to the status of Queens Counsel in England. He served as Attorney General for two years

until 1974, when he was appointed Minister of Justice and Attorney General and was also responsible for the Portfolio of Local Government. He served in these capacities until February 1976, when he left government.

He stayed out of practice for four years until April 1980, when he was reappointed into the Judicial Service to fill the new office of Chief Resident Magistrate. He served in this position for nine months, until November 1980, when he was appointed a judge of the High Court and Supreme Court of Malawi. He served in this position until February 1992, when he was appointed Chief Justice of Malawi. He continues to serve in this position up to the present. Chief Justice Banda was recently appointed an Honorary Life Fellow of the Society of Advanced Legal Studies, a constituent organization of the University of London. In December of the same year, he was appointed Ambassador Extraordinary and Plenipotentiary of His Majesty the King of Morocco to the Hellenic Republic. When his diplomatic mission was over, he returned to the Supreme Court in the capacity of Divisional President.

On 19 June 1990, Mr. Fassi Fihri was appointed Ambassador Extraordinary and Plenipotentiary of His Majesty the King to the Republic of Austria and Permanent Representative of the Kingdom of Morocco to the United Nations Office at Vienna, the United Nations Industrial Development Organization (UNIDO) and the International Atomic Energy Agency (IAEA), where he discharged the function of Governor. He was also required to follow the work of the Organization for Security and Cooperation in Europe (OSCE).

Profile

Judge O-gon Kwon has been in the judiciary as a career judge for more than 20 years. As a judge, he is well known for his amicable personality and fair trial. Also, among Republic of Korea judges, he is classified as an expert in criminal cases: he sat as a criminal judge for almost eight years, either as a judge of a single-judge court or as a presiding judge of a collegiate body (panel of three judges).

His academic excellence was an unprecedented one and his record has not yet been broken: he ranked first in his class in three important academic endeavours, that is, in basic law studies at Seoul National University Law School, in the National Bar Examination and finally in the bar apprenticeship at the Judicial Research and Training Institute of the Supreme Court.

Judge Kwon's career as a judge may seem somewhat peculiar in comparison with ordinary Republic of Korea judges who usually have no experience outside the judiciary: he worked as an Assistant Legal Adviser to the President of the Republic of Korea (1980-1984), as an important staff member in the Judicial Administration (1990-1992) and as an important staff member of the Constitutional Court of the Republic of Korea. Such diverse experience outside the court has afforded him a broader perspective. Moreover, his experience with constitutional adjudication has strengthened his belief in human rights and humanitarianism.

Judge Kwon has constantly engaged in international activities: he graduated from Harvard Law School in 1985 and he was a representative of the Republic of Korea to the Lawasia Conference in 1981 and to the Eleventh Conference of European Constitutional Courts. He also played an important role for the Republic of Korea in joining the Vienna Commission as an observer, while he worked at the Constitutional Court.

Theodor Meron (United States of America)

Professor Meron, currently the Counsellor on International Law to the United States Department of State, is the Charles L. Denison Professor of Law at New York University Law School. He immigrated to the United States in 1978 and became a citizen of the United States in 1984. He received his legal education in the universities of Jerusalem, Harvard, where he received his doctorate, and Cambridge. Since 1978 he has been Professor of International Law at New York University School of Law. Between 1991 and 1995 he was also Professor of International Law at the Graduate Institute of International Studies in Geneva. In 1994 he was named to the Charles L. Denison Chair.

He is a leading scholar of international criminal law, international humanitarian law and human rights. He was a rapporteur of a study group of the Council on Foreign Relations which recommended the establishment of the International Criminal Tribunal for the Former Yugoslavia.

He was Co-Editor-in-Chief of the *American Journal of International Law* (1993-1998) and is now an honorary editor. He is a member of the Board of Editors of the *Yearbook of International Humanitarian Law*, a member of the Council on Foreign Relations, of the American Society of International Law, of the French Society of International Law, of the American Branch of the International Law Association, of the Bar of the State of New York and of the International Institute of Humanitarian Law. He served on the advisory committees or boards of several human rights organizations, including Americas Watch and the International League for Human Rights. In 1990, he was a Public Member of the United States Delegation to the Conference on Security and Cooperation in Europe Conference on Human Dimensions in Copenhagen. In 1998, he served as a member of the United States delegation to the United Nations Conference of Plenipotentiaries on the establishment of an International Criminal Court, at Rome. He served on two sessions of the Preparatory Commission for the Establishment of the International Criminal Court. He was a member of several committees of experts of the International Committee of the Red Cross (ICRC): on Internal Strife, on Environment and Armed Conflicts, and was a member of the steering committee of ICRC experts on Customary Rules of International Humanitarian Law. He is a rapporteur of the Institute of International Law on the universality of jurisdiction for genocide, crimes against humanity and war crimes. He was a counsel and advocate of the United States before the International Court of Justice. He served as consultant to the World Bank, the Asian Development Bank and to the United States Department of State. Professor Meron is fluent in French.

He was a Humanitarian Trust Scholar at the University of Cambridge and Carnegie Lecturer at the Hague Academy of International Law, Fellow of the Rockefeller Foundation, Max Planck Institute Fellow (Heidelberg), Sir Hersch Lauterpacht Memorial Lecturer at the University of Cambridge, Visiting Fellow at All Souls College, Oxford, and a Special Fellow of UNITAR. He has lectured at many universities and at the International Institute of Human Rights (Strasbourg) and presented papers at many conferences. He leads the annual ICRC seminars for United Nations diplomats on humanitarian law at New York University and in Geneva. He leads ICRC seminars on international humanitarian law for university teachers in Geneva. In 1997, he was elected Associate Member of the Institute of International Law. In fall 1999, he was a Visiting Professor of Law at Harvard and

in spring 2000 at the University of California at Berkeley. In March 2000, he was a rapporteur of the committee of legal advisers of the Council of Europe (CAHDI) on the influence of the European Convention of Human Rights on public international law.

Professional career

Mr. Robinson joined the Jamaica Government service in 1968. He worked as a Crown Counsel in the Office of the Director of Public Prosecutions for three years and spent the rest of his Jamaican Government career in the Attorney General's Department. While at the Director of Public Prosecution's Office, he prosecuted the first extradition case in independent Jamaica; he represented the Attorney General's Department in all extradition cases up to 1991. His work as a Crown Counsel included the preparation of indictments and the prosecution of a wide range of criminal offences, including murder, robbery with aggravation and rape. He also represented the Director of Public Prosecutions in the Court of Appeal, and has appeared in Jamaica's highest court, the United Kingdom Privy Council. Mr. Robinson has also prosecuted in court martial.

From 1972 to 1998, Mr. Robinson has worked as Adviser to the Ministry of Foreign Affairs and other ministries on international law and international affairs. An expert in the law of treaties, he has been the leader of several Jamaican delegations in the negotiation of treaties in many areas of international law, including extradition, investment protection, environment, intellectual property, maritime delimitation, privileges and immunities and mutual assistance in criminal matters.

Mr. Robinson was very active in the Sixth (Legal) Committee of the United Nations General Assembly where he was Jamaica's representative for twenty-six years. While taking a broad view on the items in the Sixth Committee, he played a leadership role on several items in the Committee, including succession of States in relation to treaties; the Definition of Aggression, jurisdictional immunities of States and their property; the Status of the Diplomatic Courier and the diplomatic bag; the Draft Code of Crimes against the Peace and Security of Mankind; and the draft statute for an international criminal court.

Mr. Robinson was accredited as a delegate of Jamaica to the United Nations General Assembly in 1982, and served as Jamaica's representative on several United Nations bodies, including the United Nations Commission on International Trade Law (UNCITRAL) and the Commission on Transnational Corporations, of which he was the Chairman at the Commission's twelfth session in 1986. In 1985 Mr. Robinson, at the request of the United Nations Centre on Transnational Corporations (the Centre), prepared a paper on the position of developing countries in relation to a reference to international law in the Draft Code of Conduct for Transnational Corporations. He also, at the request of the Centre, prepared guidelines for the Organisation of Eastern Caribbean States in the negotiation of bilateral investment treaties. In 1997 he chaired the UNCTAD expert meeting on existing bilateral agreements on investments and their developing dimension.

As a member of the International Law Commission, Mr. Robinson made a substantial contribution to the codification and progressive development of international law in all areas of the Commission's work. As a member of the

Commission's Working Group on the statute of an international criminal court, he was active and instrumental in the successful and expeditious elaboration of a draft statute which was adopted by the Commission in 1994 for presentation to the General Assembly at its forty-ninth session and was the basis for the work of the United Nations Preparatory Committee in respect of the Statute for an International Court.

As a member of the Inter-American Commission from 1987 to 1995, Mr. Robinson contributed to the development of a corpus of human rights law for the Inter-American System; in particular, he worked to ensure an appropriate Caribbean contribution to the Commission's work. He also worked to ensure that the Inter-American Human Rights System benefited from the most relevant and applicable features of civil and common law. He represented the Commission in cases heard by the Inter-American Court of Human Rights.

In the course of a professional career of 26 years in international law while in Jamaican Government service, Mr. Robinson represented Jamaica at many plenipotentiary conferences, including the Third United Nations Conference on the Law of the Sea, in which he made a significant contribution to the elaboration of the provisions in the United Nations Convention on the Law of the Sea relating to the limits of national jurisdiction.

Mr. Robinson worked extensively at the regional (OAS) and subregional (Caribbean) level in the field of international law. He participated in many conferences leading to the adoption of several OAS Conventions, including those on Extradition, Mutual Legal Assistance in Criminal Matters, the Forced Disappearance of Persons, Corruption, and Illicit Traffic in Arms. He was the Vice-President of the OAS Specialized Conference on the Inter-American Convention against Corruption. At the Caribbean level, he was involved in the negotiations that led to the adoption of the Treaty establishing the Caribbean Community and Common Market.

He was Jamaica's Legal Adviser in the negotiations that led to the Convention establishing the Association of Caribbean States.

Mr. Robinson contributed in a personal capacity to workshops and symposia in several areas of international law, including the environment, maritime pollution, foreign investment, an international criminal court and the rights of indigenous peoples. He was a member of the UNEP Expert Group on International Environment Law aiming at Sustainable Development.

Mr. Robinson's expertise in international law has led to his being retained as an expert consultant by:

- (a) The Commonwealth Secretariat (Commonwealth Fund for technical cooperation) to advise Commonwealth countries on the negotiation of maritime delimitation treaties;
- (b) The United Nations Centre for Transnational Corporations in the areas of investment treaties and the Draft United Nations Code of Conduct on Transnational Corporations;
- (c) UNCTAD in relation to investment treaties;

(d) The United Nations Environmental Programme (UNEP) in the drafting of a Protocol on Specially Protected Areas and Wildlife for the Wider Caribbean Region.

Mr. Robinson has given lectures and published articles on several areas of international law, including the law of the sea, the protection of foreign investment, extradition, the law of treaties, human rights and treaty negotiations.

Mr. Robinson's background in criminal law, his extensive work in areas such as international human rights law, Truth Commissions, extradition and mutual legal assistance, his academic qualifications and the wealth of his experience in international law ensure that the Tribunal will continue to benefit from his competence and experience in criminal law, especially at the trial level, and expertise in international law; the two qualities most essential to the performance of the work of its judges.

The Tribunal is at a critical stage in its work: in the light of its heavy workload, it is essential that procedures are devised that will at once ensure expeditious and fair trials. The practical experience acquired by Mr. Robinson in the management of cases before the Tribunal since his appointment in November 1998 will contribute significantly to the discharge by the Tribunal of its commitment to meet the legitimate expectation of the international community for fair and expeditious trials. In that regard, Mr. Robinson has worked as a member of the Working Group on Judicial Practices, whose responsibility is to devise procedures for the better management of cases.

Apart from his involvement in establishing procedures for the better management of cases before the Tribunal, Mr. Robinson has also done academic work in the subject areas relevant to the Tribunal's work. His lecture entitled "Ensuring Fair and Expeditious Trials at ICTY", delivered in September 1999 at Leiden University at the commencement of the University's LLM specialization in international criminal law, will be published in the *European Journal of International Law*; additionally, he has written the chapter on "The Missing Crimes" in a book entitled *Commentary on the Rome Statute for an International Criminal Court* (General Editor, Antonio Cassese), to be published by the Oxford University Press.
