The secretariat has the honour to transmit to the Preparatory Committee a note on the accreditation of non-governmental organizations to the Preparatory Committee and the World Conference against Racism, Racial Discrimination, Xenophobia and Related Intolerance.

Note by the Secretariat on NGO accreditation

1. This note provides a list of non-governmental organizations (NGOs) which are not in consultative status with the Economic and Social Council and which are not indigenous peoples or organizations granted standing under Economic and Social Council resolution 1995/32, but which have been recommended by the secretariat to the Bureau for accreditation to the World Conference in the period following the second session of the Preparatory Committee from 6 June to 2 July 2001 (annex I).
2. Of the 546 NGOs listed in annex I, 542 have been approved by the Bureau for accreditation.
3. The Preparatory Committee may wish to note that there are four cases where an asterisk (*) has been placed before the name of an NGO in annex I which means that a Government has commented on that application.
4. In one case, that of the International Lesbian and Gay Association (ILGA), the Malaysian Ambassador in his capacity as chairperson of the Organization of the Islamic Conference (OIC) in Geneva has challenged the accreditation. The letter of the Malaysian Ambassador, the response of ILGA and information concerning the 1994 suspension of ILGA's Consultative Status are appended (annex II).
5. In the three other cases, the Permanent Mission of the People's Republic of Bangladesh to the UN Office in Geneva requested information regarding the registration of these organizations with the NGO Affairs Bureau, Dhaka. The initial letter of the Permanent Mission, the response of the Secretariat, letters from two of the NGOs in question, and a further letter from the Bangladesh Mission requesting additional time (until 23 July 2001) to consider the cases are appended (annex III).
6. With respect to the four NGOs where a Government has commented, the secretariat maintains its recommendation that these NGOs have established their competence and the relevance of their activities to the work of the preparatory committee and the World Conference and that they should therefore be accredited.

The OIC members have expressed their objection to the accreditation of a certain NGO, going under the name of International Lesbian and Gay Association, which is included in the list mentioned above.

The OIC members are of the view that the activities of this particular NGO bear no relation to the lofty objectives and principles of the World Conference and that they are also contrary to the public morality practiced in our societies.

Furthermore, on the basis of information provided by the Office of High Commissioner, the NGO in question had its special consultative status with ECOSOC suspended in 1994 and it has not received any new status yet.

We are replying to the letter of the Organization of the Islamic Conference in Geneva objecting to our request for accreditation to the World Conference against Racism.

We would like to draw the attention of the Preparatory Committee to the aims and objectives of the International Lesbian and Gay Association as set forth in our constitution, and to which all members are required to adhere:

C. AIMS AND OBJECTIVES

1. The Aims and Objectives of ILGA are

- (i) To work for the equality of lesbians, gay men, bisexuals and transgendered people and liberation from all forms of discrimination;
- (ii) To promote the universal respect for and observance of human rights and fundamental freedoms, including the elimination of all forms of discrimination and also including the realisation of the specific provisions of the following international human rights instruments:
 - The International Covenant on Civil and Political Rights;
 - The International Covenant on Economic, Social and Cultural Rights;
 - The International Convention on the Elimination of all forms of Racial Discrimination;
 - The Convention on the Elimination of all forms of Discrimination against Women;
 - The Convention on the Rights of the Child

In addition, while it is true that our consultative status with ECOSOC was suspended in 1994, we were requested - at the initiative of that organization - to resubmit our application; and it is now under consideration. Due to the burden of work of the ECOSOC committee, it was not possible to take a decision on our application at the last meeting. Therefore, it is scheduled for decision at the next meeting, in January 2001.

We hope this adequately answers to the objections raised. If you need any further information, please do not hesitate to contact us.

Reaffirming article 24 of the International Covenant on Civil and Political Rights,⁵⁵ which provides for the right of every child to such measures of protection as are required by his or her status as a minor,

Reaffirming also its resolution 1296 (XLIV) of 23 May 1968 on arrangements for consultation with non-governmental organizations, in which it is stipulated, *inter alia*, that the aims and purposes of non-governmental organizations having consultative status with the Economic and Social Council shall be in conformity with the spirit, purposes and principles of the Charter of the United Nations,

Recalling its decision 1993/329 of 30 July 1993, in which it granted consultative status to the International Lesbian and Gay Association,

Deeply concerned about questions that have been raised about whether member organizations or subsidiaries of the International Lesbian and Gay Association promote or condone paedophilia, contrary to international human rights standards and therefore the spirit, purposes and principles of the Charter of the United Nations,

1. *Decides*, pending a review by the Committee on Non-Governmental Organizations and action by the Economic and Social Council, as provided for in paragraphs 2 and 3 below, and without prejudice to the provisions of paragraph 37 of Council resolution 1296 (XLIV), to suspend the Roster status of the International Lesbian and Gay Association;

2. *Authorizes* the Committee on Non-Governmental Organizations to hold an inter-sessional meeting in order to carry out an inquiry into whether any of the International Lesbian and Gay Association member organizations or subsidiaries promote or condone paedophilia and, after giving the Association an opportunity to present its views and provide further necessary information relevant to the assurances called for in paragraph 3 below, to make a recommendation to the Council concerning the Roster status of the Association;

3. *Decides* to consider reinstating the Roster status of the International Lesbian and Gay Association, upon an appropriate recommendation of the Committee on Non-Governmental Organizations, at such time as the International Lesbian and Gay Association can provide the Council convincing assurances that neither the Association nor its member organizations or subsidiaries promote, condone or seek the legalization of paedophilia.

Enquiries were made from Bangladesh regarding the status of the three NGOs. None of these NGOs have registered themselves with the NGO Affairs Bureau, Dhaka. In Bangladesh there are more than 12,000 NGOs operating in cooperation with the Government and other organizations. It is unfortunate that none of the three NGOs, are registered with the addresses provided in the list accompanying the Note under reference. Bangladesh authorities are, therefore, unable to provide substantive comments on their participation.

Two of the NGOs named have not even provided the office addresses, while the third has provided an office address in Dhaka. It is understood from enquiries that there is an NGO by the same name - Institute for Rural Development with office at Khan Manzil, North Bogra Road, Barisal, Bangladesh and this organization is undertaking activities in that area. The concerned authorities, are therefore, unable to ascertain whether the organization named in the list is the same organization that is operating in Barisal.

There also exists another organization by the name of Parbatya Bouddha Mission having their office in the village Pilotpara, Kamanchari, P.O. & Upa-Zilla Khagrachari - 4400, Khagrachari Hill District, which is running programmes in its own area. It also could not be ascertained whether the organization that has applied i.e. (Parbatya Bouddha Mission) is the same organization mentioned in the said list.

As regards the third NGO in the name of Social Affairs for Development on Human and Natural Advancement (SADHANA), it is also not registered in the address provided in the list.

Under these circumstances, the Government of Bangladesh is unable to agree to the formal recognition of the three NGOs that have been named in the said list. The Permanent Mission has further the honour to suggest that it would be useful if a few more details on the NGOs, including details of their programmes are provided. Such details would certainly facilitate easy establishment of their credentials and thus making comment on their relevance/competence in regards of the subject of the World Conference against Racism.

The Permanent Mission of the People's Republic of Bangladesh avails itself of this opportunity to renew to the Office of the High Commissioner for Human Rights the assurances of its highest consideration.



Your Excellency:

Thank you for drawing to our attention the questions you have concerning three Bangladesh NGOs which have applied for accreditation to the World Conference against Racism, namely, that they may not be registered with the NGO Affairs Bureau in Dhaka at the addresses they provided to the WCAR Secretariat. Let me note the following:

(1) As regards the **Institute for Rural Development (IRD)** which has given us a Dhaka address, the documentation it has provided to the Secretariat states: "IRD is a Voluntary, Nonprofit making National organization, established in 1986. It is registered under the Govt. of Bangladesh Voluntary Social Welfare Agencies (Registration and Control) Ordinance of 1961. It is also registered under the Foreign Donations (Voluntary Activities) registration Rules of 1978."

(2) As regards the **Parbatya Bouddha Mission**, it does provide an alternative address to the one in Dhaka, namely: Pilotpara, Kamalchari Khagrachari Sadar, Khagrachari 4400, Khagrachari Hill Tracts, CHT, Bangladesh. We, therefore, surmise that the organization you refer to with offices in the village of Pilotpara is this same organization.

(3) As regards the **Social Affairs for Development on Human and Natural Advancement (SADHANA)**, it has provided us with its list of Board members and with a copy of its Constitution. I have sent an e-mail to them asking for details of their registration.

In the meantime, I append some of the documentation sent to us by these organizations. Should you wish to see the full files, we will be glad to provide them.




