١- وفقاً لقرارات المجلس الاقتصادي والاجتماعي ذات الصلة، وبخاصة القرار ٣٥/١٩٨٦، يُطلب إلى لجنة حقوق الإنسان أن تقوم في دورتها الثامنة والخمسين بانتخاب نصف أعضاء اللجنة الفرعية والعدد المقابل من المناوبين، إن وجد، وفقاً للنمط التالي: ثلاثة أعضاء من الدول الأفريقية؛ وثلاثة أعضاء من الدول الآسيوية؛ وعضو من دول أوروبا الشرقية؛ وثلاثة أعضاء من دول أمريكا اللاتينية؛ وثلاثة أعضاء من دول أوروبا الغربية ودول أخرى.

٢- وقام الأمين العام، في الوثيقة E/CN.4/2002/100، بإبلاغ اللجنة بالترشيحات الخاصة بالمرشحين والمناوبين للانتخاب في اللجنة الفرعية والتي وردت حتى ١٠ كانون الأول/ديسمبر ٢٠٠١. وقد تضمنت تلك الوثيقة أيضاً البيانات التي وردت عن السيرة الذاتية للمرشحين والمناوبين.

٣- ومنذ ١٠ كانون الأول/ديسمبر ٢٠٠١، وردت ترشيحات وبيانات سير ذاتية إضافية.

٤- وتتضمن هذه الوثيقة القائمة المستوفاة للترشيحات الخاصة بعضوية اللجنة الفرعية وذلك حتى ٢٠ آذار/مارس ٢٠٠٢. وتتضمن هذه الوثيقة أيضاً بيانات السيرة الذاتية التي وردت منذ ١٠ كانون الأول/ديسمبر ٢٠٠١ (انظر المرفق)\*.

Mr. Michael E. SHERIFIS (Expert)

(Nominated by the Government of Cyprus)

1. Ambassador Sherifis has served as a member of the Committee on the Elimination of Racial Discrimination (CERD) from 1994 until March 2002. He has been the Chairman of the Committee from March 2000 until March 2002, and he also served twice as Vice-Chairman. He has been actively involved in the work of the Committee and he has repeatedly chaired a number of its working groups.

2. In June 2001 he was elected Chairman of the meeting of Chairpersons of the United Nations treaty bodies in Geneva.

3. Specifically, with reference to humanitarian issues, Ambassador Sherifis has held, among others, the following assignments:

(a) Head of the delegation of Cyprus to the World Conference against Apartheid, held in Lagos in 1997;

(b) Deputy Head of the delegation of Cyprus to the Conference on Humanitarian Law Applicable in Armed Conflicts, held in Geneva from 1974-1977, which resulted in the adoption of two Protocols Additional to the Geneva Conventions;

(c) Head or Deputy Head of the delegation of Cyprus to several sessions of the United Nations Commission on Human Rights;

(d) Representative of Cyprus to the Third (Humanitarian, Social and Cultural) Committee of the General Assembly in 1968, 1969, 1976, 1977, 1978 and 1979;

(e) Member of the Commonwealth Inter-governmental Committee on the establishment of a new Global Humanitarian Order in 1994-1995, the report of which was adopted by the Commonwealth Summit meeting in New Zealand in September 1995;

(f) Chairman of the Commonwealth Inter-governmental Committee on Refugees and Displaced Persons, the report of which was unanimously adopted by the Commonwealth Heads of State in November 1997.

4. He participated in numerous seminars and lectured extensively at various universities, think-tanks and councils of foreign affairs on issues relating to human rights and international relations.

5. He has university degrees in Law, as well as in Political and Economic Sciences. He speaks Greek, Italian, English and French.

6. Prior to his retirement from the Civil Service in December 1997, he served as Ambassador to the Federal Republic of Yugoslavia from 1983-1985, to Moscow from 1985-1989, to Washington DC from 1989-1993 and to Italy from 1994-1997. He was also non-resident Ambassador to several countries including Canada, Brazil, Ecuador, Malta, Bahamas, Jamaica, Finland, Poland, Czechoslovakia and Switzerland.

7. He has extensive experience within the United Nations system, having served as Permanent Representative to the United Nations Office and the International Organizations in Geneva for four years and as Ambassador-Deputy Permanent Representative in New York from 1980 to 1983.

Mr. Alexandros N. VIKIS (Alternate)

1. Ambassador Vikis has served as Ambassador of the Republic of Cyprus to Mexico, Venezuela, Peru, Ecuador, Bolivia, Panama, Costa Rica, Guatemala, Nicaragua, Cuba and the Dominican Republic.
2. He has very extensive experience with the United Nations system, for many years serving as Permanent Representative, Deputy Permanent Representative and as Director of the office of the Permanent Secretary of the Ministry for Foreign Affairs. He represented Cyprus at the Third Committee of the General Assembly and at the Special Political Committee, among other bodies, for 12 years between 1982 and 1996.
3. As Deputy Permanent Representative to the United Nations in New York, he was in charge of the Third Committee, Security Council matters and other subjects. He also served as the Representative of Cyprus to the Council for Namibia and the Committee for the Inalienable Rights of the Palestinian People from 1983 to 1986.
4. He was the Head or a member of the delegation of Cyprus at several human rights meetings, including the Commission of Human Rights and the World Conference against Racism, Racial Discrimination, Xenophobia and Related Intolerance.
5. As Director of the European Division of the Ministry for Foreign Affairs and later as Director of the Division of International Organizations, Multilateral Affairs and Human Rights, he represented Cyprus at many international conferences.
6. Ambassador Vikis has university degrees in Political Science and International Relations and post-graduate degrees in International Relations and Social Anthropology. He taught Social Anthropology at the American University of Beirut and he worked as a researcher at the Social Research Centre of the Ministry of Education in Cyprus, carrying out anthropological research. Mr. Abdul SATTAR (Expert)

(Nominated by the Government of Pakistan)

Foreign Minister since November 1999, Abdul Sattar was a member of the Foreign Service of Pakistan from 1953, and served in high positions at home and abroad before retirement in 1992.

In the Ministry for Foreign Affairs he was Director-General for South Asia, 1972-1975, Additional Secretary for Asia and the Pacific, 1982-1986, and Foreign Secretary, 1986-1988.

He was Ambassador to Austria and Hungary (and Permanent Representative to IAEA and UNIDO), 1975-1978, to India, 1978-1982 and 1990-1992, and to the USSR, 1988-1990. His other diplomatic assignments were in Saudi Arabia, the Sudan and the United States.

Abdul Sattar was senior member of the Pakistani delegation to the Geneva Conference in 1988 which concluded the accords leading to the withdrawal of Soviet forces from Afghanistan. He headed the Pakistani delegation that negotiated the disengagement of the armies of the two countries following the Brasstacks crisis, 1986. Earlier, in 1972, he was a member of the delegation at the Simla conference.

After retirement, Abdul Sattar served as Foreign Minister in the Caretaker Cabinet of Prime Minister Moeen Qureshi in 1993.

From 1994 to 1999, he participated in several seminars and Track-II meetings on economic, political and security issues, sponsored by academic institutions in Australia, China, Japan, Pakistan and the United States. He also attended Pugwash meetings in Mexico and Italy.

Nuclear issues were the subject of Abdul Sattar's study at the United States Institute of Peace, Washington, DC, where he was a Distinguished Fellow in 1994. His paper, "Reducing nuclear dangers in South Asia", was published in *The Nonproliferation Review*, Monterey, CA., in the Winter 1995 issue. Other articles he published included "Simla Agreement: negotiating under duress", and "Afghanistan: from Jihad to civil war", which were published in the *Journal of the Institute of South Asian Studies*, Islamabad. From 1994 to 1999, he wrote occasional opinion pieces in newspapers and magazines at home and abroad.

He is co-author of *Pakistan in Perspective*, 1947-1997, published by Oxford University Press, Karachi, in 1997.

Abdul Sattar graduated from Forman Christian College, Lahore, and has a Master's degree from the Punjab University and the Fletcher School of Law and Diplomacy, United States of America.

Before joining the Foreign Service, he taught at Lawrence College, Murree Hills.

In college he played basketball, became captain of the college team and member of the Punjab provincial team. Also, he played (non-competitive) tennis.

He was President of the Islamabad Club in 1974.

He has been a member of the Islamabad Council of World Affairs and of the Margala Study Group since 1992.
