#### **Addendum**

1. As regards the chairmanship and vice-chairmanship of the International Civil Service Commission, it is recalled that article 2 of the Commission's statute provides that:

“The Commission shall consist of fifteen members appointed by the General Assembly, of whom two, who shall be designated Chairman and Vice-Chairman, respectively, shall serve full-time.”

2. The vacancies for Chairman and Vice-Chairman of the International Civil Service Commission will occur on 1 January 2003.

3. The Government of Tunisia has put forth a candidate for the position of Chairman of the International Civil Service Commission. The Government of Poland has put forth a candidate for the position of Vice-Chairman.

While managing those two large departments, he was personally involved in the development and implementation of various reform and efficiency measures, in order to provide professional and effective conference and information services to Member States.

Over a long period of time, he participated in the work of United Nations bodies dealing with various aspects of personnel issues. He was Chairman of the Appointments and Promotion Board (1991–1993), of the Steering Committee for the Improvement of the Status of Women in the Secretariat (1989–1992), and of the Publications Board (1982–1993). He was also a member of the Programme Planning and Budgeting Board (1984–1993), and the Secretariat Group on Administrative Reform (1983–1984).

In his country's Civil and Foreign Service, he held a wide range of posts requiring managerial competence. Before assuming his current position, he served as Ambassador, Permanent Representative of Poland to the United Nations. He was the Secretary of State and First Deputy Minister for Foreign Affairs of Poland in 1996 and 1997. From 1994 to 1995, he was the Parliamentary Secretary and Deputy Minister for Foreign Affairs of Poland. During that period (1994–1997), he was Vice-Chairman of his country's delegation to the General Assembly.

From 1973 to 1978 he was his country's Permanent Representative to the United Nations Office in Geneva. In 1978, he became Director of the Department of International Organizations in the Ministry of Foreign Affairs of Poland. His executive career at the Foreign Ministry began as Head of the Treaties Section. Later, he became Deputy Director (1968) and Director (1971) of the Ministry's Legal and Treaties Department.
