Section 22

Economic and social development in Western Asia

(Programme 18 of the medium-term plan for the period 2002-2005)

Overview

- 22.1 The programme of work under this section has been elaborated within the framework of programme 18 of the medium-term plan for the period 2002-2005 and will be implemented by the Economic and Social Commission for Western Asia (ESCWA). It includes six interlinked subprogrammes.
- 22.2 The objective of this programme is to accelerate the pace of economic, social and technological development in the region and to halt the unsustainable exploitation of its natural resources. This can be best served through the facilitation of Arab regional integration, which was mandated as the principal concern for the ESCWA secretariat by the Commission at its twenty-first session.
- 22.3 The ESCWA region is confronted by four principal challenges: (a) the absence of comprehensive, integrated sustainable social policies that take into consideration the economic, social and environmental aspects of development; (b) the need to consider the impact of economic variables on the social dimension of development in addressing the unsustainable economic situation vis-à-vis sustained population growth; (c) the need to respond to the challenges of globalization and trade liberalization under the World Trade Organization (WTO) regime; and (d) the need to keep abreast of the requirements of the rapid pace of the technology revolution and to bridge the digital divide. These considerations are especially important in a region characterized by rapid population growth, conflicts and scarcity of water resources.
- 22.4 The programme, which takes into account the report of the Secretary-General entitled "Strengthening of the United Nations: an agenda for further change" (A/57/387 and Corr.1) and the related General Assembly resolution 57/300, is predicated on the strategic approach of the reform exercise carried out by ESCWA in 2002-2003 and further developed for the biennium 2004-2005. This approach employs rational criteria to emphasize, strengthen or add existing or new elements to the new programme structure. On the basis of this exercise, ESCWA will continue to rationalize its work by focusing on the four pivotal region-specific priority areas at the subprogramme level, which are also central to the Millennium Declaration Goals and the Monterrey and Johannesburg outcomes: (a) managing social policies, given that existing social policies in the ESCWA region are often fragmented; (b) managing water and energy, given the importance of water in a region which is characterized by scarcity of resources, most of which are shared, and which are offset by abundant energy resources; (c) managing globalization, the driving force in world economic developments; and (d) managing technology, an issue of special importance owing to the considerable digital divide that characterizes this region. Task-oriented intra- and interdivisional work teams will follow a holistic multidisciplinary approach to the implementation of the programme of work that underlines the strong linkages among the four priorities identified. Corresponding changes were introduced to the organizational structure to accommodate these priorities.
- 22.5 The programme will continue to pursue its objectives by reorienting its work in the area of social development to focus on raising the member States' awareness of the need for widening the scope of the social aspects of development to cover pressing issues and to formulate integrated and sustainable social policies. The integration of the industrial and agricultural sectors with energy, environment and water disciplines at ESCWA was intended to consolidate the programme of work and to improve multidisciplinary synergies, eliminate redundancies and increase focus since the

agricultural sector is the primary consumer of water and the industrial sector of energy. Combining issues that deal with globalization and regional integration under one subprogramme is also emblematic of ESCWA attempts to draw on synergies in its work since regional economic integration could be a catalytic step towards integration into the world economy. Placing transport issues under the subprogramme that deals with globalization also serves the realization of programmatic synergies since transport facilitation is closely related to trade facilitation, a key issue under the WTO regime.

- 22.6 ESCWA will also assist its member States with accession to WTO and implementation of the related agreements and position them for competition in regional and international markets. It will attempt to stress the relative importance of knowledge-based industries as a leading sector of the global economy, which could drive regional development and introduce information and communication technologies as a tool for poverty reduction and job creation, which could lead to a better quality of life without enormous investments or environmental damage. Thus, subprogramme 5 in its entirety has been dedicated to this purpose. Furthermore, ESCWA will assist member countries to increase their capacity to assess quantitatively economic and financial data and trends and coordinate economic policies to achieve the economic development of the region through subprogramme 3, which has been explicitly dedicated to this purpose.
- 22.7 The programme will continue to serve as a forum for articulating the concerns of the member countries, facilitating dialogue and exchanging best practices. It will further continue to assist member States by raising awareness of the principal issues of concern and providing advocacy in facilitating consensus and the adoption of regional positions vis-à-vis issues discussed at global forums.
- 22.8 ESCWA will carry out its activities in cooperation with organizations of the United Nations system, regional and international entities. Chief among those are the Department of Economic and Social Affairs, the United Nations Conference on Trade and Development (UNCTAD), other United Nations regional commissions, the United Nations Development Programme (UNDP), the International Labour Organization (ILO), the United Nations Environment Programme (UNEP), the Food and Agriculture Organization of the United Nations (FAO), the Office of the High Representative for Least Developed Countries, Landlocked Developing Countries and Small Island Developing States, the Bretton Woods Institutions and WTO. Some regional level partners are the League of Arab States and the Arab Fund for Economic and Social Development and its subsidiary bodies. Collaboration and cooperation will include organizing joint meetings, preparing joint studies and sharing information and experience. Efforts will continue to enhance cooperation among regional United Nations entities through the Regional Coordination Group. ESCWA will also exert efforts to involve civil society institutions in its work.
- 22.9 Rationalization of the number of outputs, initiated in the previous biennium within the framework of the restructuring of ESCWA programmes, has resulted in a 15 per cent reduction, mostly in non-recurrent publications, in the 2002-2003 programme. There will be a further 12 per cent reduction in 2004-2005. This reduction, which focuses limited resources on key outputs, exhibits significant multidisciplinary synergies and capitalizes on a shift from a quantitative to a qualitative approach to programme formulation so as to optimize programme impact.
- 22.10 The programme's main expected accomplishments and indicators of achievement for the biennium 2004-2005 are detailed, together with the required resources, under the programme of work and under executive direction and management. The overall framework of these expected accomplishments and indicators of achievement is shown in table 22.1 below.

22.11 The resources proposed under this section amount to \$51,066,300, including a resource growth of \$1,223,500 (or 2.4 per cent at 2002-2003 rates). The increase is the result of a range of adjustments in the activities and related resources proposed for this section, as reflected in table 22.4 below, which may be summarized as follows:

- (a) The increase of \$209,900 under executive direction and management is due to the delayed impact of growth in 2002-2003 (\$125,800), and increases of \$27,400 under general temporary assistance and overtime and \$56,700 under expert groups;
- (b) The increase of \$336,400 under the programme of work relates to: (i) the delayed impact of growth in 2002-2003 under subprogramme 6, Comparative statistics for improved planning and decision-making; the reclassification of two P-4 posts to the P-5 level, one under subprogramme 1, Integrated policies for the management of regional resources for sustainable development, and another under subprogramme 4, Regional integration and responding to globalization; and the reclassification of a local level post to P-2/1 under subprogramme 2, Integrated social policies (\$319,900); and (ii) additional requirements of \$16,500 under non-post objects of expenditure resulting from an increase of \$96,700 under general temporary assistance and overtime, largely offset by decreases under consultants and experts (\$61,000) and under travel of staff (\$19,200);
- (c) The increase of \$677,200 under programme support is a net result of additional requirements due to the delayed impact of growth in 2002-2003 (\$1,081,500) and decreased requirements (\$404,300) as a result of changes under various non-post objects of expenditure.

22.12 During the biennium 2004-2005, expected extrabudgetary resources amounting to \$1,400,000 will be utilized to supplement resources from the regular budget to finance activities related to: (a) training to enhance regional capacity for policy analysis; (b) local community development in Arab rural areas; (c) the enhancement of the national capacities of member States in the calculation of purchasing power parities and for preparation of related comparative studies for economic development; and (d) the initiation of pilot facilities in selected ESCWA member countries to demonstrate and evaluate schemes for employment creation and poverty alleviation through new technology.

- 22.13 Owing to the particular situation of the region, ESCWA has always found it difficult to estimate in advance the level of extrabudgetary resources to which it would have access. Owing to the efforts of its secretariat, however, ESCWA has succeeded, in the course of the bienniums 2000-2001 and 2002-2003, in mobilizing more resources than those which had initially been indicated.
- 22.14 The ESCWA secretariat has engaged in consultations on the programme of work with the Advisory Committee established by ESCWA resolution 175 (XV) of 18 May 1989 to facilitate such consultations with member States. The full review of the draft programme of work by ESCWA member States is expected to take place at the twenty-second session of the Commission, in April 2003.
- 22.15 The issue of publications as a part of the programme of work has been reviewed in the context of each subprogramme. It is anticipated that recurrent and non-recurrent publications will be issued as shown below in summary and as distributed in the output information for each subprogramme.

A. Policy-making organs

Resource requirements (before recosting): \$115,500

- 22.17 The Economic and Social Commission for Western Asia comprises 13 member States. The Commission meets biennially, normally at its headquarters. Until 1999, Commission sessions were preceded by a session of the Technical Committee, which was redesignated the Preparatory Committee in accordance with Commission resolution 223 (XX) of 27 May 1999. Pursuant to that resolution, as of 2005, the Preparatory Committee will meet prior to the plenary of the Commission to consider agenda items. Consequently, the Commission's twenty-third session, in 2005, will be preceded by a three-day meeting to be followed by a two-day plenary session of the Commission. The intergovernmental machinery of the Commission includes six subsidiary bodies to assist the Commission on programme matters, such as monitoring and evaluation of programme performance, and to provide advice on the formulation of work programmes in their respective areas of competence. The six intergovernmental committees are: (a) the Statistical Committee; (b) the Committee on Social Development; (c) the Committee on Energy; (d) the Committee on Water Resources; (e) the Committee on Transport; and (f) the Technical Committee on Liberalization of Foreign Trade and Economic Globalization in the countries of the ESCWA region. Five of these six subsidiary bodies hold their sessions biennially, and the Committee on Transport meets annually. During the biennium 2004-2005, the sequence and dates of their sessions will be as follows: the sixth session of the Statistical Committee (3 days in 2004); the fifth session of the Committee on Social Development (3 days in 2004); the fifth session of the Committee on Energy (2 days in 2004); the sixth session of the Committee on Water Resources (3 days in 2004); and the fourth session of the Committee on Liberalization of Foreign Trade and Economic Globalization in the countries of the ESCWA region (2 days in 2005). The Committee on Transport will hold its fifth and sixth sessions, lasting three days each, in 2004 and 2005 respectively.

- 22.18 A provision of \$115,500 under temporary assistance for meetings, at the maintenance level, is required for interpretation, translation and general temporary assistance during the sessions of the Commission, the Preparatory Committee and the six subsidiary committees.

B. Executive direction and management

Resource requirements (before recosting): \$2,794,200

- 22.19 Executive direction and management comprises the functions of the Office of the Executive Secretary and information services.

- 22.20 The Office of the Executive Secretary provides overall direction, programme oversight, planning, coordination and integrated management and policy guidelines for the substantive divisions and for technical cooperation and other support services, including the Statistical Coordination Unit and Conference and Library Services, maintains effective and regular contact with representatives of member States with a view to discussing substantive issues of concern to member States and to the region; ensures more effective collaboration and coordination between ESCWA and the rest of the United Nations Secretariat, specialized agencies, international and regional intergovernmental and non-governmental organizations; and gives overall direction to information services rendered by the ESCWA secretariat.
- 22.21 The Office of the Executive Secretary oversees the functioning of the intergovernmental machinery of the Commission, including its biennial session and its subsidiary bodies. It also coordinates the activities of the secretariat of the Regional Coordination Group, established in 1999 to further facilitate consultations with all United Nations entities in the ESCWA region, and those of the ESCWA Advisory Committee, established by ESCWA resolution 175 (XV) of 18 May 1989 to facilitate consultations between the ESCWA secretariat and member States.
- 22.22 In addition, the Office oversees public information functions through the joint services of the United Nations Information Centre/United Nations Information Services. Activities will aim at increasing public awareness and understanding of the work conducted by the United Nations in general and ESCWA and the United Nations specialized agencies in the home country in particular. They will include the dissemination of information and the launching of media campaigns, the issuance of press releases, bulletins and information kits, the development of quality audio and video programmes, the production of the ESCWA information booklet, interviews, press

conferences, round-table discussions, the preparation of lectures and briefings on United Nations issues and the issuance of occasional pamphlets or brochures to cover special events.

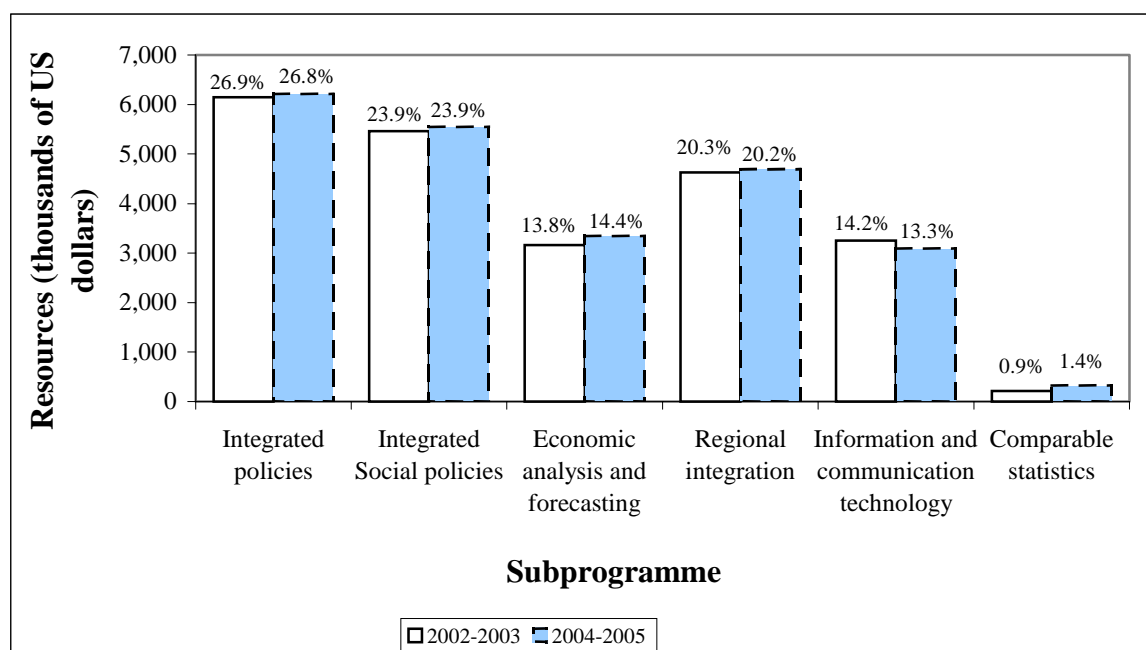
- 22.23 The amount of \$2,794,200 provides for: (a) \$2,585,700 for 16 posts, reflecting an increase of \$125,800 due to the delayed impact of the establishment of a P-4 post for the position of Chief of Protocol/Coordination in 2002-2003; and (b) non-post requirements of \$208,500, reflecting an increase of \$84,100 over the current biennium, due to (i) the decentralization of part of the total overtime provision, previously budgeted under programme support (\$15,200); (ii) a provision for additional temporary assistance in line with the increased responsibilities of the office with regard to administrative direction of the Statistics Coordination Unit and conference and library services (\$12,200); and (iii) additional funds for the biennial meetings of two expert groups that formulate ESCWA policy directives on substantive issues and on promoting regional Arab integration (\$56,700).

External factors

- 22.25 The subprogramme is expected to achieve its objectives and expected accomplishments on the assumption that there is: (a) a desire on the part of member States for partnership and cooperation in planning and managing shared natural resources; (b) the continued availability of extrabudgetary resources; (c) a willingness on the part of member States to adopt technology development policies and institutions; (d) active participation of small and medium-sized enterprises in related ESCWA activities; (e) a willingness on the part of member States to provide data and information for the construction of databases and environmental monitoring; and (f) the availability of sufficient resources for the Governments to undertake the necessary related development measures.

Outputs

- 22.26 During the biennium, the following outputs will be delivered:
- (a) Servicing of intergovernmental and expert bodies:
 - (i) Committee on Water Resources:
 - a. Substantive servicing of six meetings of the sixth session of the Committee on Water Resources;
 - b. Parliamentary documentation: a report to the Commission on the sixth session of the Committee on Water Resources;
 - (ii) Committee on Energy:
 - a. Substantive servicing of four meetings of the fifth session of the Committee on Energy;
 - b. Parliamentary documentation: a report to the Commission on the fifth session of the Committee on Energy;

This Committee coordinates the implementation, by all divisions, of the programme of work, which has been formulated by drawing upon subprogramme 6 of programme 18 of the medium-term plan for the period 2002-2005.

- 22.47 The amount of \$321,700 comprises: (a) \$301,300 for the continued funding of two posts, reflecting the increase of \$104,500 due to the delayed impact of growth in 2002-2003; and (b) \$20,400 under non-post expenditures, reflecting an increase of \$3,500, for the convening of an expert group meeting on the compilation of statistics on trade in services.

D. Programme support

Resource requirements (before recosting): \$24,946,800

- 22.48 Programme support comprises the Administrative Services Division, the Programme Planning and Technical Cooperation Division and the Conference Services Section and Library.

Outputs

- 22.49 The outputs of the Administrative Services Division include the following:
- (a) Overall administration and management: planning, monitoring and evaluating ESCWA regular budget and extrabudgetary activities and technical cooperation programmes;
 - (b) Human resources management: recruitment and placement; provision of staff administration and staff welfare services; training; career development and upgrading of substantive skills; staff-management relations, administration of justice; resolution of disputes and conflicts; provision of medical services and legal advice;
 - (c) Budgetary and financial services: advising the Executive Secretary on all administrative, management, security and organizational matters; provision of guidance, coordination and support services for programme managers in the preparation of programme budget proposals and performance reports; overall control of utilization of regular budget and extrabudgetary resources; provision of accounting services and financial disbursements, including payroll, vendors, per diem and other entitlements; coordination of the Integrated Management Information System (IMIS);

- (d) Electronic data-processing services: provision of information technology services and infrastructure and standardization of software and hardware; provision of in-house programming services for all substantive divisions in order to ensure compatibility with the existing technology as well as to establish a centralized control management system of the Local Area Network (LAN); provision of videoconferencing; enhancement of the ESCWA Internet and Intranet sites;
- (e) General services: administration of the implementation of the headquarters agreement between the United Nations and the host Government; facilities management and maintenance; provision of commercial and procurement services; communications support including satellite, radio network, telephone and fax; transportation, logistic and travel services; liaison with government officials of the host country; protection of personnel and property; provision of postal services; maintenance of central registry and archives system; store and inventory management.

22.50 The outputs of the Programme Planning and Technical Cooperation Division include the following:

- (a) Planning, monitoring and evaluation: programme planning, monitoring and evaluation of the programme of work, regular budget and extrabudgetary activities, including coordination within ESCWA and with other United Nations and non-United Nations organizations;
- (b) Management of technical cooperation activities: provision of administrative backstopping for project formulation, preparation, implementation, monitoring and evaluation; provision of advisory services for member countries, at their request, through a pool of highly qualified experts and assistance in their capacity-building through workshops/seminars; maintaining liaison with United Nations organizations, intergovernmental and non-governmental organizations and donor Governments and agencies, as well as fund-raising.

22.51 The outputs of the Conference Services Section and the Library include the following:

- (a) Conference services: provision of conference services for the policy-making organs of ESCWA and other intergovernmental meetings held under its auspices, including the preparation and coordination of official meetings; provision of interpretation, verbatim reporting, translation, editorial services; documentation and publication services; secretarial and technical support;
- (b) Library services: provision of library services and information for staff, member States, United Nations libraries and depository libraries and other clients; acquisition of publications, databases; indexing of ESCWA documents on the Official Document System to make them available to Internet users; and developing library Internet/Intranet web pages.

- 22.52 The amount of \$24,946,800 is required: (a) \$18,750,000 for the continuation of 159 posts. The increase of \$1,081,500 is due to the delayed impact resulting from growth in 2002-2003; and (b) \$6,196,800 under non-post expenditures, reflecting a decrease of \$404,300, which is the net result of a number of increases and decreases under various objects of expenditure, the bulk of which reflect actual expenditure experience.

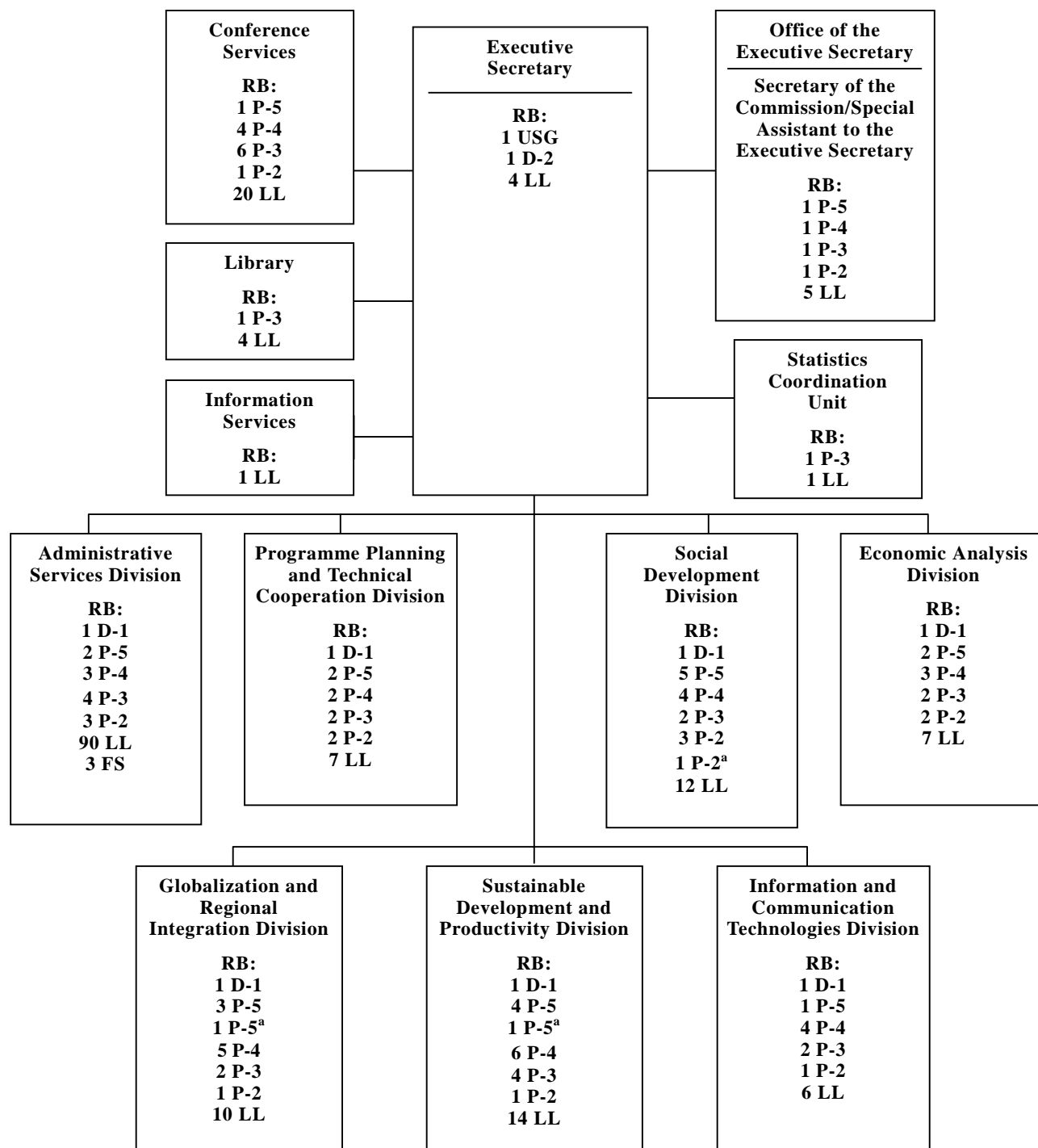
