NOTE VERBALE DATED 8 FEBRUARY 1967 FROM THE MINISTRY OF FOREIGN AFFAIRS
OF THE UNITED REPUBLIC OF TANZANIA ADDRESSED TO THE SECRETARY-GENERAL*

The Ministry of Foreign Affairs of the United Republic of Tanzania presents its compliments to the Secretary-General of the United Nations and has the honour to refer to Your Excellency's Note No. PO 230 SORH (1) of 13 January 1967 requesting information on the measures taken by the Tanzania Government in accordance with the provisions of resolution S/RES/232 (1966) adopted by the Security Council on 16 December 1966 on the question concerning the situation in Southern Rhodesia.

I am enclosing a copy of two Orders on Imports and Exports which "Absolutely prohibit" importation and exportation of all goods from Rhodesia.

Your Excellency will note that the Orders came into force on 12 November 1965 immediately following the Rhodesia rebellion.

Furthermore the Tanzania Government has gone beyond the imposition of the selective mandatory sanctions and has imposed a comprehensive ban on all trade with Rhodesia.

The monthly returns on trade are being compiled and they will soon be forwarded.

The Ministry of Foreign Affairs of the United Republic of Tanzania avails itself of this opportunity to renew to the Secretary-General of the United Nations the assurances of its highest consideration.

THE EAST AFRICAN CUSTOMS MANAGEMENT ACT, 1952

(No. 12 of 1952)

IN EXERCISE of the powers conferred on him by subsection (2) of section 16 of the East African Customs Management Act, 1952, the President of the United Republic of Tanzania hereby makes the following Order

THE PROHIBITED IMPORTS (TANZANIA) ORDER, 1965

1. This Order may be cited as the Prohibited Imports (Tanzania) Order, 1965, and shall come into operation on the 12th day of November 1965.

2. (1) Subject to the provisions of this paragraph, the direct or indirect importation into Tanganyika of any goods from Southern Rhodesia is absolutely prohibited.

(2) Nothing in subparagraph (1) shall apply to -

(a) goods, the property of a person ordinarily resident in Tanzania, which were exported from Southern Rhodesia before the 11th day of November 1965;

(b) used personal or household goods (including motor vehicles and instruments and tools for the owner's personal use in his profession or trade), the property of a person lawfully entering Tanzania;

(c) letters and postcards.

THE EAST AFRICAN CUSTOMS MANAGEMENT ACT, 1952

(No. 12 of 1952)

IN EXERCISE of the powers conferred on him by subsection (2) of section 62 of the East African Customs Management Act, 1952, the President of the United Republic of Tanzania hereby makes the following Order:

THE PROHIBITED EXPORTS (TANZANIA) ORDER, 1965

1. This Order may be cited as the Prohibited Exports (Tanzania) Order, 1965, and shall come into operation on the 12th day of November 1965.

2. (1) Subject to the provisions of this paragraph, the exportation from Tanganyika of any goods to, or any goods ultimately destined for, Southern Rhodesia is absolutely prohibited.

(2) Nothing in sub-paragraph (1) shall apply to the clothing or personal effects of a person leaving Tanzania, or to letters and postcards.
