NOTE VERBALE DATED 9 MARCH 1966 FROM THE PERMANENT REPRESENTATIVE OF
MADAGASCAR TO THE UNITED NATIONS ADDRESSED TO THE SECRETARY-GENERAL

The Permanent Representative of the Malagasy Republic to the United Nations presents his compliments to the Secretary-General of the United Nations and has the honour to transmit to him herewith note No. 045/66 A.E./DRE/API of the Ministry of Foreign Affairs of the Malagasy Republic, dated 14 January 1966, relating to the question of Southern Rhodesia.

The Permanent Representative would be grateful if the Secretary-General would have this note circulated as an official document of the Security Council and of the General Assembly.

The Ministry of Foreign Affairs of the Malagasy Republic presents its compliments to the United Nations Secretariat and has the honour to acknowledge receipt of its note No. PO 230 SORH (1) of 29 November 1965, transmitting resolution 217 (1965), adopted by the Security Council on 20 November 1965, concerning the question of Southern Rhodesia.

The Ministry of Foreign Affairs wishes to state in that connexion that the Malagasy Government has just published decree No. 65-819 of 22 December 1965 prohibiting all commercial relations between the Malagasy Republic and Rhodesia and denying access to its territory to all Rhodesian vessels and aircraft.

The Ministry of Foreign Affairs of the Malagasy Republic takes this opportunity, etc.

DECREE NO. 65-819

prohibiting all commercial relations between the
Malagasy Republic and Rhodesia and denying access
to the territory to all Rhodesian vessels and
aircraft.

The President of the Republic, Head of the Government,

Having regard to the Constitution;

Having regard to the Charter of the Organization of African Unity, ratified
by decree No. 63-461 of 25 July 1963;

In the Council of Ministers,

Decrees:

Article 1 - All commercial relations between the Malagasy Republic and
Rhodesia are prohibited.

Article 2 - Access to the territory of the Malagasy Republic is denied to
all Rhodesian vessels and aircraft.

Article 3 - This decree shall be registered and published in the Official
Gazette of the Republic.

Done at Tananarive, on 22 December 1965
