## Overview

- 18.1 The Economic and Social Commission for Asia and the Pacific (ESCAP) is responsible for the implementation of the programme of work under this section. The programme is guided by the Commission and its subsidiary organs, namely, the thematic Committees on Poverty Reduction, Managing Globalization and Emerging Social Issues, and eight sectoral subcommittees.
- 18.2 The activities for which ESCAP is responsible fall within the framework of programme 15, Economic and social development in Asia and the Pacific, of the biennial programme plan for the period 2006-2007.
- 18.3 The overall objective of the programme is to promote economic and social development, with special emphasis on increasing access to opportunities for individuals, communities and economies in the Asian and Pacific region, in three key thematic areas as identified by the Commission, namely, poverty reduction, managing globalization and addressing persistent and emerging social issues.
- 18.4 The internationally agreed goals, including those contained in the Millennium Declaration and the outcomes of key major global conferences, serve as the overarching framework for the programme, with special focus given to Millennium Development Goals 1, 3, 6, 7 and 8 and the key areas with regard to the follow-up to major global conferences, including the International Conference on Financing for Development, the World Summit on Sustainable Development and the World Summit on the Information Society.
- 18.5 "Meeting the challenges in an era of globalization by strengthening regional development cooperation" was the main theme of the commemorative sixtieth session of the Commission in Shanghai. The work of the Commission has been designed to reflect the overall vision contained in the Shanghai Declaration, adopted by the Commission in its resolution 60/1.
- 18.6 ESCAP will build on the comparative advantage of the United Nations in addressing economic and social issues through its convening authority. ESCAP serves as the only comprehensive regional intergovernmental forum in Asia and the Pacific for tackling interrelated development issues within a coherent and integrated framework.
- 18.7 The linkages in the programme's normative, analytical and operational work, a particular feature of the work of the regional commissions, will be strengthened to ensure value added support to members and associate members in their efforts to enhance national capacity in three key areas: (a) formulating economic and social development policies and programmes; (b) negotiating effectively in multilateral and regional forums; and (c) reviewing progress in achieving the internationally agreed goals and targets.
- 18.8 In view of the importance accorded by the Commission to the work of the four ESCAP regional institutions, which are subsidiary bodies of the Commission, the outputs of those institutions have been duly reflected. The four regional institutions are: (a) the Asian and Pacific Centre for Agricultural Engineering and Machinery, based in Beijing; (b) the Asian and Pacific Centre for Transfer of Technology, based in New Delhi; (c) the Centre for Alleviation of Poverty through Secondary Crops Development in Asia and the Pacific, based in Bogor, Indonesia; and (d) the Statistical Institute for Asia and the Pacific, based in Chiba, Japan.
- 18.9 Pursuant to General Assembly resolution 58/269 of 23 December 2003, a new subprogramme on development of Pacific island countries and territories has been established to address, in a more coherent manner, the special needs and circumstances of the 19 small island developing countries and territories in the Pacific, which comprise a significant portion of the Commission's membership. The overall objective of this subprogramme, which will be implemented by the

ESCAP Pacific Operations Centre, based in Suva, is to build policy and management capacity of those countries and territories focusing on the Commission's three thematic priority areas, as outlined in paragraph 18.3.

- 18.10 Emphasis has been given to the special needs of the least developed and landlocked countries as well as economies in transition, which have been mainstreamed in all subprogrammes to ensure that priority is accorded to these special groups of countries in the implementation of the programme of work, particularly in support of the achievement of the Millennium Development Goal of halving extreme poverty by the year 2015.
- 18.11 Recognizing that gender equality is a necessary precondition for the advancement of Asian and Pacific societies, ESCAP has mainstreamed gender into all relevant subprogrammes. The process of assessing the implications for women and men of any planned action, including legislation, policies and programmes, will continue to be accorded priority.
- 18.12 The Commission carries out its activities in cooperation with other departments and offices of the Secretariat, entities of the United Nations system and entities external to the United Nations, including the Asian Development Bank, the Association of Southeast Asian Nations, the Economic Cooperation Organization, the secretariat of the Pacific Community, the Council of Regional Organizations for the Pacific, the Asian Clearing Union, the South Asian Association for Regional Cooperation, the Mekong River Commission, the ESCAP/World Meteorological Organization Typhoon Committee and Panel on Tropical Cyclones, and non-governmental organizations and academic institutions, as well as the private sector. Such collaboration and cooperation include joint planning of programmes and preparation of studies and reports, participating in meetings, knowledge networking and sharing of technical expertise.
- 18.13 The expected accomplishments and indicators of achievement for the Commission in the biennium 2006-2007 are set out in detail, together with estimated resource requirements under programme of work, as well as under executive direction and management. The overall framework of the expected accomplishments and indicators of achievement is shown in table 18.1.

- 18.14 To enable ESCAP to ensure that its programme of work is fully aligned with the priorities of its membership and is also cost-effective and efficient, a rigorous internal review of the existing and planned activities was undertaken. Through this review, which was complemented by an intensive intergovernmental review process by the Advisory Committee of Permanent Representatives and Other Representatives Designated by the Members of the Commission, a series of eight legislative

subcommittees and the Commission, a significant number of outputs of marginal utility were eliminated and replaced by new outputs that are more responsive to the emerging needs of the ESCAP membership.

- 18.15 A rigorous review of the value added by publications to the achievement of the expected accomplishments of each subprogramme under the programme of work was undertaken. That review resulted in the programming of the recurrent and non-recurrent publications summarized below and as distributed in the output information for each subprogramme.

- 18.16 The overall resources required for the biennium 2006-2007 for this section amount to \$65,375,200 before recosting, reflecting an increase of \$308,100 (or 0.5 per cent). The growth shown in table 18.4 can be summarized as follows:

- (a) The decrease of \$5,800 under policymaking organs relates to reduced requirements for travel of conference-servicing staff and expendable conference supplies;
- (b) The increase of \$84,500 under executive direction and management for posts is in response to resolution 59/4 of the Commission on the implementation of the Programme of Action for the Least Developed Countries for the Decade 2001-2010, wherein the Executive Secretary was requested to ensure that the priorities and commitments identified in the Programme of Action were mainstreamed in the programme of work of each subprogramme. In addition, a review of the overall programme management needs of the secretariat resulted in the consolidation of functions for programme planning in the Programme Management Division under programme support. This required the following redeployments: the inward redeployment of a P-3 post and two Local level posts from programme support and the outward redeployment of a P-4 post to programme support;
- (c) The net increase of \$930,500 under programme of work would be utilized to strengthen the linkages between the programme's normative, analytical and operational work and to provide support and align the work of the Commission's regional institutions with the thematic priorities of ESCAP as requested by the Commission at its sixtieth session. This provides for the proposed establishment of one P-5 post in each of the following areas: (i) poverty reduction, focusing on the development of secondary crops under subprogramme 1; (ii) agricultural engineering and machinery development to promote trade and investment under subprogramme 4; and (iii) transfer of technology and promotion of innovative systems under subprogramme 7. Furthermore, to strengthen the new subprogramme 3 on development of Pacific island countries and territories, in accordance with Commission resolutions 60/6 on the revitalization of the United Nations ESCAP Pacific Operations Centre and 60/7 on the Pacific Urban Agenda, the establishment of one P-4 post and the inward redeployment of one Local level post from programme support are proposed. In addition, in pursuance of the regional follow-up of the outcomes of the World Summit on the Information Society, it is proposed that subprogramme 7 be strengthened through the establishment of one P-2 post in exchange for the abolition of one Local level post. The above net increase also takes into account the delayed impact of four P-2 posts established in the biennium 2004-2005. In

summary, the strengthening of the programme of work would result in additional requirements of \$938,800 for posts, partly offset by a decrease in non-post requirements of \$8,300, particularly for consultants;

- (d) Under programme support, the net decrease of \$701,100 relates to a decrease of \$1,071,500 for posts, partly offset by an increase of \$370,400 for non-post costs. ESCAP proposes the abolition of 15 Local level posts, 14 of which are under programme support, because of improved cost-effectiveness realized through the utilization of contractual services, particularly in the areas of information technology and facility management, and increased productivity as a result of increased automation of processes and investment in information technology. In addition, ESCAP proposes the outward redeployment of four posts (1 P-3 and 2 Local level posts to executive direction and management and 1 Local level post to subprogramme 3), offset by the inward redeployment of a P-4 post from executive direction and management. The increase in non-post resources is required mainly to ensure continuity of functions that can be more effectively performed through contractual services in areas where Local level posts are abolished and to provide for additional operating expenses and investment in information technology.

- 18.17 During the biennium 2006-2007, the projected extrabudgetary resources, amounting to \$26,080,900, will be utilized to supplement regular budget resources to implement mandated as well as technical cooperation activities, such as technical advisory services, training, workshops, seminars and field projects, that are required as inputs to the Commission's analytical and normative work and to support Governments, at their request, in the achievement of the Millennium Development Goals and in the implementation of activities related to the outcomes of major global conferences and other key global and regional mandates, as well as to respond to new mandates addressing the impact of the recent South-East Asian/Indian Ocean tsunami. Extrabudgetary resources play a critical role in attaining the expected accomplishments under the programme of work. The projected increase is proposed mainly to fund additional activities associated with the establishment of multi-hazard early warning systems for tsunamis and other natural disasters in the region and is related to increased recognition by donors of the value of the Commission's technical cooperation work in supporting its membership to build capacity in economic and social fields, particularly through regional cooperation.
- 18.18 Pursuant to General Assembly resolution 58/269, resources identified for the conduct of monitoring and evaluation, which are crucial to ensuring that high-quality services are provided to the ESCAP membership, amount to \$825,700 (reflected under subprogrammes 1-8 and programme support), of which \$450,200 is funded under the programme budget (\$380,700 for post-related resources and \$69,500 in non-post resources) and \$375,500 from extrabudgetary resources.
- 18.19 The estimated percentage distribution of the resources of the programme in the biennium 2006-2007 is as shown in table 18.3.
- 18.20 The distribution of resources is summarized in tables 18.4 and 18.5.

## A. Policymaking organs

### *Resource requirements (before recosting): \$855,500*

- 18.21 The Commission, which in 2004 had 53 members and 9 associate member countries and territories, provides overall direction to the work of its secretariat and reports to the Economic and Social Council. It holds regular annual sessions, with each session comprising a senior officials' segment followed by a ministerial segment. An informal session among the heads of delegations during the ministerial segment of each Commission session may be organized, for which simultaneous interpretation is provided.
- 18.22 At its fifty-eighth session, in May 2002, the Commission adopted resolution 58/1 on the restructuring of its conference structure. As a result, the intergovernmental subsidiary bodies of the Commission now comprise three thematic committees and eight subcommittees, namely, the Committee on Poverty Reduction (including the Subcommittee on Poverty Reduction Practices and the Subcommittee on Statistics), the Committee on Managing Globalization (including the Subcommittee on International Trade and Investment, the Subcommittee on Transport Infrastructure and Facilitation and Tourism, the Subcommittee on Environment and Sustainable Development and the Subcommittee on Information, Communication and Space Technology) and the Committee on Emerging Social Issues (including the Subcommittee on Socially Vulnerable Groups and the Subcommittee on Health and Development), as well as two special bodies, the Special Body on Least Developed and Landlocked Developing Countries and the Special Body on Pacific Island Developing Countries. The total duration of the sessions of legislative organs equals 51 meeting days per biennium (for the annual meetings of the Commission, three committees, eight subcommittees and two special bodies). Subject to the approval of the Commission, ad hoc ministerial conferences and ad hoc intergovernmental meetings may also be held during the biennium. In addition to the subsidiary bodies of the Commission, the Advisory Committee of Permanent Representatives and Other Representatives Designated by the Commission meets monthly to advise the Executive Secretary on the exercise of his or her functions and to liaise

between the Commission and the secretariat. Meetings of the Commission and its committees and special bodies are normally held at the United Nations Conference Centre in Bangkok. If held at another location, at the invitation of a member Government, all additional costs are borne by the host country.

- 18.23 Pursuant to resolution 58/1, a midterm review of the functioning of the conference structure was conducted during the sixty-first session of the Commission, in April 2005. At its sixty-third session in 2007, the Commission will undertake an in-depth review of its conference structure, including the thematic priorities and subsidiary structure as part of its continuing efforts to ensure the relevance of the programme.

- 18.24 The amount of \$855,500, representing a decrease of \$5,800, is required in connection with the meetings of the Commission, its committees and other intergovernmental bodies. The provision covers the cost of temporary assistance for meetings, consultants and experts, travel of supplementary conference-servicing staff and of a staff member from the Regional Commissions New York Office to attend each annual Commission session, editorial services during periods of peak workload, external printing, supplies and materials, hospitality and so on. The reduced amount of \$5,800 relates to travel of staff (\$3,800) and supplies and materials (\$2,000), based on expenditure patterns.

## B. Executive direction and management

### *Resource requirements (before recosting): \$4,002,200*

- 18.25 The executive direction and management component comprises the Office of the Executive Secretary, the Least Developed Countries Coordination Unit and the United Nations Information Service.
- 18.26 The Office of the Executive Secretary provides overall direction, supervision and management of the ESCAP secretariat to ensure that ESCAP plays a major role in the economic and social development of the region and translates issues of global importance into regional action. The core functions of the United Nations Information Service are to disseminate public information on the work of the United Nations and ESCAP throughout the region and to provide information services to the divisions of ESCAP.
- 18.27 The Least Developed Countries Coordination Unit addresses the special needs and concerns of least developed member countries, landlocked developing member countries and small island developing member countries and mobilizes and coordinates the activities of the secretariat for the benefit of those countries.

- 18.28 The component is expected to achieve its objectives and expected accomplishments on the assumption that: (a) the stakeholders fulfil their responsibilities and obligations; and (b) national institutions are willing to provide relevant information.

- 18.30 The amount of \$4,002,200 comprises: (a) \$3,651,200 for the funding of 24 posts: 12 (5 Professional and 7 General Service) under the Office of the Executive Secretary (\$1,926,600), 7 (3 Professional and 4 General Service) under the United Nations Information Service (\$886,800) and 5 (3 Professional and 2 General Service) under the Least Developed Countries Coordination Unit (\$837,800). The increase of \$84,500 under posts is related to: (i) the inward redeployment of three posts (1 P-3 and 2 Local level) from programme support to strengthen the work of the Least Developed Countries Coordination Unit in such areas as mainstreaming the concerns of the least developed and landlocked developing countries in the work of all subprogrammes and servicing the Special Body on Least Developed and Landlocked Developing Countries and to augment the capacity of the Office of the Executive Secretary to service the legislative organs of the Commission; (ii) the outward redeployment of one P-4 post to programme support to strengthen programme management; and (b) \$351,000, at the maintenance level, for non-post requirements, including: (i) consultants (\$24,800) with expertise not available in the Secretariat for the preparation of studies and for public information consultancy activities, such as the production of films; (ii) expert group meetings (\$7,700); (iii) travel of staff (\$277,000); (iv) contractual services (\$32,600); (v) public information supplies, books, periodicals and subscriptions for the library (\$6,900); and (vi) public information exhibition structures for promotional purposes (\$2,000).

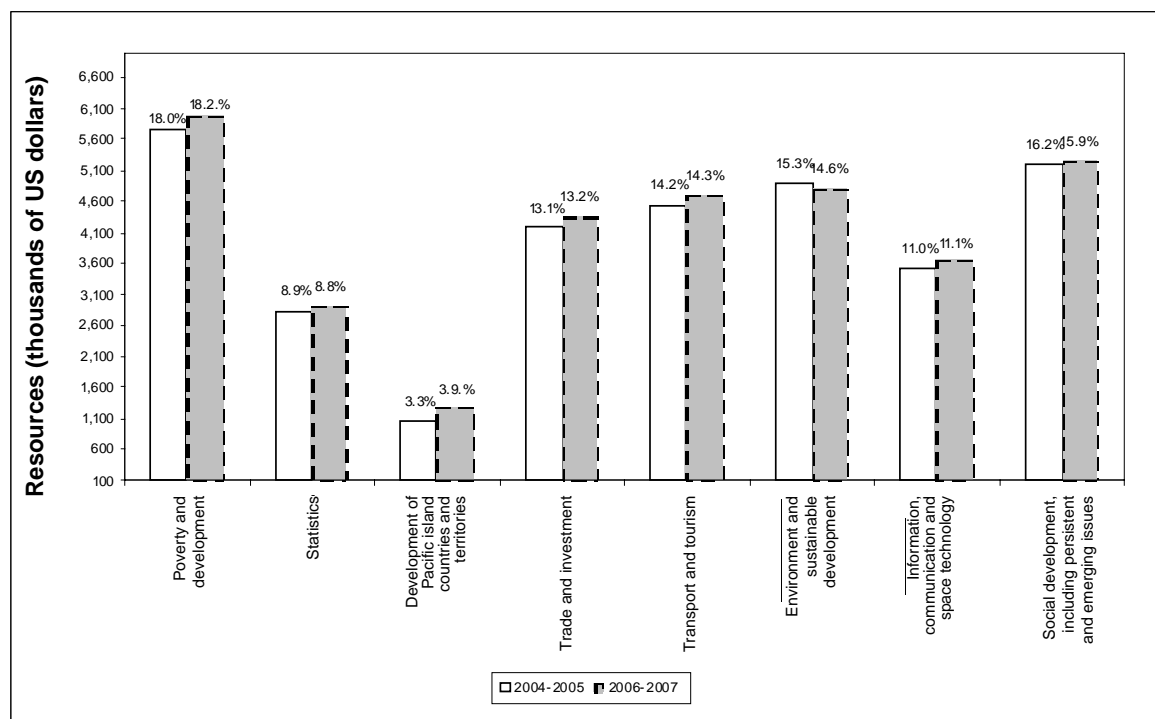

- 18.35 The amount of \$5,991,900, reflecting an increase of \$214,000, comprises: (a) \$5,598,900 for the funding of 37 posts (21 Professional and 16 General Service), reflecting an increase of \$218,400 resulting from the proposed establishment of one P-5 post to strengthen the work of the subprogramme on poverty reduction through secondary crops development and the delayed impact of a P-2 post established in the biennium 2004-2005; and (b) \$393,000 for non-post requirements, reflecting a net decrease of \$4,400 due to decreased requirements for travel of staff, partly offset by increased costs for printing the publications of the subprogramme. - 18.45 The amount of \$1,277,700, an increase of \$202,500, comprises: (a) \$1,029,300 for the funding of seven posts (4 Professional and 3 General Service), reflecting an increase of \$192,000 due to the establishment of one P-4 post and the inward redeployment of one Local level post from programme support to strengthen the work of the Centre in pursuance of the mandates emanating from ESCAP resolutions 60/6 on the revitalization of the United Nations ESCAP Pacific Operations Centre and 60/7 on the Pacific Urban Agenda; and (b) \$248,400 for non-post requirements, reflecting an increase of \$10,500 due to the increased level of activities pursuant to resolutions 60/6 and 60/7. - 18.50 The amount of \$4,358,100, reflecting an increase of \$149,000, comprises: (a) \$4,199,600 for the funding of 27 posts (16 Professional and 11 General Service), reflecting an increase of \$143,800 resulting from the proposed establishment of one P-5 post to strengthen the work of the subprogramme on agricultural engineering and machinery development in Asia and the Pacific in response to the request of the Commission to realign this area of work with the thematic priorities of ESCAP; and (b) \$158,500 under non-post requirements to provide for: (i) consultants (\$42,200) with specialized expertise not available in the Secretariat for the preparation of studies and background papers; (ii) expert group meetings (\$24,600); (iii) travel of staff (\$71,100) to attend and service meetings and to undertake consultations with Government authorities; and (iv) contractual services (\$20,600) for the external production of publications. The increase of \$5,200 in non-post resources is the net result of increased requirements for the new format and increased quality of the publications of the subprogramme, including *Trade and Investment Review*, and increased requirements for travel of staff related to trade and investment opportunities, partly offset by reduced requirements related to the reduction in the number of expert groups from three to two.
- 18.51 The extrabudgetary resources of \$2.6 million provide for 10 posts (4 Professional and 6 General Service) and resources for technical cooperation activities aimed at increasing the number of member countries making progress to accede to the World Trade Organization and strengthening the capacity of member States in such areas as trade negotiations, trade and investment agreements and mechanisms, promotion of good practices and agricultural engineering and machinery development.

- 18.55 The amount of \$4,709,100, an increase of \$168,900, comprises: (a) \$4,535,800 for the funding of 28 posts (17 Professional and 11 General Service), reflecting an increase of \$157,400 owing to the inward redeployment of one P-2 post following the transfer of activities for the theme of managing globalization from subprogramme 6 to subprogramme 5; and (b) \$173,300 under non-post resources to provide for: (i) consultants (\$22,900) with specialized expertise not available in the secretariat to provide input to the *Review of Developments in Transport in Asia and the Pacific*; (ii) expert group meetings (\$32,100); (iii) travel of staff (\$108,100) to attend meetings, to undertake consultations with Governments and organizations and to provide advisory services; and (iv) external printing (\$10,200). The increase of \$11,500 in non-post resources is due to the inclusion of planned advisory missions on United Nations transport facilitation conventions.
- 18.56 Extrabudgetary resources of \$1.2 million provide for two Professional posts as well as resources for the dissemination of data and information and for strengthening of institutional capacity at the national level in the field of transport and tourism through studies, group training and advisory services.

- 18.60 The amount of \$4,806,700, a reduction of \$99,200, comprises: (a) \$4,631,900 for the funding of 30 posts (17 Professional and 13 General Service), reflecting a decrease of \$82,800 due to the delayed impact of a P-2 post established in the biennium 2004-2005 offset by the outward redeployment of one P-2 post to subprogramme 5; and (b) \$174,800 under non-post requirements to provide for: (i) consultants (\$24,700) with specialized expertise not available in the secretariat for the preparation of studies; (ii) three expert group meetings (\$51,900); (iv) travel of staff (\$81,100) to attend meetings, to consult with Governments and to provide advisory services; and (v) contractual services (\$17,100) for external printing. The decrease of \$16,400 in non-post requirements is due to reduced requirements for travel of staff and a reduction in the number of publications, partly offset by increased requirements for one additional ad hoc expert group meeting on the “greening” of economic growth.
- 18.61 The extrabudgetary resources of \$6,153,400 provide for one Professional post and resources for technical cooperation activities, such as group training and advisory services, aimed at enhancing the awareness of Member States of their common interests and concerns and increasing their capacity to formulate and implement effective, gender-responsive policies towards the achievement of internationally agreed development goals, including those contained in the Millennium Declaration and the outcomes of major United Nations conferences and summits,

including the World Summit on Sustainable Development. The anticipated increase of \$2,768,400 is related to multi-year projects for the establishment of multi-hazard early warning systems for tsunamis and other natural disasters in the region.

- 18.65 The amount of \$3,675,900, an increase of \$161,700, comprises: (a) \$3,541,800 for the funding of 22 posts (14 Professional and 8 General Service), reflecting an increase of \$160,800 due to the proposed establishment of one P-5 post to strengthen the work of the subprogramme on the transfer of technology, including national innovation systems, in Asia and the Pacific in response to the request of the Commission to realign this area of work with the thematic priorities of ESCAP, and one P-2 post to strengthen the coordination of regional outcomes of the World Summit on the Information Society and implementation of activities related to the Regional Plan of Action for an Information Society in Asia and the Pacific, offset by the abolition of one Local level post; and (b) \$134,100 in non-post resources to provide for: (i) consultants (\$19,600) with specialized expertise not available in the secretariat for the preparation of studies, background papers and materials; (ii) three expert group meetings (\$56,300); (iii) travel of staff (\$50,800) to meetings and to consult with Governments; and (iv) external printing (\$7,400). The increase of \$900 in non-post resources is the net effect of increased requirements for participation of Pacific member countries in the expert group meetings offset by reduced requirements for travel of staff and external printing.
- 18.66 The extrabudgetary resources of \$3,090,800 provide for 14 posts (2 Professional and 12 General Service) and technical cooperation activities, including group training and advisory services, as well as research for and preparation of publications, to strengthen the capacity of member States to develop and implement policies and programmes that facilitate equitable access to information, communication and space technology and enhance the integration of such technology in the planning and implementation of socio-economic development programmes and plans.

## Subprogramme 8

### Social development, including persistent and emerging issues

#### *Resource requirements (before recosting): \$5,254,200*

- 18.67 The subprogramme is under the responsibility of the Emerging Social Issues Division. The programme of work has been formulated by drawing upon subprogramme 8 of programme 15 of the biennial programme plan for the period 2006-2007.

- 18.70 The amount of \$5,254,200, an increase of \$59,000, comprises: (a) \$5,064,800 for the funding of 32 posts (19 Professional and 13 General Service), reflecting an increase of \$74,600 due to the delayed impact of 1 P-2 post established in the biennium 2004-2005; and (b) \$189,400 under non-post resources to provide for: (i) consultants (\$40,600) with specialized expertise not available in the secretariat for the preparation of studies, background papers and materials; (ii) five expert group meetings (\$67,400); (iii) travel of staff (\$60,200) to attend meetings, to consult with Governments and to provide advisory services; and (iv) external printing (\$21,200). The decrease of \$15,600 in non-post resources is mainly a result of the reduced number of participants in expert group meetings.
- 18.71 The extrabudgetary resources of \$2,885,000 provide for five posts (2 Professional and 3 General Service), as well as resources for technical cooperation activities such as regional workshops and training courses, preparation of publications and promotion of regional cooperation to strengthen national capacity to achieve internationally agreed development goals, including those contained in the Millennium Declaration and the outcomes of major United Nations conferences and summits pertaining to poverty reduction, gender equality, health and socially vulnerable groups.

## D. Programme support

### *Resource requirements (before recosting): \$27,526,600*

- 18.72 Programme support is under the responsibility of the Programme Management Division, the Administrative Services Division and the Library. The allocation of responsibilities among these three entities is as follows:
- (a) The Programme Management Division provides policy guidelines and coordinates all aspects of programme planning, budgeting, monitoring and evaluation, and manages technical cooperation projects and funds. The Division accords priority to improving the relevance and impact of the Commission's work through more effective results-based programme and project planning as well as improved systems for monitoring and evaluation of parliamentary, normative and technical cooperation activities. It also provides secretarial assistance to the Advisory Committee of Permanent Representatives and Other Representatives Designated by Members of the Commission;
  - (b) The Administrative Services Division provides central common services in the areas of finance, human resources management, including training, travel and procurement, facility management, information and technology services and protocol. In addition, the Division

provides conference services, including language services, for the Commission and its subsidiary bodies, as well as managing the United Nations Conference Centre in Bangkok. The Division accords priority to improving the overall quality and efficiency of its services, implementing human resources management initiatives to create a more versatile and multi-skilled workforce and streamlining work procedures through process engineering and automation;

- (c) The Library provides information services to the entire secretariat and to delegations, as well as outside users, including the collection of books, journals and materials related to the work of the substantive divisions; the collection of parliamentary documentation, meetings reports and documents; and electronic access to documents and publications through the Web.

## Outputs

18.73 The outputs of the Programme Management Division include the following:

- (a) Programme planning, budgeting and evaluation: provision of programme planning policy guidance, training and support to the substantive divisions in the formulation of their respective strategic frameworks and programme budgets; management of programme and budgetary delivery through the provision of training and support in monitoring and evaluating programme implementation; provision of guidance and support for programme performance reports; management of the regular programme of technical cooperation and projects funded by the Development Account; provision of guidance and support to the substantive divisions in budget-related matters and internal oversight of accounts; coordination with the other entities of the Executive Committee on Economic and Social Affairs for joint programming; servicing of the annual Commission sessions, including items related to programme planning and evaluation and draft resolutions; and servicing of regular meetings of the Advisory Committee of Permanent Representatives and Other Representatives Designated by Members of the Commission, which meets monthly;
- (b) Management of technical cooperation projects and funds: provision of guidance and support to the substantive divisions in developing demand-driven technical cooperation projects that clearly feed into the achievement of one or more of the Commission's expected accomplishments for 2006-2007 in the context of the work programme, including facilitation of joint planning workshops for inter-thematic and interdivisional projects; project appraisal; monitoring and evaluation of technical cooperation projects; organization of consultations with donors and partners and analysis of donor trends for funding; coordination with partners of the United Nations Development Group and other relevant agencies for joint technical cooperation activities; servicing of the annual ESCAP sessions on technical cooperation issues, including pledging; dissemination of information on the Commission's technical cooperation work; further development and implementation of a fund-raising strategy to broaden the funding base for technical cooperation.

18.74 The outputs of the Administrative Services Division include the following:

- (a) Administrative support services: provision of overall administration and management, including policy formulation, establishment of managerial and administrative guidelines and protocol services;
- (b) Human resources management: provision of: services for the recruitment, promotion and placement of staff, medical services, staff development and training, assistance to staff on regulations and rules; engagement of consultants; administration of allowances and benefits; staff-management relations;

- (c) Financial services: provision of financial management services, including the issuance of making payments, including the payroll, payments of vendors and staff entitlements; treasury services; monitoring and guidance on the correct utilization of financial resources; overall financial management and accounting services;
- (d) Conference services: provision of editorial, interpretation, translation and text-processing services; internal document reproduction services; management of the United Nations Conference Centre;
- (e) Central support services: cost-effective management of the facilities and services of the United Nations complex in Bangkok; facility maintenance; procurement and travel services; storage and inventory management; communication and information technology infrastructure, including the replacement and maintenance of software, hardware and telecommunications equipment; development and maintenance of local software applications; coordination with Headquarters on centrally developed applications; information infrastructure enhancements for local area network and switchboard systems; installation and maintenance of intrusion detection systems; and ongoing operational support, including support and maintenance of the Integrated Management Information System.

18.75 The outputs of the Library include library and information technology services, as well as advisory and training services, concerning the information system, which are provided in response to the work programme of the ESCAP secretariat, staff of United Nations agencies in Bangkok and the public and private sectors.

18.76 The amount of \$27,526,600, a reduction of \$701,100, comprises: (a) \$21,446,600, reflecting a decrease of \$1,071,500, for the funding of 218 posts (54 Professional and 147 General Service); and (b) \$6,080,000, reflecting an increase of \$370,400, for non-post costs, including: (i) other staff costs (\$462,900) such as general temporary assistance, overtime and contractual services for repairs of personal computers, drivers, messengers, an electrician, audio-video technicians and printing press operators; (ii) consultants (\$82,000) with specialized expertise not available in the secretariat for strengthening monitoring and evaluation systems and preparing informational materials on technical cooperation programmes; (iii) travel of staff (\$132,200) for participation in meetings, consultations with Headquarters and programme and project monitoring and evaluation missions; (iv) contractual services (\$333,000), such as training programmes, data-processing infrastructure services and external printing; (v) general operating expenses (\$3,315,600), including the rental and maintenance of premises, utilities, the rental of equipment, the maintenance of data-processing equipment, furniture and equipment and other miscellaneous

services; (vi) hospitality (\$3,300) for official functions; (vii) supplies and materials (\$544,700); (viii) furniture and equipment (\$1,202,100); and (ix) contribution to the inter-agency coordination unit under the auspices of the United Nations Development Programme (\$4,200).

- 18.77 The decrease of \$1,071,500 under posts is the net result of the following: (a) the inward redeployment of one P-4 post from executive direction and management for strengthening the overall programme management of the Commission; (b) the outward redeployment of three posts (1 P-3, 2 Local level) to executive direction and management for strengthening the work of the Least Developed Countries Coordination Unit and the capacity to service the legislative organs of the Commission; (c) the outward redeployment of one Local level post to subprogramme 3 in recognition of the servicing requirements of the office; and (d) the abolition of 14 Local level posts owing to improved cost-effectiveness through the utilization of contractual services, particularly in the areas of information technology and facility management, and increased productivity as a result of increased automation of processes and investment in information technology.
- 18.78 The increase of \$370,400 under non-post costs is required mainly to ensure continuity of functions that can be more effectively performed through contractual services, in areas where Local level posts are abolished and to cover additional operating expenses and investment in information technology. The related increase is the net result of cost increases for the provision of contractual data-processing services, maintenance contracts for the building complex in Bangkok, maintenance contracts for data-processing equipment, the replacement of office automation equipment and increased costs for electricity and supplies, partly offset by reduced requirements for communications and the replacement and maintenance of office furniture and equipment.
- 18.79 The extrabudgetary resources of \$2,469,700 provide for 21 posts (5 Professional and 16 General Service) and resources for services in support of technical cooperation activities in the area of management of technical cooperation, monitoring and evaluation, finance, human resources management, procurement, information technology and other miscellaneous services.

The Advisory Committee reiterates its view that publications need to be linked directly to expected accomplishments in the manner stated in paragraph 72 of the first report of the Advisory Committee on the proposed programme budget for the biennium 2002-2003 (A/56/7). The Committee also recommends that thought be given to devising other means of providing the information now being communicated through hard-copy publications, such as increasing use of the Internet and the United Nations-wide Intranet, as well as seminars and workshops (para. V.4).

The Advisory Committee recalls its previous observations on interregional interaction and collaboration (see A/56/7, paras. V.28, V.31, V.49 and V.50) and requests that the regional commissions intensify their efforts, as well as coordination within the United Nations system. The Committee does not find the measures adopted so far to be adequate and believes that the regional commissions should intensify their efforts to collaborate and interact among themselves and with other regional entities in order to share experiences, lessons learned and workload (para. V.5).

The Advisory Committee recalls that in paragraph 72 of General Assembly resolution 56/253, the Assembly noted with concern the high proportion of General Service posts compared to Professional posts in the regional commissions and requested the Secretary-General to report to it at its fifty-seventh session on efforts undertaken, as appropriate. The Committee notes the information contained in paragraph 66 of the Introduction to the proposed programme budget, and requests that information on such steps as may have been taken to address the request of the Assembly, including the elaboration of local prevailing conditions, be provided for each regional commission in the context of the next estimates (para. V.6).

For the biennium 2006-2007, all publications are clearly linked to specific subprogramme expected accomplishments, through intermediate results contributing to the relevant expected accomplishment. Additional means of information dissemination, most specifically the Internet and Intranet, have been employed for many traditionally hard-copy publications.

The programme planning divisions of the regional commissions meet regularly with the Department of Economic and Social Affairs, the Office of Internal Oversight Services and the Programme Planning and Budget Division to exchange information and viewpoints. A regional commission web board has been established to share experiences, lessons learned and good practices. Active planning sessions were held with other Executive Committee on Economic and Social Affairs entities during the development of the 2006-2007 work programme.

ESCAP took a proactive approach in reducing the number of Local level staff through the abolition of 15 posts, 14 of which are under programme support, with the aim of improving cost-effectiveness through the utilization of contractual services, particularly in the areas of information technology and facility management, and increased productivity as a result of increased automation of processes and investment in information technology.

The Advisory Committee recalls its recommendations in paragraphs V.39 and V.40 of its previous report (A/56/7) on the need to refine some of the results-based-budgeting techniques for ESCAP. The Committee commends the Commission for attempting to draft the expected accomplishments and indicators of achievement more concisely and encourages further improvements in this area (para. V.41).

**Report of the Board of the Auditors**  
(A/59/5, vol. I, chap. II)

The Board reiterates its previous recommendation that the Administration take action to review those trust funds whose purposes have long been attained in order to identify and close those that are inactive and no longer required (para. 52).

The Board recommends that the Administration ensure that substantive offices submit progress reports for ongoing projects and terminal reports for completed projects in a timely manner (para. 56).

The Board recommends that the Administration continue to develop and conduct training programmes that would address issues involved in the implementation of results-based budgeting (para. 188).

The Board recommends that the Administration continually assess and monitor strict adherence to the administrative instructions on hiring, remunerating and evaluating the performance of consultants (para. 256).

ESCAP has conducted a series of programme planning, monitoring and evaluation, and performance reporting training events for all subprogramme managers and staff. This has resulted in the more precise development of expected accomplishments and better preparation of programme performance reports in the form of accomplishment accounts.

ESCAP revised the existing internal procedures and instructions pertaining to technical cooperation trust funds. A new online resource guide has been published on the ESCAP Intranet. By increasing the awareness of its staff about the procedures in force, ESCAP aims to improve the timeliness of project closure and minimize the delay in reprogramming of funds.

ESCAP issued a new online resource guide on its Intranet. Improved internal reviews and controls have been introduced to ensure timely preparation and higher quality of progress and terminal reports.

ESCAP does and will continue to conduct training programmes to address issues involved in the implementation of results-based budgeting.

ESCAP is developing a standard format for terms of reference that includes targeted outputs, delivery dates, performance indicators and travel requirements. ESCAP ensures adherence to the guidelines on remuneration levels set by the Office of Human Resources Management and is working with programme managers to ensure that evaluations are conducted in a timely manner.

**Report of the Office of Internal Oversight Services on its audit of the regional commissions**  
(A/58/785)

Rather than focus on small extrabudgetary projects, ESCAP should base its capacity to execute extrabudgetary projects on an analysis of the financial and managerial requirements needed to conduct its normative core activities (para. 36).

ESCAP has adopted a policy of focusing on larger scale multidisciplinary projects, using results-based planning as a means of creating greater impact in technical cooperation work.

ESCAP should develop benchmarks to determine levels of the Commission's in-kind contributions to extrabudgetary activities (para. 37).

The Executive Secretaries of the regional commissions should undertake an overall reassessment of their intergovernmental machinery to streamline the processes and avoid duplication. Recommendations to revitalize and support those entities that could be useful and a change in the focus of others that have been inactive should be presented to the member States for their consideration. The Executive Secretaries should specifically review the overall coherence and effectiveness of their respective intergovernmental bodies, with particular emphasis on: (i) standardizing rules and procedures for the establishment of those bodies (including subsidiary bodies); (ii) regularly reviewing and monitoring participation by members of the regional commissions; (iii) clarifying mandates to avoid overlap among different bodies; (iv) revisiting mandates of non-functioning bodies; (v) aligning those bodies and the substantive divisions servicing them; and (vi) regularly reporting and following up on the recommendations made by intergovernmental bodies (para. 71).

OIOS recommends that in the area of fund-raising, there should be a focal point within each regional commission to: (i) follow up on all fund-raising meetings, contacts and activities; (ii) coordinate, prepare and follow up on the pledging conference; (iii) maintain a database of all projects in need of fund-raising; (iv) prepare a quarterly report on the progress of fund-raising activities for the Executive Secretaries, with circulation to all divisional heads; and (v) exchange best practices and lessons learned in fund-raising efforts (para. 77).

The Executive Secretaries of the regional commissions should exchange best practices with respect to the recruitment of regional advisers, the development of work plans and the monitoring, reporting and evaluation of all

The Commission's new results-based project framework ensures that all resources required for project implementation are identified. Incremental resources for extrabudgetary activities are appropriately recovered from the donor in accordance with financial regulation 3.11 to ensure that extrabudgetary projects do not involve additional financial liability for the Organization.

The reassessment of the intergovernmental machinery in ESCAP took place during the midterm review of the functioning of the conference structure of the Commission, carried out in 2005. Feedback from questionnaires completed by government delegations attending intergovernmental conferences was used as a basis for the midterm review, as well as for determining the level and extent of participation in those events.

The Programme Management Division is the focal point for fund-raising in ESCAP and is entrusted with conducting fund-raising meetings and contacts, maintaining a project database, and producing periodic reports for submission to the Executive Secretary.

Best practices with respect to the recruitment of regional advisers has taken place, with ESCAP providing guidance to other regional commissions on overall regional adviser management, including experience derived



regional advisory activities, so that their respective regional advisory services can be better integrated into their substantive divisions' work programmes and thereby achieve maximum thematic impact (para. 79).

The Executive Secretaries of the regional commissions should establish a mechanism for: (i) assessing the quality of publications; (ii) categorizing a publication as a "flagship"; (iii) harmonizing the timing of the issuance of flagship publications; (iv) implementing peer-review exercises; (v) assessing the composition of the readership; and (vi) exchanging best practices and lessons learned. That could enable the regional commissions to improve the dissemination of information to their respective regions, improve access to their publications and standardize policies for the downloading of their documents (para. 83).

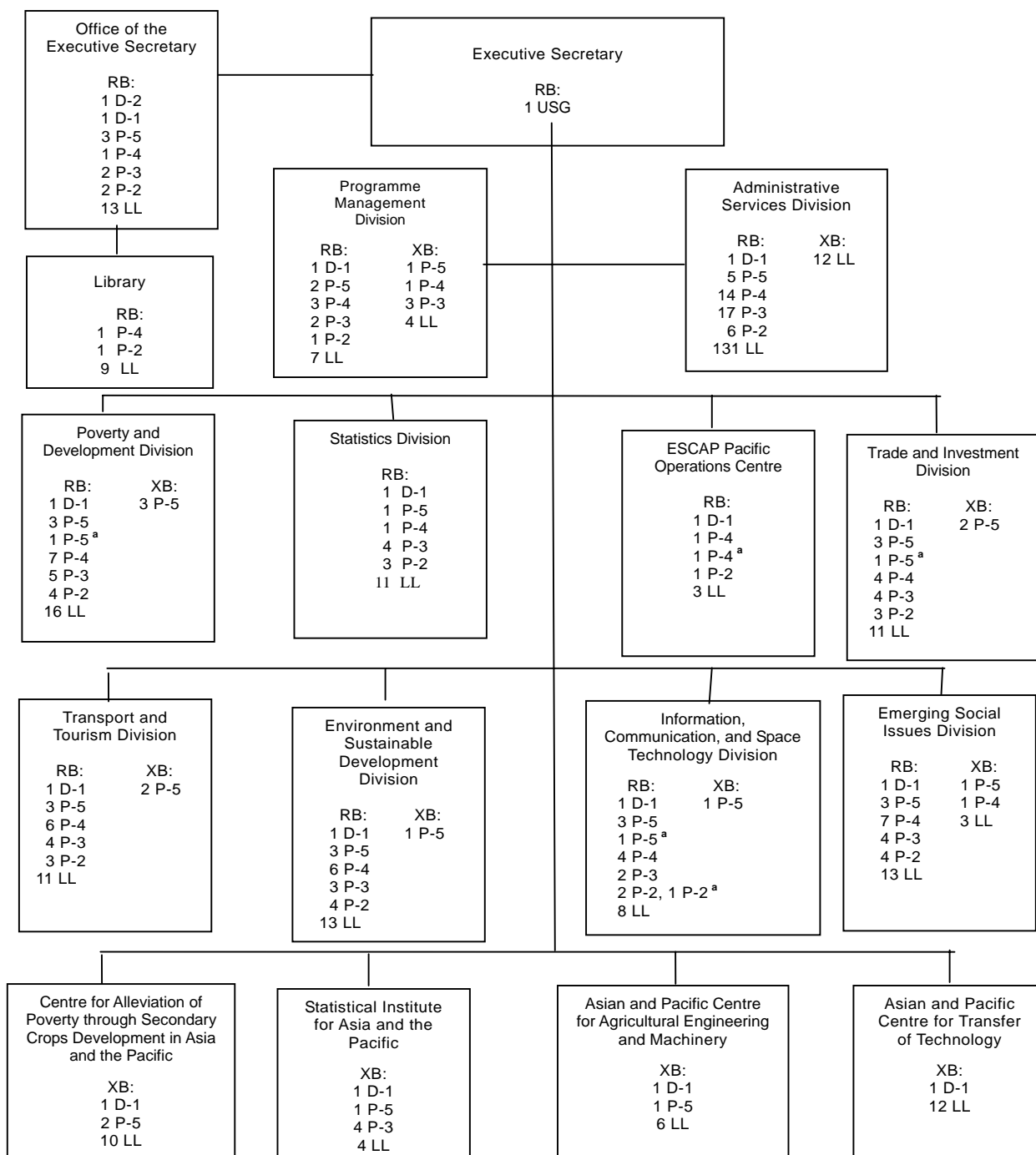

from the development of work plans, monitoring of ongoing services and the evaluation of overall effectiveness. Collaborative efforts were undertaken for a consistent approach to planning for overall advisory services under the regular programme of technical cooperation (Section 22), including harmonization with substantive divisions' work programmes, for the biennium 2006-2007.

ESCAP undertook a rigorous review of the value added by publications to the achievement of the expected accomplishments of each subprogramme under the programme of work. Measures have been implemented to ensure higher quality publications through peer-review mechanisms and more focused dissemination and launch policies.
