### Decision on the allocation of seats on the Commission and the Tribunal

*The Meeting of States Parties,*

*Having considered* the two joint proposals from the African and Asian States parties in relation to the allocation of seats on the Commission on the Limits of the Continental Shelf and the International Tribunal for the Law of the Sea to reflect the increase in the number of States parties (see annexes),

1. *Decides* that further work on proposals for the allocation of seats would be required to adopt decisions at the commencement of the eighteenth meeting of States parties;

2. *Also decides* to take up at the next meeting of States parties the issue of allocation of seats on the Commission and the Tribunal, under the item entitled “The allocation of seats on the Commission and the Tribunal”.



## Annex I

### **Future elections of the members of the Commission on the Limits of the Continental Shelf: joint African and Asian draft proposal**

1. In view of the past substantial growth in the number of, in particular, African and Asian States parties, the present decision is made to satisfy the need for revision of, and some certainty in, the equitable geographical representation in the composition of the Commission on the Limits of the Continental Shelf.
2. (a) Provided that no regional group will have fewer than three seats, the members of the Commission will be elected as follows:
  - (i) Five plus one commissioners shall be elected from the Group of African States;
  - (ii) Five plus one commissioners shall be elected from the Group of Asian States;
  - (iii) Three commissioners shall be elected from the Group of Eastern European States;
  - (iv) Four commissioners shall be elected from the Group of Latin American and Caribbean States;
  - (v) Three commissioners shall be elected from the Group of Western European and other States;
- (b) The additional one seat of the African and Asian Groups in the Commission shall rotate. Asia shall occupy six seats in the next elections to the Commission, Africa shall occupy six seats in the elections following those, and so on.
3. The above arrangements will be applicable to future elections, while not prejudicing new arrangements necessitated by the proportional growth of any regional group.

Explanation of Joint African and Asian Groups' Proposal for Equitable Geographical Representation in the Commission on the Limits of the Continental Shelf (CLCS) and the International Tribunal for the Law of the Sea (ITLOS), as per Articles 2 and 3 of Annex II of UNCLOS, Articles 2 and 3 of the ITLOS Statute and as per text of Asian Group's Proposal, which is applicable to both CLCS and ITLOS.

## Annex II

### **Future elections of the members of the International Tribunal for the Law of the Sea: joint African and Asian draft proposal**

1. In view of the past substantial growth in the number of, in particular, African and Asian States parties, the present decision is made to satisfy the need for revision of, and some certainty in, the equitable geographical representation in the composition of the International Tribunal for the Law of the Sea.
2. (a) Provided that no regional group will have fewer than three seats, the members of the Tribunal will be elected as follows:
  - (i) Five plus one judges shall be elected from the Group of African States;
  - (ii) Five plus one judges shall be elected from the Group of Asian States;
  - (iii) Three judges shall be elected from the Eastern European Group;
  - (iv) Four judges shall be elected from the Group of Latin American and Caribbean States;
  - (v) Three judges shall be elected from the Group of Western European and other States;
- (b) The additional one seat of the African and Asian Groups in the Tribunal shall rotate. Asia shall occupy six seats in the next elections to the Tribunal, Africa shall occupy six seats in the elections following those, and so on.
3. The above arrangements will be applicable to future elections, while not prejudicing new arrangements necessitated by the proportional growth of any regional group.
