### Organization of the session

#### A. Opening and duration of the session

1. The Commission for Social Development held its forty-seventh session at United Nations Headquarters on 15 February 2008 and from 4 to 13 February 2009. The Commission held \_\_\_ meetings (1st to \_\_\_).

At its 1st and 2nd meetings, on 15 February 2008 and 4 February 2009, in pursuance of that decision, the Commission elected the following officers by acclamation:

    - (a) Programme performance and implementation for the biennium 2006-2007;
    - (b) Proposed programme of work for the biennium 2010-2011;
    - (c) United Nations Research Institute for Social Development.
  5. Provisional agenda for the forty-eighth session of the Commission.
  6. Adoption of the report of the Commission on its forty-seventh session.
