Framework questions

Delegations are requested to organize their interventions around the following questions so as to frame the discussions on assessing the effectiveness of the Agreement:¹

1. In which areas is implementation of the recommendations adopted at the Review Conference in 2006 proceeding generally well?
2. In which areas is implementation of the recommendations adopted at the Review Conference in 2006 at an early stage or where has there been little progress in implementation?
3. What means could be proposed to further strengthen the substance and methods of implementation of the Agreement?
