At its first regular session of 1984, the Economic and Social Council endorsed the decision of the Commission on Human Rights to extend the mandate of the Special Representative on the situation of human rights in El Salvador for another year and to request him to submit his report on further developments in the situation of human rights in that country to the General Assembly at its thirty-ninth session and to the Commission at its forty-first session (decision 1984/136).

At the thirty-ninth session, the General Assembly will have before it a note by the Secretary-General transmitting the report of the Special Representative called for under Commission resolution 1984/52.

Situation of human rights and fundamental freedoms in Chile

At its first regular session of 1984, the Economic and Social Council endorsed the decision of the Commission on Human Rights to extend the mandate of the Special Rapporteur on the situation of human rights in Chile for another year and to request him to report on the situation of human rights in that country to the General Assembly at its thirty-ninth session and to the Commission at its forty-first session (decision 1984/140).

At the thirty-ninth session, the General Assembly will have before it a note by the Secretary-General transmitting the report of the Special Rapporteur called for under Commission resolution 1984/63.

Question of human rights in southern Africa

At the thirty-ninth session, the General Assembly will have before it the progress report of the Ad Hoc Working Group on policies and practices which violate human rights in South Africa and Namibia, in accordance with Economic and Social Council resolution 2082 A (LXII) (E/CN.4/1984/8) and a note by the Secretary-General (A/39/496).

Permanent sovereignty over national resources in the occupied Palestinian and other Arab territories

At the thirty-ninth session, the General Assembly will have before it the report of the Secretary-General called for under resolution 38/144 (A/39/326-E/1984/111).

Assistance to the Palestinian people

At the thirty-ninth session, the General Assembly will have before it the report of the Secretary-General called for under resolution 38/145 (A/39/265-E/1984/77 and Add.1).

Consumer protection

Pursuant to General Assembly resolution 38/147, the Economic and Social Council, at its organizational session for 1984, decided to set up an informal sessional working group of the whole to review the draft guidelines on consumer protection, under the chairmanship of one of the Vice-Presidents; it decided that the Vice-President should submit a report thereon to the Council at its second regular session of 1984 (decision 1984/101, sect. I).

At its second regular session of 1984, the Council, having taken note of the discussions held during its first and second regular sessions of 1984, decided to transmit to the General Assembly for consideration, with a view to their adoption at its thirty-ninth session as agreed in resolution 38/147, the draft guidelines on consumer protection (E/1983/71) and the comments of States thereon, contained in conference room paper No. 1 (resolution 1984/63).

At the thirty-ninth session, the General Assembly will have before it the report of the Secretary-General called for under resolution 38/147.

International Conference on Population, 1984

At the thirty-ninth session, the General Assembly will have before it the report of the Secretary-General called for under resolution 38/148.

Exchange of information on banned hazardous chemicals and unsafe pharmaceutical products

At the thirty-ninth session, the General Assembly will have before it the following documents:

At the thirty-ninth session, the General Assembly will have before it the report of the Secretary-General called for under resolution 38/199 (A/39/289-E/1984/107 and Add.1).

#### Further implementation of General Assembly resolution 37/214

At the thirty-ninth session, the General Assembly will have before it the report of the Secretary-General called for under decision 38/432 (A/39/97-E/1984/59).

#### Human rights and mass exoduses

This question has been considered by the General Assembly since its thirty-fifth session, in 1980, (resolutions 35/196, 37/186 and 38/103) and by the Commission on Human Rights since its thirty-fifth session, in 1979, (resolutions 30 (XXXVI), 29 (XXXVII), 1982/32, 1983/35 and 1984/49).

At its thirty-sixth session, the Commission on Human Rights requested the Secretary-General, in cases where any large-scale exoduses became a matter of international concern, to consider establishing direct contacts with appropriate Governments, to assess the relationships between the situation and full enjoyment of human rights and to make concrete recommendations for ameliorating such situations (resolution 30 (XXXVI)).

At its thirty-seventh session, the Commission on Human Rights decided to appoint for a period of one year a Special Rapporteur to study the question of human rights and massive exoduses; and requested the Special Rapporteur to submit his study to the Commission at its thirty-eighth session, together with conclusions and recommendations (resolution 29 (XXXVII)).

At its first regular session of 1981, the Economic and Social Council approved the Commission's decision to appoint a Special Rapporteur and requested the Secretary-General to provide him with all necessary assistance to carry out his study (decision 1981/145).

At its thirty-eighth session, the Commission on Human Rights requested the Secretary-General to transmit the study of the Special Rapporteur to the General Assembly for consideration at its thirty-seventh session (resolution 1982/32).

At its thirty-eighth session the General Assembly took due note of the report of the Secretary-General (A/38/538); invited Governments to intensify their co-operation and assistance in world-wide efforts to address the problem of mass exoduses; requested those Governments that had not yet done so to communicate to the Secretary-General their opinions on the study and recommendations of the Special Rapporteur with a view to the General Assembly taking a decision on those recommendations; and requested the Secretary-General to follow closely developments on this question and to take into consideration all the further comments of Member States including those expressed at the thirty-eighth session of the Assembly and at the fortieth session of the Commission on Human Rights, and to keep under review the recommendations of the Special Rapporteur (resolution 38/103).

At its fortieth session in March 1984, the Commission on Human Rights welcomed the intention of the Secretary-General to utilize to the greatest extent possible the relevant United Nations machinery in order to analyse promptly information on situations which might cause mass exoduses; welcomed the fact that the Secretary-General would continue to follow closely developments in the area of human rights and mass exoduses; and decided to keep under review at its forty-first session the problem of human rights and mass exoduses (resolution 1984/49).

At the thirty-ninth session, no advance documentation is expected on this question.

#### World population situation

At its forty-fifth session, in 1968, the Economic and Social Council requested the Secretary-General to submit to the General Assembly biennially a concise report on the world population situation, including an assessment of the current and prospective population trends (resolution 1347 (XLV)). At its forty-seventh session, the Council decided that only the summary and conclusions of the biennial report should be put before the Council and the Assembly (E/4735, p. 19).

At its first regular session of 1984, the Economic and Social Council took note of the summary and conclusions of the biennial report of the Secretary-General on the world population situation in 1984 (A/39/128-E/1984/35) and decided to transmit them to the General Assembly (decision 1984/119).

At the thirty-ninth session, the General Assembly will have before it the summary and conclusions of the biennial report of the Secretary-General (A/39/128-E/1984/35).

Proclamation of a transport and communications decade in Asia and the Pacific

At its second regular session of 1983, the Economic and Social Council, inter alia, emphasized the urgent need to upgrade the standards of transport and communications infrastructure in the Asia and the Pacific region; took account of the proposal for the proclamation of a transport and communications decade in Asia and the Pacific during the period 1985-1994; endorsed resolution 234 (XXXIX) of the Economic and Social Commission for Asia and the Pacific relating to the preparation of a phased programme of action for a decade; and requested the Secretary-General to submit a report on the implementation of resolution 1983/69 at its second regular session of 1984 (resolution 1983/69).

At its second regular session of 1984, the Economic and Social Council, having taken note of the report of the Secretary-General concerning the proclamation of a decade (E/1984/116), inter alia, recommended that the General Assembly proclaim a transport and communications decade for Asia and the Pacific during the period 1984-1994, in accordance with resolution 236 (XL) of the Economic and Social Commission for Asia and the Pacific; and requested the Secretary-General to submit a report on the implementation of resolution 1984/78 to the Council at its second regular session of 1986 and every two years thereafter until the end of the decade (resolution 1984/78).

At the thirty-ninth session, no advance documentation is expected on this question.

Staff and administrative questions of the Economic Commission for Western Asia

At its second regular session of 1984, the Economic and Social Council, deeply concerned about the high vacancy rate which had prevailed in the Economic Commission for Western Asia for a number of years, inter alia, proposed to the General Assembly that it should authorize the Secretary-General to take all necessary measures to enable the Commission to recruit staff from any State member of the Commission to meet the Commission's personnel requirements and that all members of the Commission should be treated in a manner consistent with their full membership in the Commission in regard to employment in the secretariat of the Commission (resolution 1984/81).

Report of the Commission on Transnational Corporations on its reconvened special session

At its resumed fifty-seventh session in 1974, the Economic and Social Council decided to establish an intergovernmental Commission on Transnational Corporations as an advisory body to the Council to assist it in dealing with the issue of transnational corporations; and decided further that the Commission would assist the Council in fulfilling its responsibilities in the field of transnational corporations by undertaking work which might assist the Council in evolving a set of recommendations which, taken together, would represent the basis for a code of conduct dealing with transnational corporations (resolution 1913 (LVII)).

The Commission, which meets annually, has held nine regular sessions.

In resolution 1982/68 of 27 October 1982, the Council took note with appreciation of the work done by the Commission on Transnational Corporations and the Intergovernmental Working Group on a Code of Conduct and, inter alia, decided that the Commission on Transnational Corporations should hold a special session, open to the participation of all States, for the purpose of continuing and completing the formulation of a draft code of conduct on transnational corporations. It requested the Commission to submit the full and final draft Code of Conduct to the Council for its consideration and transmission to the General Assembly at its thirty-eighth session for consideration and appropriate action. The special session of the Commission was held at Headquarters from 7 to 18 March 1983 and from 9 to 21 May 1983.

At its thirty-eighth session, the General Assembly decided to reconvene for one week, early in 1984, the special session of the Commission for the purpose of assessing the work on the draft code of conduct to facilitate the negotiation of outstanding issues (General Assembly decision 38/428 of 19 December 1983). The reconvened special session of the Commission was held at Headquarters from 9 to 13 January 1984.

In its decision 1984/109 of 21 February 1984, the Council, having assessed the work undertaken by the Commission on Transnational Corporations, at its reconvened special session (9-13 January 1984) and of the divergencies still to be overcome (see E/1984/9 and Add.1), decided to reconvene further the special session of the Commission from 11 to 29 June 1984, with a view to completing the formulation of the draft code of conduct for submission to the General Assembly at its thirty-ninth session through the Economic and Social Council at its second regular session of 1984.

At its second regular session of 1984, the Economic and Social Council took note of the report of the Commission on its reconvened special session (E/1984/9/Add.2) and decided to transmit it to the Assembly at its thirty-ninth session for consideration (decision 1984/163).

At the thirty-ninth session, the General Assembly will have before it the report of the Commission on its reconvened special session (E/1984/9/Add.2).

#### World Conference on Fisheries Management and Development

At its second regular session of 1984, the Economic and Social Council noted with satisfaction the statement made on 17 July 1984 before the First (Economic) Committee of the Council by the Secretary-General of the World Conference on Fisheries Management and Development, convened by the Food and Agriculture Organization of the United Nations at Rome from 27 June to 6 July 1984, and decided to invite the Director-General of the Food and Agriculture Organization of the United Nations to submit the report of the World Conference on Fisheries Management and Development to the General Assembly at its thirty-ninth session for consideration (decision 1984/164).

13. Report of the International Court of Justice

At the thirty-ninth session, the report of the International Court of Justice, covering the period from 1 August 1983 to 31 July 1984, will appear as Supplement No. 4 (A/39/4).

14. Report of the International Atomic Energy Agency

At the thirty-ninth session, the General Assembly will have before it the report of the Agency for 1983 (A/39/458 and Add.1). In his statement to the Assembly, the Director-General of the Agency will give an account of any major developments since the date of issue of the report.

15. Elections to fill vacancies in principal organs:

(a) Election of five non-permanent members of the Security Council

At the thirty-ninth session, the General Assembly will have to fill the seats being vacated by the following States: Malta, Netherlands, Nicaragua, Pakistan and Zimbabwe. As stipulated in rule 144 of the rules of procedure, a retiring member is not eligible for immediate re-election.

(b) Election of eighteen members of the Economic and Social Council

At the thirty-ninth session, the General Assembly will have to fill the seats being vacated by the following States: Austria, Benin, Brazil, Colombia, France, Germany, Federal Republic of, Greece, Japan, Liberia, Mali, Pakistan, Portugal, Qatar, Romania, Saint Lucia, Swaziland, Tunisia and Venezuela. As stipulated in rule 146 of the rules of procedure, a retiring member is eligible for immediate re-election.

(c) Election of five members of the International Court of Justice

At the thirty-ninth session, the General Assembly, along with the Security Council, will have to fill the seats being vacated by the following five members: Mr. Elias, Mr. Lachs, Mr. Mosler, Mr. Oda and Mr. El-Khani. The Assembly will have before it the following documents:

(a) Memorandum by the Secretary-General: A/39/354-S/16676;

(b) List of candidates: A/39/357-S/16680;

(c) Curriculum vitae of candidates: A/39/358-S/16681.

16. Elections to fill vacancies in subsidiary organs and other elections:

(a) Election of fifteen members of the Industrial Development Board

At the thirty-ninth session, the General Assembly will have to fill the seats being vacated by the following States: Australia, China, Germany, Federal

Republic of, Iraq, Lesotho, Liberia, Malaysia, Mexico, Panama, Sierra Leone, Spain, Turkey, Ukrainian Soviet Socialist Republic, United Kingdom of Great Britain and Northern Ireland and Venezuela. Members of the Board are eligible for immediate re-election.

(b) Election of twenty members of the Governing Council of the United Nations Environment Programme

At the thirty-ninth session, the General Assembly will have to fill the seats being vacated by the following States: Afghanistan, Botswana, Burundi, Byelorussian Soviet Socialist Republic, Canada, Colombia, Greece, Guinea, India, Jamaica, Mexico, Morocco, Oman, Poland, Senegal, Spain, Thailand, United Kingdom of Great Britain and Northern Ireland, United Republic of Tanzania and Uruguay. Members of the Governing Council are eligible for immediate re-election.

(c) Election of twelve members of the World Food Council

At the thirty-ninth session, the General Assembly will have to fill the seats being vacated by the following States: Botswana, Canada, China, Colombia, Gambia, Greece, India, Mexico, Thailand, United Republic of Tanzania, United States of America and Yugoslavia. As stipulated in resolution 3348 (XXIX), paragraph 8, members of the Council are eligible for immediate re-election. The Assembly will have before it a note by the Secretary-General (A/39/297).

(d) Election of seven members of the Committee for Programme and Co-ordination

At the thirty-ninth session, the General Assembly will have to fill the seats being vacated by the following States: Germany, Federal Republic of, Netherlands, Pakistan, Romania, Trinidad and Tobago, United Kingdom of Great Britain and Northern Ireland and Yugoslavia. Members of the Committee are eligible for immediate re-election. The Assembly will have before it a note by the Secretary-General (A/39/298).

(e) Election of the members of the Board of Governors of the United Nations Special Fund for Land-locked Developing Countries

At the thirty-ninth session, the General Assembly will have to elect the entire membership of the Board of Governors. As stipulated in article 4, paragraph 2, of the statute of the Special Fund, retiring members of the Board of Governors are eligible for re-election.

(f) Election of the Executive Director of the United Nations Environment Programme

At the thirty-ninth session, the General Assembly will have before it a note by the Secretary-General concerning the election of the Executive Director.



17. Appointments to fill vacancies in subsidiary organs and other appointments;

(a) Appointment of members of the Advisory Committee on Administrative and Budgetary Questions

At the thirty-ninth session the General Assembly will have to fill the vacancies that will arise upon the expiry of the terms of office of Mr. Ferrer Vieyra, Mrs. Housholder, Mr. Khalevinski, Mr. Lahlou and Mr. Pedersen. The Assembly will have before it a note by the Secretary-General (A/39/101).
