AND OTHER APPOINTMENTSAppointment of members of the Committee on ContributionsReport of the Fifth CommitteeRapporteur: Mr. Ali Achraf MOJTAHED (Islamic Republic of Iran)

1. At its 39th meeting, on 30 November 1984, the Fifth Committee considered a note by the Secretary-General (A/39/102) concerning the vacancies in the membership of the Committee on Contributions which will occur as a result of the expiration of the term of office of six of its members on 31 December 1984. The Fifth Committee also considered a note by the Secretary-General (A/39/102/Add.1) advising the General Assembly of the resignation of a member of the Committee on Contributions, requiring the appointment by the Assembly, at its current session, of a person to fill the unexpired portion of the term of office of the member who had resigned, i.e. until 31 December 1985.

2. The Fifth Committee also had before it a note by the Secretary-General (A/C.5/39/49) containing the name of a person nominated by his Government for appointment to the Committee on Contributions to fill the unexpired portion of the term of office of the member who had resigned, as well as a further note by the Secretary-General (A/C.5/39/50) containing the names of seven persons nominated by their respective Governments for appointment to the Committee on Contributions for a three-year term beginning on 1 January 1985.

3. The Fifth Committee decided by acclamation to recommend to the General Assembly that it should appoint Mr. Yasuo Noguchi (Japan) as a member of the Committee on Contributions for a one-year term beginning on 1 January 1985.

4. The Fifth Committee, following the withdrawal by the representative of the Federal Republic of Germany of the candidature of Mr. Wilfried Koschorreck, decided by acclamation to recommend to the General Assembly that it should appoint

Mr. Amjad Ali (Pakistan), Mr. Ernesto Battisti (Italy), Mr. Javier Castillo Ayala (Mexico), Mr. Anatoly Semënovich Chistyakov (Union of Soviet Socialist Republics), Mr. Dominique Souchet (France) and Mr. Wang Liansheng (China) as members of the Committee on Contributions for a three-year term beginning on 1 January 1985.

RECOMMENDATION OF THE FIFTH COMMITTEE
