### **Report of the Secretary-General concerning the credentials of the representatives and deputies and alternate representatives of the members of the Security Council elected for the period 2012-2013**

1. At its 37th plenary meeting, on 21 October 2011, the General Assembly elected Guatemala, Morocco, Pakistan and Togo as non-permanent members of the Security Council for a term of two years beginning on 1 January 2012. At its 40th plenary meeting, on 24 October, the Assembly elected Azerbaijan as a non-permanent member of the Council, also for a term of two years beginning on 1 January 2012.

2. Pursuant to rule 15 of the provisional rules of procedure of the Security Council, the Secretary-General wishes to report that, with regard to the representation of the members of the Council elected for the period 2012-2013, he has received the communications referred to hereinunder.
