I. Introduction

1. At its 2nd plenary meeting, on 16 September 2011, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its sixty-sixth session the item entitled “Review of the efficiency of the administrative and financial functioning of the United Nations” and to allocate it to the Fifth Committee.
2. The Fifth Committee considered the item at its 25th meeting, on 23 December 2011. Statements and observations made in the course of the Committee’s consideration of the item are reflected in the relevant summary record (A/C.5/66/SR.25).
