Implementation of resolutions and decisions relating to the drug programme of the United Nations Office on Drugs and Crime adopted during the period 2008-2011 in which action by the Office was requested

Report of the Secretariat

1. The present note was prepared pursuant to Commission on Narcotic Drugs resolution 54/10, entitled “Improving the governance and financial situation of the United Nations Office on Drugs and Crime: recommendations of the standing open-ended intergovernmental working group on improving the governance and financial situation of the United Nations Office on Drugs and Crime”, in which the Commission recommended that a short and concise report on the implementation of resolutions should be submitted by the Secretariat to the Commission as part of its session held in the first half of the year.

2. Tables 1-11 provide information on the status of implementation of resolutions and decisions relating to the drug programme of UNODC adopted during the period 2008-2011 by the General Assembly, the Economic and Social Council or the Commission on Narcotic Drugs in which action by the United Nations Office on Drugs and Crime was requested. Information is also provided, in table 12, on the implementation of Commission resolution 49/4, which has been reported on biennially since the fifty-first session of the Commission. References are made to documents containing information on the implementation of such resolutions and decisions.
