Identical letters dated 13 July 2012 from the Permanent Representative of the Syrian Arab Republic to the United Nations addressed to the Secretary-General and the President of the Security Council

Upon instructions from my Government, and following my letters dated 16-20 and 23-25 April, 7, 11, 14-16, 18, 21, 24, 29 and 31 May, 1, 4, 6, 7, 11, 19, 20, 25, 27 and 28 June and 2, 3, 9, 11 and 13 July 2012, I have the honour to transmit herewith a detailed list of violations of the plan for cessation of violence that were committed by armed groups in Syria on 11 July 2012 (see annex).

It would be highly appreciated if the present letter and its annex could be circulated as a document of the Security Council.

Wednesday, 11 July 2012

Governorate of Rif Dimashq

1. At 0900, an armed terrorist group stole microbus number 396530 belonging to the Order-Keeping Forces.
2. At 1000, an armed terrorist group fired at order-keeping personnel in Harasta, wounding one of them.
3. At 1100, an armed terrorist group fired at Col. Imad Mu'alla, his wife, and their children, killing him and wounding the children.
4. In the city of Dariya, an armed terrorist group abducted citizen Haytham Muhammad Mulbanji, born in 1958, who is the owner of a clothing store in al-Ma'damiyah.
5. The body of an unidentified man in his 50s was found in Dariya in a vacant lot next to Bilal Mosque. He had been killed by a gunshot, and his body showed signs of torture. Written on his hand was "Muhammad Sa'id al-Halabi, Sniper".
6. In the town of Judaydat Artuz, an armed terrorist group used a black Kia Rio vehicle, licence plate unknown, to assassinate Col. (ret.) Ahmad Jannad Bin Sha'ban, born 1958, on al-Jala' Street, Workers Square, as he was driving his Kia Cerato. The group also stole his vehicle.
7. Armed terrorists deployed densely in Hawsh Arab, which is subordinate to al-Tall, next to the main water well centre.
8. An armed terrorist group abducted citizen Ziyad Umar al-Mawsili in the district of Duma with his Daewoo vehicle, licence No. 247259/Damascus. He was freed after his vehicle was stolen.
9. An armed terrorist group fired at Order-Keeping Forces in the town of Aqraba, near the Aqraba gas station, attempted to set fire to the gas station, and planted explosive charges around the gas station. As a result, two citizens were killed: Mu'attaz Bin Muhammad Ghabur, who was shot in the head; and Muhammad Talal Tuba Bin Mahmud, born 1985.
10. In the village of Babila, the body of citizen Zakariya Bin Yusuf Sa'd, born 1970, was found, after he had been abducted by an armed terrorist group using a silver Mercedes vehicle. The group demanded a ransom of LS 2 million in exchange for his release.
11. An armed terrorist group burned a Mazda 929 car, licence No. 101393/Damascus, belonging to Ibrahim Bin Ahmad Uyun, born 1967, in the town of Yalda.

12. An armed terrorist group fired at Order-Keeping Forces in the town of Hujayrah, on Ali al-Wahsh Street, wounding two citizens: Muhammad Bin Ahmad Sultan Surur, born 1983; and Nidal Bin Ghazwan Rajub.
13. An armed terrorist group blocked off al-Sayyidah Zaynab Road with tires and rocks.
14. An armed terrorist group in a Kia Rio car abducted citizen Ahmad Ali Sumur, born 1958, who is an employee of the town of al-Hajr al-Aswad (head of utilities) in front of his house. He was able to escape and return to his house.
15. An armed terrorist group shot citizen Johnny Mikha'il Azir in the district of Qatna, wounding him.
16. The body of an unidentified woman killed by a gunshot was found in the town of al-Utaybah.
17. An unidentified body was found in the city of Harasta.
18. An armed terrorist group in the city of Harasta abducted citizen Muhammad Bin Fahd Ward, born 1981, and his Kia Cerato car, licence No. 795054/Damascus.
19. An armed terrorist group abducted police officer Muhammad Eid Bin Muhammad al-Qal'aji, born 1978 in Idlib, as he was performing his job in the town of al-Malihah.

Governorate of Damascus

20. On 10 July 2012 at 2330, a sound bomb exploded in the district of al-Fahhamah, next to the Adidas athletic clothing agency in al-Mawasim Market, belonging to citizen Muhammad Muhannad al-Midani Bin Muhammad Khayr, born 1962 and a Jordanian national. The explosion broke the glass storefront and caused other material damage.
21. On 10 July 2012 at 2400, an armed terrorist group fired at citizen Ayman Bin Ibrahim Shabani, born 1965, when he was in the locality of al-Qabun, killing him. The group stole his car, a Peugeot 504, licence No. 734197/Damascus.
22. At 1430 in the locality of al-Abassiyin, inside the Ministry of Oil, an explosive charge exploded in a Peugeot 406, licence No. 403011/Army, belonging to citizen Abdallah Bin Walid al-Tabbakh, who is the son of the late retired Maj. Gen. Walid al-Tabbakh. The car was completely burned by the fire. A completely burned unidentified body was observed in the car.
23. At 1910, an explosive charge exploded in the locality of al-Abassiyin, Baghdad-al-Azbakiyah Street, intersection with al-Mabarah Street. The charge was attached to a private Shanghai touring car, licence No. 598551/ Damascus, belonging to citizen Salah-al-Din Arabi Rabbab, born 1963. After his brother, Muhi-al-Din, who was moving behind him in another vehicle, informed him of the existence and ignition of the charge, he stopped and removed the charge from the exhaust of the car and threw it onto the ground. The charge exploded, creating a small pit with a length of 20 cm, a width of 20 cm, and depth of 4 cm. The aforesaid car was not damaged. Car number 142122, belonging to citizen Kamal Hamdi al-Hamasnah (born 1951), which was parked near the location of the explosion, was damaged by shrapnel, as were three persons who were near the location. They were taken to the hospital for medical assistance.

24. At 1930, two police officers, Ala' Haydar and Haydar Wannus, were guarding the northern gate of the entrance to Khalij garage in the locality of al-Qadam. Two private vehicles, licence numbers unknown, pulled up. Each vehicle carried five armed terrorists dressed in civilian clothing impersonating security personnel, with cartridge pouches, guns, and pistols. They got out of the two cars, drew the guns on the two police officers, and bound them with plastic ties. They attempted to abduct police officer Ala' Haydar. However, he was able to free himself. Police patrols were sent to assist, and the armed men fled in an unknown direction.

Governorate of Dar'a

25. On 10 July 2012 at 2100, an armed terrorist group fired at citizen Usama Kushan in Nimr.

26. On 10 July 2012 at 2130, an armed terrorist group abducted Sgt. Samir al-Samuri and police officer Husayn al-Rahmun in the district of al-Shajarah.

27. On 10 July 2012 at 2200, an armed terrorist group planted an explosive charge in the town of Kafr Shams.

28. On 10 July 2012 at 2300, an armed terrorist group fired at order-keeping personnel in Rankus, killing Conscript Muhammad al-Uwayd.

29. At 0100, an armed terrorist group fired at the roadblocks of al-Natur and al-Ba'l, which belong to the Order-Keeping Forces in Tafas.

30. At 0130, an armed terrorist group fired at the military barracks in the district of Rajm al-Sayd.

31. At 0200, an armed terrorist group shot and killed Master Sgt. Abd-al-Hadi al-Awad after abducting him. His body was found on Atman-Khirbat Ghazallah Road.

32. At 0500, an armed terrorist group fired rounds and RPGs at order-keeping personnel in Sayd.

33. At 0800, an armed terrorist group fired at citizens in Dar'a, wounding four.

34. As 0900, an armed terrorist group stole a Mitsubishi, number 106613, belonging to citizen Muhammad al-Nabulsi in al-Shajarah.

35. At 1000, an armed terrorist group fired at order-keeping personnel in al-Mahattah quarter, wounding one of them.

36. At 1200, an armed terrorist group fired at an order-keeping roadblock in al-Mazirib.

37. At 1230, an armed terrorist group fired at border guard personnel in Tall Shihab.

38. At 1230, an armed terrorist group fired at a building in the district of Busra al-Sham.

39. At 1600, an armed terrorist group planted a mine on a dirt road in Busr al-Harir. The mine exploded on a civilian vehicle carrying two citizens, killing them.

Governorate of Homs

40. On 10 July 2012 at 2000, an armed terrorist group fired rounds and RPGs at order-keeping personnel in al-Qusur, al-Qarabis, al-Qahirah Street, Bab-Tadmur, Abu al-Laban roundabout, al-Sultaniyah, Talbisah, and al-Rastan.

41. On 10 July 2012 at 2100, an armed terrorist group fired at order-keeping personnel in al-Khalidiyah, killing Conscript Muhammad al-Najjar and wounding a lieutenant.

42. On 10 July 2012 at 2200, an armed terrorist group fired at order-keeping personnel in al-Ghawtah quarter, killing Sgt. Akram Salman.

43. At 0600, an armed terrorist group fired rounds and RPGs at order-keeping personnel in al-Sultaniyah, killing 1 and wounding 11, including a first lieutenant.

44. At 0700, an armed terrorist group fired rounds and RPGs at order-keeping personnel in Jurat al-Shiyah, killing Conscript Ra'fat Alam-al-Din and wounding three, including a captain.

45. At 0730, an armed terrorist group set off an explosive charge and fired an RPG at an overnight bus belonging to the Defence Factories Enterprise as it moved on the Salmiyah-Homs Road, at the site of the village of Tall Amri, killing two and wounding three.

46. At 0800, an armed terrorist group fired rounds, RPGs, and mortars at order-keeping personnel at al-Khalidiyah, wounding two, including a first lieutenant.

47. At 0800, an armed terrorist group fired rounds, RPGs, mortars, and LAW [light anti-armour weapon] missiles at order-keeping personnel at al-Qarabis, killing three corporals, including Conscript Isa al-Ahmad and Cpl. Namur al-Amr, and wounding 42 men, including a brigadier general and lieutenant.

48. At 0900, an armed terrorist group fired rounds and RPGs at order-keeping personnel in al-Qahirah Street and Karm Shamsham, killing one and wounding six, including a first lieutenant.

49. At 0900, an armed terrorist group fired various weapons at order-keeping personnel in the al-Qusur quarter, killing 5 and wounding 37.

50. At 0900, an armed terrorist group fired at order-keeping personnel in Wadi al-Sayih, wounding two men.

51. In 1200, an armed terrorist group fired at order-keeping personnel in al-Qusayr, wounding four.

52. At 1930, an armed terrorist group blew up a car at the roadblock at the al-Shayihat intersection in al-Qasir, killing Conscript Umar Mansur and wounding three.

Governorate of Hamah

53. On 10 July 2012 at 2000, an armed terrorist group fired sniper fire at an order-keeping roadblock in al-Tuwayni, wounding one element [other rank or enlisted man].

54. On 10 July 2012 at 2115, an armed terrorist group fired at an order-keeping roadblock near al-Sijn roundabout.

55. On 10 July 2012 at 2200, an armed terrorist group abducted Muhammad al-Ulaywi from his workplace at the water pumps in the village of Busayrin.
56. At 0230, an armed terrorist group fired at order-keeping personnel near Ayn al-Lawzah roundabout, wounding one.
57. At 0900, an armed terrorist group blocked the path of a microbus being driven by citizen Isma'il Abdallah on the Salmiyah-al-Sa'n Road, al-Hart locality, and abducted four citizens.
58. At 1000, an armed terrorist group blew up a booby-trapped car at an order-keeping roadblock near al-Hukama' School in the village of Subin on the Hamah-Muhradah Road, killing Conscript Sarbsast Khalil Hajj and wounding four others, including a colonel, in addition to causing material damage to a number of adjacent vehicles and buildings.
59. At 1000, an armed terrorist group killed citizen Ayman Yunus after abducting him on 9 July 2012.
60. At 1200, an armed terrorist group planted two explosive charges in al-Qusur quarter and detonated one of them during an attempt by military engineering personnel to disarm it, wounding two elements.
61. At 1300, an armed terrorist group blocked the path of Warrant Officer Ahmad Wahud on the al-Turaymisah-al-Safsafiyah public road, abducted him, and stole his motorcycle.
62. At 1340, an armed terrorist group fired at an order-keeping roadblock near al-Sibahi roundabout.
63. At 1500, an armed terrorist group blew up the water line feeding the city of al-Salmiyah and the villages of Talldarah and al-Kafat, near the villages of Taqsis and al-Daminah, which cut off the area's water completely.
64. At 1520, an armed terrorist group stole a car, licence No. 492286, belonging to citizen Shadi Kirwan.
65. At 1800, an armed terrorist group blocked the path of a car carrying vegetables on al-Raqqah-Salmiyah Road at the location of the al-Sayb intersection.
66. At 1800, an armed terrorist group killed a citizen and deposited his body west of the village of Qusayr Dayr Huwayt.
67. At 1900, an armed terrorist group detonated an explosive charge on the oil pipeline passing through the area of Athriya, near the intersection of al-Aqirbat, al-Raqqah-Salmiyah public road, setting the pipeline on fire.

Governorate of Aleppo

68. On 10 July 2012 at 2200, an armed terrorist group fired at order-keeping personnel at A'zaz, killing seven of them, [including] Conscript Muhammad al-Shalu, Conscript Muhammad Ali, Conscript Sayyar Sido, and destroying three vehicles of the Order-keeping Forces.
69. On 10 July 2012 at 2400, an armed terrorist group placed an explosive charge next to the Shams gas station at the locality of al-Aziziyah.

70. At 0100, an armed terrorist group place an explosive charge next to police officer housing in the district of al-Safirah.
71. At 0230, an armed terrorist group conducted an armed attack against a police station in the subdistrict of al-Hajib, district of al-Safirah.
72. At 0300, an armed terrorist group set up 10 domestically manufactured rockets on the northern side of the village of Nayir, pointing at Nabal, and fired 2 of them.
73. At 0600, an armed terrorist group conducted an armed attack against the Khan Tuman Dam project. The group bound the guards and stole 14 automatic rifles, 11 hunting rifles, 16 wooden boxes containing copper wire, and 27 barrels filled with mineral oil.
74. At 0800, an armed terrorist group cut off the Halab-al-Raqqah road at the village of al-Zakiyah, which is in the subdistrict of al-Khafsah in Manbij, and stole a bus belonging to the Maskanah Sugar Company after removing the passengers from it.
75. At 0830, an armed terrorist group abducted two conscripts, Ata al-Hamu and Muhammad al-Hashim, in the district of Manbij.
76. At 1015, an armed terrorist group assassinated a laboratory physician, Abd-al-Basit Arja at al-Kurrah al-Ardiyah roundabout.
77. At 1130, an armed terrorist group shot and killed citizen Kannan Saryu next to Zamzam Office on Icarda Street in the locality of al-Azamiyah.
78. At 1300, an armed terrorist group stole the contents of al-Muwaylah Dam in the village of al-Buwaydir.
79. At 1330, an armed terrorist group fired at citizens in al-Azamiyah quarter.
80. At 1430, an armed terrorist group blocked the path of the director of the Glass Company in Aleppo, citizen Muhammad Amin Hamu, on al-Muslimiyah Road.
81. At 1500, an armed terrorist group abducted five members of the Order-Keeping Forces in the district of Dayr Hafir.
82. At 1600, an armed terrorist group stole a Government car belonging to the Physicians Union in the al-Hamdaniyah quarter, after removing its driver.
83. At 1700, an armed terrorist group detonated an explosive charge near the al-Maghsalah roadblock of the Order-Keeping Forces in al-Atarib, wounding one of them.

Governorate of Idlib

84. On 10 July 2012 at 2030, an armed terrorist group detonated an explosive charge on a tanker containing kerosene on the al-Ladhiqiyah Highway, at Jisr al-Shughur, al-Yunusiyah intersection, killing the driver and wounding three persons.
85. At 1000, an armed terrorist group fired at the Jisr al-Shagur-al-Daribat Road, wounding a first lieutenant.
86. At 1000, an armed terrorist group abducted Conscript Dahham al-Khalid on Jisr al-Shughur-Idlib-Muhambal Road.

87. At 1400, an armed terrorist group fired at order-keeping personnel on the al-Hamra'-Dalbiya-al-Safsafiyah (Salqin) Road, killing Conscript Ali Husayn Hajj Qasim and wounding two others.

Governorate of Dayr al-Zawr

88. On 10 July 2012 at 2100, an armed terrorist group fired at order-keeping personnel in the city of Dayr al-Zawr, killing Conscript Muhammad al-Abdallah and wounding eight.

Governorate of Hasakah

89. At 0945, an armed terrorist group conducted an attack against the Aliyah police station on Tal Tamr-Aleppo Road, stealing seven rifles, three pistols, and two cars, abducting two officers, and wounding one person.

Governorate of Latakia

90. At 0745, an armed terrorist group set up an ambush of order-keeping patrols in the district of al-Haffah, killing Chief Warrant Officer Sumar al-Uqdah and a civilian worker, Hafiz Zakariya, and wounding 43, including a major and two captains.

Syrian-Turkish border

91. At 1200, an armed terrorist group attempted to infiltrate from Turkish territory into Syrian territory and fired at border guard personnel in the district of Jisr al-Shughur.

Syrian-Iraqi border

92. On 10 July 2012 at 2100, an armed terrorist group attempted to infiltrate from Iraqi territory into Syrian territory and fired on border guard personnel at al-Bukamal-Second Station.
