## **SUMMARY OF MEETINGS**

### **Tuesday, 18 September 2012**

#### **1085th plenary meeting**

##### **General statements**

General statements from the opening plenary continued. Statements were made by representatives of the following member States: Argentina; Morocco; Zimbabwe; the United States of America; the Russian Federation; Tunisia; South Africa; South Sudan; Ecuador; and the Sudan. In addition, a statement was made by the representative of the non-governmental organization LDC Watch.

Mr. Petko Draganov, Deputy Secretary-General of UNCTAD, made an introductory statement on agenda items 4 and 8. This was followed by a statement by Mr. Heiner Flassbeck, Director of the Division on Globalization and Development Strategies.

##### **General statements**

Statements were made by representatives of the following member States: Indonesia (on behalf of the Group of 77 and China); Ecuador (on behalf of Group of Latin American and Caribbean States on item 4); El Salvador (on behalf of Group of Latin American and Caribbean States on item 8); the Islamic Republic of Iran (on behalf of the Asian Group); Nigeria (on behalf of the African Group); the European Union; Nepal (on behalf of the least developed countries); India; Viet Nam; Morocco and China. In addition, a statement was made by the representative of the non-governmental organization New Vision International.

These were followed by remarks by Mr. Heiner Flassbeck, Director of the Division on Globalization and Development Strategies, and an intervention by the representative of Ecuador.

#### **1086th plenary meeting**

##### **Item 4      Interdependence: Coordinating stimulus for global growth**

The Board continued its consideration of item 4 with a panel discussion. Presentations were made by Mr. Alfredo Calcagno, Head of the Macroeconomic and Development Strategies Branch of the Division on Globalization and Development Strategies; H.E. Mr. Faizel Ismail, Permanent Representative of South Africa; H.E. Mr. Luis Gallegos, Permanent Representative of Ecuador; and Professor Costas Lapavistas from the School of Oriental and African Studies in the United Kingdom of Great Britain and Northern Ireland.

Next followed an interactive debate with interventions by the representatives of Barbados, Ethiopia, Argentina and Zambia, and the participation of the panellists and Mr. Heiner Flassbeck, Director of the Division on Globalization and Development Strategies.
