Report of the Human Rights Council

Programme budget for the biennium 2012-2013

Revised estimates resulting from resolutions and decisions adopted by the Human Rights Council at its nineteenth, twentieth and twenty-first sessions

Report of the Secretary-General

Summary

The General Assembly, in part V of its resolution 63/263, endorsed the conclusion contained in the report of the Advisory Committee on Administrative and Budgetary Questions (A/63/629) concerning the merit of an annual presentation to the Assembly of the revised estimates arising from resolutions and decisions adopted by the Human Rights Council. In its resolution 65/281, the Assembly decided to consider, through its Fifth Committee, all financial implications emanating from the resolutions and decisions contained in the annual report of the Human Rights Council, including those emanating from its September session. The present report therefore details additional budgetary requirements for the biennium 2012-2013, estimated at \$7,461,800, and additional requirements of \$985,400 to be considered in the context of the proposed programme budget for the biennium 2014-2015 resulting from resolutions and decisions adopted by the Council at its nineteenth, twentieth and twenty-first regular sessions, held in 2012, as contained in its report to the General Assembly (A/67/53 and Corr.1 and Add.1). It is proposed that the amount of \$7,461,800 be financed through additional appropriations in the context of the contingency fund for the biennium 2012-2013. In addition, it is proposed that, as at 1 January 2013, one new P-3 post be established under section 24, Human rights, of the programme budget for the biennium 2012-2013 to support an independent expert, appointed by the Council in its resolution 19/10 on human rights and the environment.



I. Introduction

1. The present annual report is in line with the conclusion of the Advisory Committee on Administrative and Budgetary Questions (see A/63/629, para. 10), endorsed by the General Assembly in part V of its resolution 63/263, on the merit of an annual presentation to the General Assembly of the revised estimates arising from resolutions and decisions adopted by the Human Rights Council. The Assembly, in its resolution 65/281, decided to consider, through its Fifth Committee, all financial implications emanating from the resolutions and decisions contained in the annual report of the Council, including those emanating from its September session. The present report is submitted to inform the Assembly of the requirements resulting from resolutions and decisions adopted by the Council at its nineteenth, twentieth and twenty-first regular sessions, held in 2012 (A/67/53 and Corr.1 and Add.1).

2. The Human Rights Council adopted a number of resolutions and decisions by which it authorized relevant human rights bodies and special procedures to continue or undertake additional activities, including meetings. Accordingly, under rule 153 of the rules of procedure of the General Assembly, the Council was provided, where appropriate, with statements of programme budget implications prior to the adoption of those resolutions and decisions. The Council was informed that the detailed resource requirements would be submitted to the General Assembly for its consideration and approval in the context of the revised estimates report, submitted annually, in which it would be determined whether some of the additional requirements could be met from within the provisions of the programme budget for the biennium 2012-2013 and which of the additional requirements would be requested in the context of the contingency fund, established by the Assembly in its resolutions 41/213 and 42/211.

3. With regard to those resolutions and decisions that were orally revised prior to adoption by the Human Rights Council, either the revisions introduced had no impact on the statements of programme budget implications submitted to the Council or the related statements were modified and/or withdrawn.

4. Some of the requirements resulting from resolutions adopted by the Council relate to activities of a perennial nature, for which provisions were made in the programme budget for the biennium 2012-2013 in the amount of \$3,066,900. They will continue to be included in the proposed programme budget for the biennium 2014-2015 for mandates extended beyond the current biennium.

5. The programme budget implications arising from the resolutions adopted at the nineteenth, twentieth and twenty-first regular sessions of the Human Rights Council give rise to total requirements of \$13,605,300 for the biennium 2012-2013, of which \$3,066,900 are of a perennial nature, \$3,076,600 are expected to be absorbed within the existing resources, and \$7,461,800 represent additional requirements for the biennium 2012-2013, including \$2,130,900 under section 2, General Assembly and Economic and Social Council affairs and conference management, \$5,317,200 under section 24, Human rights and \$13,700 under section 29E, Administration, Geneva. It is proposed that the additional requirements of \$7,461,800 be financed from additional appropriations in the context of the contingency fund for the biennium 2012-2013. It is also proposed that, as at 1 January 2013, one new P-3 post be established under section 24, Human rights, of the programme budget for the

biennium 2012-2013. All of the requirements (new and perennial) are summarized in the annex to the present report.

6. In most of the resolutions adopted at its nineteenth, twentieth and twenty-first sessions, the Human Rights Council requested the Secretary-General and the United Nations High Commissioner for Human Rights to provide all the resources and assistance necessary for the effective fulfilment of the mandates and/or to implement the requested activities from within existing resources. In each related programme budget implications statement, the attention of the Council was drawn to the provisions of section VI of General Assembly resolution 45/248 B and subsequent resolutions, the most recent of which was resolution 66/246, in which the Assembly reaffirmed that the Fifth Committee was the appropriate Main Committee of the Assembly entrusted with responsibilities for administrative and budgetary matters, and also reaffirmed the role of the Advisory Committee on Administrative and Budgetary Questions.

7. With regard to the requests made in a number of its resolutions, for example, 19/32 and 19/33 regarding, respectively, organizing a workshop/seminar and preparing a summary of the proceedings of the workshop, the attention of the Human Rights Council was drawn to the standard categories of final outputs in the programme narrative of the programme budget. In accordance with the existing standards, a meeting is considered to be intergovernmental if its membership consists of Governments and the organization of such a meeting involves substantive services, technical services and conference services. Meetings of expert groups and other meetings at which people serve in their individual capacities, not as the representatives of Governments, are not entitled to the same range of services as an intergovernmental meeting. Outputs, defined as seminars, workshops and symposia, are usually considered in the category of group training. Official reports to intergovernmental bodies should be fully processed by conference services. Working papers presented to expert group meetings, reports whose primary users are within the secretariat, and conference room and other background papers for intergovernmental bodies are not considered to be official reports and hence are not entitled to full conference services, in particular translation into all six official languages.

II. Additional requirements relating to the resolutions and decisions adopted by the Human Rights Council

A. Resolution 19/5

Question of the realization in all countries of economic, social and cultural rights

8. Under the terms of paragraphs 19 and 20 of resolution 19/5, the Human Rights Council:

(a) Decided to focus on the issue of economic, social and cultural rights of women and the empowerment of women in that regard, including in the context of the achievement of the Millennium Development Goals, in consultation with States, relevant special procedures and United Nations bodies and agencies and other stakeholders, in its annual discussion on the integration of a gender perspective, to

be held at its twenty-first session, and requested the Office of the United Nations High Commissioner for Human Rights (OHCHR) to prepare and disseminate a report of the proceedings;

(b) Requested the Secretary-General to submit to the Council, at its twenty-second session, a report on the implementation of the resolution, with a special focus on economic, social and cultural rights of women and the empowerment of women in that regard, including in the context of the achievement of the Millennium Development Goals.

9. As a result of the adoption of resolution 19/5 by the Human Rights Council, additional requirements of \$43,100 will arise to finance: (a) travel to Geneva and daily subsistence allowance for participation in consultations by two special rapporteurs and three panellists (one person from each of the five geographic regions) under section 24, Human rights; and (b) conference services for the processing and translation of the requested report under section 2, General Assembly and Economic and Social Council affairs and conference management, of the programme budget for the biennium 2012-2013, as detailed in table 1 below.

10. Provisions for the estimated amount of \$43,100 were not included in the programme budget for the biennium 2012-2013. However, every possible effort will be made to meet the additional requirements of \$43,100 per year, including \$16,800 under section 2, General Assembly and Economic and Social Council affairs and conference management, and \$26,300 under section 24, Human rights, from within the available resources approved under those sections of the programme budget for the biennium 2012-2013. No additional appropriation will be requested as a result of the adoption of the resolution.

B. Resolution 19/6

Special rapporteur in the field of cultural rights

11. Under the terms of paragraphs 8 and 11 of resolution 19/6, the Human Rights Council:

(a) Decided to extend, for a period of three years, the mandate of the current mandate holder as a special rapporteur in the field of cultural rights, as set out in the relevant United Nations human rights instruments;

(b) Requested the Special Rapporteur to report regularly to the Council and the General Assembly in accordance with their respective programmes of work.

12. The adoption of resolution 19/6 gives rise to estimated additional requirements of \$982,800 for the implementation of the requested activities, including: (a) \$156,800 for interpretation during field missions and for the conference services processing of the reports under section 2, General Assembly and Economic and Social Council affairs and conference management; and (b) \$826,000 for general temporary assistance at the P-3 level for 12 months per annum and at the General Service level for 6 months per annum, and for travel of the Special Rapporteur, including: (i) country visits (two missions of an average of 10 days' duration per annum); (ii) travel to Geneva to report to the Human Rights Council (one trip of 5 days' duration per annum); (iii) travel to New York to report to the General Assembly and to hold an annual consultation with States, the Office of the United Nations High Commissioner for Human Rights and relevant stakeholders (one trip of 5 days' duration per annum); (iv) travel to attend the annual meeting of special procedures (one trip of 5 days' duration per annum); and (v) two missions per year to Paris for consultations with the United Nations Educational, Scientific and Cultural Organization or to attend or follow up on relevant international conferences and events (two trips of 3 days' duration per annum), under section 24, Human rights, of the programme budget for the biennium 2012-2013.

13. The mandate of the Special Rapporteur, which replaced the mandate of an independent expert in the field of cultural rights, approved by the Human Rights Council by its resolution 10/23, falls under the category of activities considered to be of a perennial nature. Resources for such activities are provided in the amount of \$722,800, including \$156,800 under section 2, General Assembly and Economic and Social Council affairs and conference management, and \$566,000 under section 24, Human rights, of the programme budget for the biennium 2012-2013 (see para. 9 of the Secretary-General's report on revised estimates resulting from resolutions and decisions adopted by the Human Rights Council at its tenth and eleventh sessions (A/64/353)). Details of the additional requirements are provided in table 2 below.

14. With regard to the estimated additional requirements of \$260,000, every possible effort will be made to absorb them within the existing resources under section 24, Human rights, of the programme budget for the biennium 2012-2013. No additional appropriation will be required as a result of the adoption of the resolution. Owing to the perennial nature of the activities of the Special Rapporteur, the related requirements will continue to be considered in the context of the proposed programme budgets.

C. Resolution 19/10 Human rights and the environment

15. Under the terms of paragraph 2 of resolution 19/10, the Human Rights Council decided to appoint, for a period of three years, an independent expert on the issue of human rights obligations relating to the enjoyment of a safe, clean, healthy and sustainable environment, whose tasks would be:

(a) To study, in consultation with Governments, relevant international organizations and intergovernmental bodies, including the United Nations Environment Programme (UNEP) and relevant multilateral environment agreements, human rights mechanisms, local authorities, national human rights institutions, civil society organizations, including those representing indigenous peoples and other persons in vulnerable situations, the private sector and academic institutions, the human rights obligations, including non-discrimination obligations, relating to the enjoyment of a safe, clean, healthy and sustainable environment;

(b) To identify, promote and exchange views on best practices relating to the use of human rights obligations and commitments to inform, support and strengthen

environmental policymaking, especially in the area of environmental protection, and, in that regard, to prepare a compendium of best practices;

(c) To make recommendations, consistent with her or his mandate, that could help the realization of the Millennium Development Goals, in particular Goal 7;

(d) To take into account the results of the United Nations Conference on Sustainable Development to be held in Rio de Janeiro, Brazil, in June 2012, and to contribute a human rights perspective to follow-up processes;

(e) To apply a gender perspective by, inter alia, considering the particular situation of women and girls and identifying gender-specific discrimination and vulnerabilities;

(f) To work in close coordination, while avoiding unnecessary duplication, with other special procedures and subsidiary organs of the Council, relevant United Nations bodies and the treaty bodies, taking into account the views of other stakeholders, including relevant regional human rights mechanisms, national human rights institutions, civil society organizations and academic institutions;

(g) To submit a first report, including conclusions and recommendations, to the Council at its twenty-second session and annually thereafter.

16. The adoption of resolution 19/10 gives rise to estimated additional requirements of \$1,398,000, including: (a) \$898,000 for simultaneous interpretation at the consultative meeting in Geneva and during country visits, and for the conference services processing of eight documents per year, under section 2, General Assembly and Economic and Social Council affairs and conference management; (b) \$496,200 for one P-3 post (12 months per annum) and general temporary assistance at the P-3 level (six months per annum) and at the General Service level (six months per annum); travel of the independent expert: (i) to conduct country visits (two missions of an average of 10 days' duration per annum); (ii) to report to the Council in Geneva (one trip of 5 days' duration per annum); (iii) to hold an annual consultation with States, the Office of the United Nations High Commissioner for Human Rights and other relevant stakeholders (one trip of 5 days' duration per annum); (iv) to attend the annual meeting of special procedures (one trip of 5 days' duration per annum); (v) to consult with UNEP in Nairobi (one trip of 3 days' duration per annum); and (vi) to participate in follow-up to the United Nations Conference on Sustainable Development (one trip of 3 days' duration per annum); travel of staff: (i) to accompany the independent expert during country visits (two missions of an average of 10 days' duration per annum); (ii) to accompany the independent expert to Nairobi for consultations with UNEP; and (iii) to accompany the independent expert in follow-up to the United Nations Conference on Sustainable Development; local transportation, security, communications and other miscellaneous expenses during field missions; travel of representatives/meeting participants (five trips per annum from each region) to attend an annual consultation in Geneva with the independent expert, States, relevant United Nations treaty bodies and other relevant stakeholders; and travel of representatives/mandate holders: two trips of 3 days' duration to Geneva per annum to allow a treaty body member and another special procedures mandate holder to attend the annual consultation of the independent expert; consultancy (six months at the P-3 level per annum) to assist the mandate holder in the preparation of thematic studies and the compendium on best practices and to provide consultancy support on

technical matters related to his or her annual report to the Council, under section 24, Human rights; and (c) \$3,800 for sound technician/recording services under section 29E, Administration, Geneva, of the programme budget for the biennium 2012-2013, as detailed in table 3 below.

17. Provisions for the requested activities are not included in the programme budget for the biennium 2012-2013. Therefore, additional appropriations in the amount of \$1,398,000, including \$898,000 under section 2, General Assembly and Economic and Social Council affairs and conference management, \$496,200 under

section 24, Human rights, and \$3,800 under section 29E, Administration, Geneva, of the programme budget for the biennium 2012-2013 will be sought under the terms of the contingency fund for the biennium 2012-2013. In addition, the amount of \$8,700 will be required under section 37, Staff assessment, to be offset by an equivalent amount under income section 1, Income from staff assessment.

D. Resolution 19/11

Rights of persons with disabilities: participation in political and public life

18. Under the terms of paragraphs 13 and 14 of resolution 19/11, the Human Rights Council:

(a) Decided that its next annual interactive debate on the rights of persons with disabilities would be held at its twenty-second session, and that it would focus on the work and employment of persons with disabilities;

(b) Requested the Office of the United Nations High Commissioner for Human Rights to prepare a study on the work and employment of persons with disabilities, in consultation with States and other relevant stakeholders, including the International Labour Organization, regional organizations, the Special Rapporteur on Disabilities of the Commission for Social Development, civil society organizations, including organizations of persons with disabilities, and national human rights institutions, and requested that the study be made available on the website of the Office of the High Commissioner, in an accessible format, prior to the twenty-second session of the Council.

19. The adoption of resolution 19/11 gives rise to additional requirements of \$84,200 for the implementation of the requested activities, including: (a) \$35,000 for the processing and translation of documentation under section 2, General Assembly and Economic and Social Council affairs and conference management; and (b) \$49,200 for consultancy at the P-3 level for one month to produce an accessible version of the study, and travel and daily subsistence allowance for three days for five panellists (one from each region) and their respective personal assistants to participate in the interactive dialogue, under section 24, Human rights, of the programme budget for the biennium 2012-2013, as detailed in table 4 below.

20. Provisions for the requested activities are not included in the programme budget for the biennium 2012-2013. Therefore, additional appropriations in the amount of \$84,200, including \$35,000 under section 2, General Assembly and Economic and Social Council affairs and conference management, and \$49,200 under section 24, Human rights, of the programme budget for the biennium 2012-2013 will be sought under the terms of the contingency fund for the biennium 2012-2013.

E. Resolution 19/12

Situation of human rights in the Islamic Republic of Iran

21. Under the terms of paragraphs 1 and 3 of resolution 19/12, the Human Rights Council decided to extend the mandate of the Special Rapporteur on the situation of human rights in the Islamic Republic of Iran for a further period of one year, and requested the Special Rapporteur to submit a report on the implementation of his mandate to the Council at its twenty-second session and to the General Assembly at its sixty-seventh session.

22. The mandate of the Special Rapporteur falls under the category of activities considered to be of a perennial nature and gives rise to total requirements of \$414,500, as follows: (a) \$156,800 for simultaneous interpretation services for the delegation while it is on mission, and the conference services processing of documentation under section 2, General Assembly and Economic and Social Council affairs and conference management; and (b) \$257,700 for general temporary assistance at the P-3 level for 12 months; travel resources for: (i) two missions of the Special Rapporteur to the Islamic Republic of Iran, neighbouring or other relevant States, of an average duration of 15 days each, and three trips to Geneva per year (each of 5 days' duration) for consultations, to attend the annual meeting of special rapporteurs and to present reports to the Human Rights Council; (ii) one trip of the Special Rapporteur to New York (of 5 days' duration) to present a report to the General Assembly; and (iii) travel of staff to accompany the Special Rapporteur during the field missions to the Islamic Republic of Iran and on the trip to New York; and miscellaneous expenses, under section 24, Human rights, of the programme budget for the biennium 2012-2013, as detailed in table 5 below.

23. Of the total amount of \$414,500 required for the implementation of the activities requested in the resolution, the provisions of \$156,800, under section 2, General Assembly and Economic and Social Council affairs and conference management, and \$73,200, under section 24, Human rights, are already included in the programme budget for the biennium 2012-2013. With regard to the estimated additional requirements of \$184,500, every possible effort will be made to absorb them within the existing resources under section 24. No additional appropriation will be sought as a result of the adoption of the resolution. Owing to the perennial nature of the activities of the Special Rapporteur, the related requirements will continue to be considered in the context of the proposed programme budgets.

F. Resolution 19/13

The situation of human rights in the Democratic People's Republic of Korea

24. Under the terms of paragraphs 3 and 8 of resolution 19/13, the Human Rights Council:

(a) Decided to extend the mandate of the Special Rapporteur, in accordance with the Council resolution 16/8, for a period of one year;

(b) Invited the Special Rapporteur to submit regular reports on the implementation of his mandate to the Council and to the General Assembly.

25. The mandate of the Special Rapporteur falls under the category of activities considered to be of a perennial nature. Resources for such activities are provided in the total amount of \$231,400, including: (a) \$156,800 under section 2, General Assembly and Economic and Social Council affairs and conference management, for simultaneous interpretation and processing of documentation; and (b) \$74,600 under section 24, Human rights, of the programme budget for the biennium 2012-2013, for activities of the Special Rapporteur, including travel of the Special Rapporteur and staff, and general operating expenses incurred during field missions, as detailed in table 6 below.

26. No additional appropriation will be required as a result of the adoption of the resolution. Owing to the perennial nature of the activities of the Special Rapporteur, the related requirements will continue to be considered in the context of the proposed programme budgets.

G. Resolution 19/17 Israeli settlements in the Occupied Palestinian Territory, including East Jerusalem, and in the Occupied Syrian Golan

27. Under the terms of paragraphs 9 and 11 of resolution 19/17, the Human Rights Council:

(a) Decided to dispatch an independent international fact-finding mission, to be appointed by the President of the Council, to investigate the implications of the Israeli settlements for the civil, political, economic, social and cultural rights of the Palestinian people throughout the Occupied Palestinian Territory, including East Jerusalem, with a mandate ending upon the submission of a report to the Council, and called upon Israel, the occupying Power, not to obstruct the process of investigation and to cooperate fully with the mission;

(b) Requested the Secretary-General to report on the implementation of the resolution at its twentieth session.

28. The requested activities fall under the category of activities considered to be of a perennial nature. Resources for such activities are provided in the programme budget for the biennium 2012-2013 in the total amount of \$290,000, including: (a) \$88,300 for interpretation during the field mission and the translation of post-session documentation under section 2, General Assembly and Economic and Social Council affairs and conference management; and (b) \$201,700 for: (i) travel and accommodation for three commissioners with four support staff and other staff members, including a coordinator, a legal adviser and a security officer, to Geneva, Cairo and Lebanon; (ii) consultancy for six months and travel of a thematic expert at the P-3 level; and (iii) local costs for transportation, communications, consumables and other costs, under section 24, Human rights, of the programme budget for the biennium 2012-2013, as detailed in table 7 below.

29. No additional appropriation will be required as a result of the adoption of the resolution. Owing to the perennial nature of the activities of the Special Rapporteur,

the related requirements will continue to be considered in the context of the proposed programme budgets.

H. Resolution 19/20

The role of good governance in the promotion and protection of human rights

30. Under the terms of paragraph 5 of resolution 19/20, the Human Rights Council requested the United Nations High Commissioner for Human Rights to prepare, in consultation with relevant United Nations agencies, programmes and funds, and to present to the Council at its twenty-fourth session, a report outlining the role of the public service as an essential component of good governance in the promotion and protection of human rights, including a compilation of good practices based on information received from the aforementioned stakeholders.

31. The adoption of the resolution gives rise to estimated additional requirements of \$78,500 for the implementation of the requested activities, including: (a) \$35,000 for the translation of documentation into all official languages under section 2, General Assembly and Economic and Social Council affairs and conference management; and (b) \$43,500 for consultancy at the P-5 level for two months to prepare the report, including the compilation of good practices, as detailed in table 8 below.

32. Provisions for the requested activities are not included in the programme budget for the biennium 2012-2013. Therefore, additional appropriations of \$78,500, including \$35,000 under section 2, General Assembly and Economic and Social Council affairs and conference management, and \$43,500 under section 24, Human rights, of the programme budget for the biennium 2012-2013 will be sought in the context of the contingency fund for the biennium 2012-2013.

I. Resolution 19/21

Situation of human rights in Myanmar

33. Under the terms of paragraphs 18 and 20 of resolution 19/21, the Human Rights Council:

(a) Decided to extend for one year the mandate of the Special Rapporteur on the situation of human rights in Myanmar, in accordance with Commission on Human Rights resolutions 1992/58 of 3 March 1992 and 2005/10 of 14 April 2005, and Human Rights Council resolutions 7/32 of 28 March 2008, 10/27 of 27 March 2009, 13/25 of 26 March 2010 and 16/24 of 25 March 2011, and invited the Special Rapporteur to include in his next report, *inter alia*, further recommendations on the needs of Myanmar, including with regard to technical assistance and capacity-building;

(b) Request the Special Rapporteur to submit a progress report to the General Assembly at its sixty-seventh session, and to the Human Rights Council in accordance with its annual programme of work.

34. The mandate of the Special Rapporteur falls under the category of activities considered to be of a perennial nature. Resources for such activities in the amount of \$230,400 are provided in the programme budget for the biennium 2012-2013, including: (a) \$156,800 for simultaneous interpretation during field missions and conference services documentation processing under section 2, General Assembly and Economic and Social Council affairs and conference management; (b) \$73,600 under section 24, Human rights, for activities of the Special Rapporteur, including trips to Myanmar, neighbouring or other relevant States of an average duration of 15 days each; three trips to Geneva per year (each of 5 days' duration) for consultations, to attend the annual meeting of special rapporteurs and to present reports to the Council; and one trip (each year) to New York (of 5 days' duration) to present a report to the General Assembly; travel of staff to accompany the Special Rapporteur during the field missions and the trip to New York; and (c) general operating expenses incurred during field missions, including transportation, security, communications and other miscellaneous expenses, as detailed in table 9 below.

35. As the related provisions in the amount of \$230,400 are included in the programme budget for the biennium 2012-2013, no additional appropriation will be required as a result of the adoption of the resolution. Owing to the perennial nature of the activities of the Special Rapporteur, the related requirements will continue to be considered in the context of the proposed programme budgets.

J. Resolution 19/22

Human rights situation in the Syrian Arab Republic

36. Under the terms of paragraphs 14, 15, 16 and 21 of resolution 19/22, the Human Rights Council:

(a) Decided to extend the mandate of the commission of inquiry, established by the Council in its resolution S-17/1, and requested the commission to continue its work, to provide an oral update to the Council at an interactive dialogue at its twentieth session, and to present a written updated report at an interactive dialogue at its twenty-first session;

(b) Requested the commission of inquiry to conduct and continuously update a mapping exercise of gross violations of human rights since March 2011, including an assessment of casualty figures, and to publish it periodically;

(c) Invited the Office of the United Nations High Commissioner for Human Rights to facilitate the safe and secure storage of information and evidence, gathered by the commission of inquiry, on violations and abuses of international human rights law in the Syrian Arab Republic since March 2011;

(d) Decided to transmit the updated reports of the commission of inquiry to all relevant United Nations bodies and the Secretary-General for appropriate action, and requested the Secretary-General to present a report on the implementation of the resolution to the Council at its twentieth and twenty-first sessions.

37. The adoption of resolution 19/22 gives rise to additional requirements of \$2,100,100 for the implementation of the requested activities, including: (a) \$786,900 for the core secretariat to support the commission: general temporary assistance and travel resources to provide for one P-5 coordinator, eight P-3/P-4 officers (legal, investigative, security and interpretation) and three assistants, as well as for seconded military and gender advisers for a period of between one and six months, depending on the responsibilities of the position; (b) \$27,900 for

consultancy and travel resources for a pathologist for one month; (c) \$330,500 for travel and accommodation for the commissioners to Geneva, the Syrian Arab Republic and neighbouring countries, as well as close protection detail; (d) \$203,000 for travel and accommodation for staff accompanying the commissioners; (e) \$94,000 for local costs for transportation, communications, consumables and other costs; and (f) \$657,800 for conference services, including \$144,200 for interpretation and \$513,600 for the processing and translation of documentation.

38. The additional resource requirements of \$2,100,100, including \$657,800 under section 2, General Assembly and Economic and Social Council affairs and conference management, and \$1,442,300 under section 24, Human rights, of the programme budget for the biennium 2012-2013 are detailed in table 10 below.

39. Provisions for the requested activities are not included in the programme budget for the biennium 2012-2013. Therefore, an additional appropriation of \$2,100,100 would be required to support the new mandate resulting from the adoption of the resolution.

40. In April 2012, the concurrence of the Advisory Committee on Administrative and Budgetary Questions with regard to entering into commitments of \$2,100,100 under provisions of General Assembly resolution 66/249, on unforeseen and extraordinary expenses, was sought and received. The related expenditures were reported in the context of the first performance report of the Secretary-General on the programme budget for the biennium 2012-2013 (A/67/592). Therefore, no additional appropriations will be sought in the context of the present report for activities requested in resolution 19/22.

K. Resolution 19/24 The Social Forum

41. Under the terms of paragraphs 6 and 9 of resolution 19/24, the Human Rights Council:

(a) Decided that the Social Forum would meet for three working days in 2012, in Geneva, on dates suitable for the participation of representatives of States Members of the United Nations and of the broadest possible range of other stakeholders, especially from developing countries, and should focus on the theme "People-centred development and globalization";

(b) Requested the United Nations High Commissioner for Human Rights to facilitate participation in the 2012 Social Forum in order to contribute to interactive dialogues and debate at the Forum, and to assist the Chair-Rapporteur as resource persons, of up to 10 experts, including representatives from civil society and grass-roots organizations in developing countries.

42. The adoption of resolution 19/24 gives rise to additional requirements of \$110,000 for return travel to Geneva and daily subsistence allowance for four days for 10 experts under section 24, Human rights, of the programme budget for the biennium 2012-2013, as detailed in table 11 below.

43. Of the total amount of \$110,000 required for the implementation of the activities requested in the resolution, provisions of \$58,800 were made under section 24, Human rights, of the programme budget for the biennium 2012-2013. L. Resolution 19/28
Assistance to Somalia in the field of human rights

44. Under the terms of paragraph 12 of resolution 19/28, the Human Rights Council requested the Secretary-General to submit to the Council, at its twenty-first session, a report assessing current United Nations support for efforts in Somalia to end all human rights abuses and combat impunity, as reflected in the report of the Working Group on the Universal Periodic Review on Somalia, and containing proposals for a more integrated approach across the United Nations system, considering in this context the role of the field presence of the Office of the United Nations High Commissioner for Human Rights in Somalia.

45. The adoption of the resolution gives rise to additional requirements in the amount of \$18,400 under section 2, General Assembly and Economic and Social Council affairs and conference management, of the programme budget for the biennium 2012-2013, for the translation into all official United Nations languages of a report, not exceeding 10,700 words, to be submitted to the Council at its twenty-first session, as detailed in table 12 below.

47. Under the terms of paragraph 10 of resolution 19/29, the Human Rights Council requested the Office of the United Nations High Commissioner for Human Rights to present to the Council, at its twenty-first session, a progress report on the situation of human rights in Yemen and on the follow-up to the resolution and Council resolution 18/19.

48. The adoption of the resolution by the Human Rights Council gives rise to additional requirements of \$79,300, including: (a) \$30,100 for the translation and processing of documentation under section 2, General Assembly and Economic and Social Council affairs and conference management; and (b) \$49,200 for travel of two staff members of the Office of the United Nations High Commissioner for Human Rights on mission to Yemen (including local travel between Sana'a, Taiz, Aden and other cities) for eight weeks; security escort wages, travel and accommodation; and operating costs, including transport and administrative support, under section 24, Human rights, of the programme budget for the biennium 2012-2013, as detailed in table 13 below.

Human rights and unilateral coercive measures

50. Under the terms of paragraph 16 (a) and (b) of resolution 19/32, the Human Rights Council requested the Office of the United Nations High Commissioner for Human Rights:

(a) To organize, prior to the twenty-third session of the Council, a workshop on the various aspects relating to the impact of the application of unilateral coercive measures on the enjoyment of human rights by the affected populations in the States targeted, with the participation of States, academic experts and civil society representatives;

(b) To prepare a report on the proceedings of the workshop and to submit it to the Council at its twenty-third session.

51. The adoption of the resolution by the Human Rights Council gives rise to additional requirements of \$287,900, including: (a) \$48,700 for interpretation services for a one-day workshop, the translation into all official languages of the summary report and its publication, under section 2, General Assembly and Economic and Social Council affairs and conference management; (b) \$238,200 under section 24, Human rights, for: (i) general temporary assistance at the P-3 level and at the General Service (Other level), both for six months; (ii) travel to and daily subsistence allowance in Geneva for two days for 10 international academic experts from all regions; and (iii) travel to and daily subsistence allowance in Geneva for two days for 10 civil society representatives from all regions; and (c) \$1,000 for conference support services under section 29E, Administration, Geneva, of the programme budget for the biennium 2012-2013, as detailed in table 14 below.

53. Under the terms of paragraph 18 (a) and (b) of resolution 19/33, the Human Rights Council requested the Office of the High Commissioner for Human Rights:

(a) To organize, before the twenty-second session of the Council, from within existing resources, a seminar on the enhancement of international cooperation in the field of human rights, with the participation of States, relevant United Nations agencies, funds and programmes, and other stakeholders, including academic experts and civil society, in addition to a member of the Advisory Committee. The seminar would build upon the study prepared by the Advisory Committee, including the recommendations contained therein;

(b) To prepare a report on the deliberations held during the seminar and to submit it to the Council at its twenty-second session.

54. The adoption of the resolution by the Human Rights Council gives rise to additional requirements of \$73,600, including: (a) \$65,300 for interpretation services in all United Nations official languages for a one-day seminar in Geneva, and the translation and processing of the report on the seminar, under section 2, General Assembly and Economic and Social Council affairs and conference management; (b) \$7,300 for travel and daily subsistence allowance in Geneva for one Advisory Committee member under section 24, Human rights; and (c) \$1,000 for conference support services under section 29E, Administration, Geneva, of the programme budget for the biennium 2012-2013, as detailed in table 15 below.

56. Under the terms of paragraphs 8 and 10 of resolution 19/35, the Human Rights Council requested the United Nations High Commissioner for Human Rights:

(a) To prepare and submit a thematic report to the Council, prior to its twenty-second session, on effective measures and best practices to ensure the promotion and protection of human rights in the context of peaceful protests;

(b) In preparing the thematic report, to draw from the experience of treaty bodies and to seek the views of States and relevant partners, such as United Nations agencies, regional organizations, national human rights institutions and civil society organizations.

57. The adoption of the resolution by the Human Rights Council gives rise to additional requirements of \$50,600, including: (a) \$35,000 for the translation and processing of the report under section 2, General Assembly and Economic and

Social Council affairs and conference management; and (b) \$15,600 for consultancy at the P-4 level for two months to seek the views of all the above-mentioned stakeholders and draft the report, as the Secretariat has no specific expertise in this area, under section 24, Human rights, of the programme budget for the biennium 2012-2013, as detailed in table 16 below.

(a) Requested the Office of the United Nations High Commissioner for Human Rights, in consultation with States, national human rights institutions, civil society, relevant intergovernmental bodies and international organizations, to draft a study on common challenges facing States in their efforts to secure democracy and the rule of law from a human rights perspective, as well as on lessons learned and best practices in the engagement of the State with the international community to support such processes, and to present the study to the Council at its twenty-second session;

(b) Decided to organize, at its twenty-third session, a panel discussion on common challenges facing States in their efforts to secure democracy and the rule of law from a human rights perspective, as well as on lessons learned and best practices in the engagement of the State with the international community to support such processes;

(c) Requested the Office of the High Commissioner to prepare a report on the outcome of the panel discussion in the form of a summary.

60. The adoption of the resolution by the Human Rights Council gives rise to additional requirements of \$100,700, including: (a) \$51,300 for the translation and processing of the report under section 2, General Assembly and Economic and Social Council affairs and conference management; and (b) \$49,400 for travel to and from Geneva and daily subsistence allowance for five panellists (one from each region) and for consultancy at the P-4 level for two months to prepare the study, under section 24, Human rights, of the programme budget for the biennium 2012-2013, as detailed in table 17 below.

R. Resolution 19/38

The negative impact of the non-repatriation of funds of illicit origin to the countries of origin on the enjoyment of human rights, and the importance of improving international cooperation

62. Under the terms of paragraph 13 of resolution 19/38, the Human Rights Council requested the Independent Expert on the effects of foreign debt and other related international financial obligations of States on the full enjoyment of all human rights to present to the Council, at its twenty-second session, an in-depth

study on the negative impact of the non-repatriation of funds of illicit origin to the countries of origin on the application by States of the maximum available resources to the full realization of all human rights, in particular economic, social and cultural rights, with special attention paid to developing countries and countries with economies in transition burdened by foreign debt.

63. The adoption of the resolution by the Human Rights Council gives rise to additional requirements of \$64,500, including: (a) \$44,500 for the translation and processing of the study under section 2, General Assembly and Economic and Social Council affairs and conference management; and (b) \$20,000 for consultancy at the P-3 level for three months to assist the Independent Expert with technical aspects of the study under section 24, Human rights, of the programme budget for the biennium 2012-2013, as detailed in table 18 below.

65. Under the terms of paragraph 8 of resolution 20/1, the Human Rights Council requested the Office of the United Nations High Commissioner for Human Rights to organize, in close cooperation with the Special Rapporteur on trafficking in persons, especially women and children, consultations with States, regional intergovernmental

bodies and organizations and civil society on the draft basic principles on the right to effective remedy for trafficked persons, and to submit a summary thereon to the Council at its twenty-sixth session.

66. The adoption of the resolution by the Human Rights Council gives rise to additional requirements of \$642,900 for the implementation of the requested activities, including: (a) \$119,300 for conference services for the four regional consultations, each held for two days with States and relevant stakeholders, including two documents in three languages as well as interpretation for the two-day meeting, and for the translation of the requested summary report on the consultations, under section 2, General Assembly and Economic and Social Council affairs and conference management; (b) \$384,000 for general temporary assistance for 12 months annually at the P-3 level for two years to assist in the organization of four regional consultations, and travel to each of four regional meetings for the Special Rapporteur, two supporting OHCHR staff and 10 to 12 regional experts; under section 24, Human rights; and (c) \$1,200 for conference support services under section 29E, Administration, Geneva, of the programme budget for the biennium 2012-2013, as detailed in table 19 below.

Under the terms of paragraph 15 of resolution 20/4, the Human Rights Council requested the Office of the United Nations High Commissioner for Human Rights to prepare, in consultation with the Office of the United Nations High Commissioner for Refugees, the Working Group on the issue of discrimination against women in law and in practice, States and other relevant stakeholders, a report on discrimination against women in nationality-related matters, including the impact on children, under national and international law, including best practices by States and other measures that eliminate nationality discrimination against women and avoid or reduce statelessness, before the twenty-third session of the Human Rights Council.

70. The adoption of the resolution by the Human Rights Council gives rise to additional requirements of \$25,900 for the conference services processing of the report under section 2, General Assembly and Economic and Social Council affairs and conference management, of the programme budget for the biennium 2012-2013, as detailed in table 20 below.

(b) Requested the Independent Expert to submit an analytical report on the implementation of the resolution and on the process of developing the commentary to the guiding principles on foreign debt and human rights to the Council in 2013, in accordance with its annual programme of work, and to submit a progress report to the General Assembly at its sixty-seventh session.

73. The adoption of the resolution by the Human Rights Council gives rise to additional requirements of \$73,900 for the implementation of the requested activities, including: (a) \$25,900 for the conference services processing of documentation under section 2, General Assembly and Economic and Social Council affairs and conference management; and (b) \$48,000 for consultancy at the P-4 level for six months to assist the Independent Expert by conducting research and drafting a conceptual framework for the commentary to the guiding principles on foreign debt and human rights, under section 24, Human rights, of the programme budget for the biennium 2012-2013, as detailed in table 21 below.

(a) Requested the Office of the United Nations High Commissioner for Human Rights to convene, in 2013, a seminar of two working days on the right to enjoy the benefits of scientific progress and its applications in order to further clarify the content and scope of this right and its relationship with other human rights and fundamental freedoms, including the right of everyone to the protection of the moral and material interests resulting from any scientific, literary or artistic production of which he or she is the author;

(b) Requested the Office of the High Commissioner:

(i) To invite States, the Special Rapporteur in the field of cultural rights and other relevant stakeholders, including academic experts and civil society organizations, as well as relevant United Nations agencies, funds and programmes and other international organizations, to participate actively in the seminar;

(ii) To submit to the Council, at the twenty-sixth session, a report in the form of a summary, on the seminar.

76. The adoption of the resolution by the Human Rights Council gives rise to additional requirements of \$181,900 for the implementation of the requested activities, including: (a) \$56,600 for interpretation in four languages (English, French, Spanish and Russian) and the translation of documentation into all United Nations official languages, under section 2, General Assembly and Economic and Social Council affairs and conference management; (b) \$124,700 for general temporary assistance at the P-3 level for four months to prepare a background paper for the seminar and to draft the report on the seminar; and travel and daily subsistence allowance for five experts and five participants from all regions, as well as the Special Rapporteur in the field of cultural rights, to Geneva and back to participate in the two-day seminar, under section 24, Human rights; and (c) \$600 for conference support services under section 29E, Administration, Geneva, of the programme budget for the biennium 2012-2013, as detailed in table 22 below.

human rights in Belarus; and to report annually to the Council and to the General Assembly in accordance with their respective programmes of work.

79. The adoption of the resolution by the Human Rights Council gives rise to additional requirements of \$404,400 for the implementation of the requested activities, including: (a) \$148,100 for interpretation during field missions and processing of the reports to the Human Rights Council and to the General Assembly, under section 2, General Assembly and Economic and Social Council affairs and conference management; and (b) \$256,300 for general temporary assistance at the P-3 level for 12 months to assist the Special Rapporteur; two field missions of the Special Rapporteur per year to Belarus, neighbouring or other relevant States, of an average duration of 10 days each; three trips to Geneva per year for consultations and/or to attend the annual meeting of special rapporteurs and to present a report to the Council; one trip to New York per year to present a report to the Assembly; travel of one staff member of the Office of the High Commissioner for Human Rights to accompany the Special Rapporteur during field missions; and general operating expenses incurred during field missions, including transportation, security and communications, under section 24, Human rights, of the programme budget for the biennium 2012-2013, as detailed in table 23 below.

(b) Decided that the working group would hold its first session for four working days in 2013, before the twenty-second session of the Council;

(c) Requested the President of the Council to invite the Chair of the Advisory Committee drafting group on the draft declaration to participate at the first session of the working group;

(d) Requested the working group to submit a report on progress made to the Council for consideration at its twenty-third session.

83. The adoption of the resolution by the Human Rights Council gives rise to additional requirements of \$329,300 for the implementation of the requested activities, including: (a) \$156,600 for interpretation services for four working days in all six official United Nations languages and the translation of the report on progress made into all six languages and its publication as an official document, under section 2, General Assembly and Economic and Social Council affairs and conference management; (b) \$169,800 for general temporary assistance at the P-3 and General Service levels for six work-months each to provide support to the working group and to prepare a report, and for return travel and daily subsistence allowance for four working days for the Chair of the Advisory Committee drafting group on the draft declaration, under section 24, Human rights; and (c) \$2,900 for conference support services under section 29E, Administration, Geneva, of the programme budget for the biennium 2012-2013, as detailed in table 24 below.

(b) Requested the Working Group, in preparing those draft basic principles and guidelines:

(i) To seek the views of States, relevant United Nations agencies, intergovernmental organizations, United Nations treaty bodies and, in particular, the Human Rights Committee, other special procedures, national human rights institutions, non-governmental organizations and other relevant stakeholders;

(ii) To submit a specific report to the Council on national, regional and international laws, regulations and practices on the right of anyone deprived of

his or her liberty by arrest or detention to bring proceedings before court, as stated in paragraph 6 (d) of the resolution;

(iii) To hold subsequently a consultation with stakeholders in relation to the preparation of the first draft basic principles and guidelines;

(iv) To present the draft basic principles and guidelines to the Council before the end of 2015, in accordance with its annual programme of work.

86. The adoption of the resolution by the Human Rights Council gives rise to additional requirements of \$237,200 for the implementation of the requested activities, including: (a) \$30,300 for interpretation services for a two-day meeting in Geneva and the translation of documentation under section 2, General Assembly and Economic and Social Council affairs and conference management; (b) \$205,700 for consultancy at the P-2 level for 12 months, including 6 months in 2013 and 6 months in 2014, to assist the Working Group on Arbitrary Detention in the compilation of laws, regulations and practices, and for travel of 10 regional experts from the five regions and of the Chair and the Rapporteur of the Human Rights Committee to Geneva under section 24, Human rights; and (c) \$1,200 for conference support services under section 29E, Administration, Geneva, under the programme budget for the biennium 2012-2013 and the proposed programme budget for the biennium 2014-2015, as detailed in table 25 below.

Technical assistance to Côte d'Ivoire in the field of human rights

95. Under the terms of paragraphs 14 and 15 of resolution 20/19, the Human Rights Council:

(a) Decided to renew the mandate of the Independent Expert on the situation of human rights in Côte d'Ivoire for a period of one year, from the twentieth to the twenty-third session of the Council;

(b) Requested the Independent Expert to submit his report at the twenty-second session and his recommendations at the twenty-third session of the Council.

96. The mandate of the Independent Expert on the situation of human rights in Côte d'Ivoire falls under the category of activities considered to be of a perennial nature. Resources for such activities are provided under section 2, General Assembly and Economic and Social Council affairs and conference management, and section 24, Human rights, of the programme budget for the biennium 2012-2013 for activities of the Independent Expert, in the total amount of \$396,500, including: (a) \$148,100 for conference services under section 2; and (b) \$248,400 for staff support, travel of the Independent Expert and staff, and general operating expenses incurred during field missions, under section 24, as detailed in table 28 below.

Situation of human rights in Eritrea

98. Under the terms of paragraph 4 of resolution 20/20, the Human Rights Council decided to appoint a special rapporteur on the situation of human rights in Eritrea for a period of one year, who would submit a report to the Council at its twenty-third session.

99. The adoption of the resolution by the Human Rights Council gives rise to additional requirements of \$448,000 for the implementation of the requested activities, including: (a) \$148,100 for interpretation during field missions and the conference services processing and translation of documentation under section 2, General Assembly and Economic and Social Council affairs and conference management; and (b) \$299,900 for general temporary assistance at the P-3 level for 12 months to assist the Special Rapporteur; two missions of the Special Rapporteur and one accompanying staff member to Eritrea, neighbouring or other relevant States, of an average duration of 10 days each; three trips of the Special Rapporteur to Geneva per year (of 5 days' duration each) for consultations and to attend the annual meeting of special rapporteurs and to report to the Council; and general operating expenses incurred during field missions, including car hire, security and escort services and a number of United Nations Humanitarian Air Service flights within Eritrea and between Eritrea and the relevant neighbouring States, under section 24, Human rights, of the programme budget for the biennium 2012-2013, as detailed in table 29 below.

100. Provisions for the requested activities were not made in the programme budget for the biennium 2012-2013. Therefore, additional appropriations of \$448,000, including \$148,100 under section 2, General Assembly and Economic and Social Council affairs and conference management, and \$299,900 under section 24, Human rights, will be sought under the terms of the contingency fund for the biennium 2012-2013.

101. In addition, the amount of \$17,500 will be required under section 37, Staff assessment, to be offset by an equivalent amount under income section 1, Income from staff assessment.

DD. Resolution 20/21

Assistance to Somalia in the field of human rights

102. Under the terms of paragraph 14 of resolution 20/21, the Human Rights Council decided to extend the mandate of the Independent Expert on the situation of human rights in Somalia for one year, from September 2012, with a view to maximizing the provision and flow of technical assistance to Somalia in the field of human rights, in order to support the efforts of the Transitional Federal Government, the successor Government and Somali subnational authorities to ensure respect for human rights and to strengthen the human rights regime, including in relation to the presidential and parliamentary speaker elections, as well as other key tasks that must be completed, and to advise the Transitional Federal Government and the successor Government, as well as the United Nations and the international community, on the steps that need to be taken to ensure that the environment is conducive to the free exchange of ideas and views and the conduct of elections, and requested the Independent Expert to report to the Council at its twenty-fourth session on the situation of human rights and the implementation of technical cooperation in Somalia.

103. The mandate of the Independent Expert falls under the category of activities considered to be of a perennial nature. Resources for such activities are provided under section 2, General Assembly and Economic and Social Council affairs and conference management, and section 24, Human rights, of the programme budget for the biennium 2012-2013 for activities of the Independent Expert, in the total amount of \$263,300, including: (a) \$148,100 for conference services under section 2; and (b) \$115,200 for staff support, travel of the Independent Expert and staff, and general operating expenses incurred during field missions, under section 24, as detailed in table 30 below.

**Contribution of the United Nations system as a whole to the

105. Under the terms of paragraphs 10, 11 and 12 of resolution 21/5, the Human Rights Council:

(a) Requested the Secretary-General to report, from within existing resources, to the Council at its twenty-sixth session on the challenges, strategies and developments with regard to the implementation of the resolution by the United Nations system, including programmes, funds and agencies, and to make concrete recommendations for action;

(b) Requested the Secretary-General to undertake a feasibility study to explore the establishment of a global fund to enhance the capacity of stakeholders to advance the implementation of the Guiding Principles on Business and Human Rights; the study should explore relevant issues, including how to secure multi-stakeholder engagement, governance models and funding options; stakeholders should be involved in a consultative process using existing channels such as the Forum on Business and Human Rights, consultations with the Working Group on the issue of human rights and transnational corporations and other business enterprises, and written and other informal consultations; and the conclusions should be presented to the Council and included in the report of the Secretary-General in June 2014;

(c) Decided to organize a panel discussion at the twenty-second or twenty-third session of the Council, with high-level representatives from relevant United Nations programmes, funds and agencies to discuss strategies for advancing the business and human rights agenda by the United Nations system, ideally as a topic for the annual half-day discussion on human rights mainstreaming at its twenty-second session.

106. The report requested in paragraph 10 of resolution 21/5 is already provided for in the programme budget for the biennium 2012-2013.

107. The requests made in paragraphs 11 and 12 of the resolution give rise to additional requirements of \$47,300 to provide for consultancy at the P-4 level for three months to prepare a feasibility study and a scoping paper for the informal consultations; and travel and daily subsistence allowance for five experts to attend a panel during the twenty-second or twenty-third session of the Human Rights Council, under section 24, Human rights, of the programme budget for the biennium 2012-2013, as detailed in table 31 below.

The adoption of the resolution by the Human Rights Council gives rise to additional requirements of \$45,800 for the implementation of the requested activities, including: (a) \$37,100 for the translation of documentation into all official languages under section 2, General Assembly and Economic and Social Council affairs and conference management; and (b) \$8,700 for one trip of the Independent Expert to New York per year for the presentation of the report to the General Assembly under section 24, Human rights, of the programme budget for the biennium 2012-2013, as detailed in table 32 below.

While resources for activities of the Independent Expert in the amount of \$91,600 are included in the programme budget for the biennium 2012-2013, provisions for the presentation of the report to the General Assembly, as requested in resolution 21/10, are not. Safety of journalists

112. Under the terms of paragraph 12 of resolution 21/12, the Human Rights Council requested the Office of the United Nations High Commissioner for Human Rights, in collaboration with the Special Rapporteur on the promotion and protection of the right to freedom of opinion and expression, to prepare, working in consultation with States and other relevant stakeholders, a compilation of good practices in the protection of journalists, the prevention of attacks and the fight against impunity for attacks committed against journalists, and to present the compilation in a report to the Council at its twenty-fourth session.

113. The adoption of the resolution by the Human Rights Council gives rise to additional requirements of \$97,000 for the implementation of the requested activities, including: (a) \$38,500 for the processing and translation of the requested final report on best practices into all official languages under section 2, General Assembly and Economic and Social Council affairs and conference management; and (b) \$58,500 for consultancy at the P-3 level for nine months to assist with the substantive research work, all related documentation, maintaining liaison with all relevant stakeholders and assisting in the compilation of laws, regulations and practices, under section 24, Human rights, of the programme budget for the biennium 2012-2013, as detailed in table 33 below.

(a) Decided to convene, at its twenty-second session, from within existing resources, a panel discussion on the issue of the negative impact of corruption on the enjoyment of human rights;

(b) Requested the Office of the United Nations High Commissioner for Human Rights to organize the panel discussion, and to liaise with States, relevant United Nations bodies, agencies, treaty bodies and special procedures, in particular the United Nations Office on Drugs and Crime and the United Nations Development Programme, international organizations, in particular the Anti-Corruption Academy, and relevant regional human rights mechanisms, as well as with civil society, non-governmental organizations and national human rights institutions, with a view to ensuring their participation in the panel discussion;

(c) Requested the Office of the High Commissioner to prepare and submit a summary report on the panel discussion to the Council at its twenty-third session.

116. The adoption of the resolution by the Human Rights Council gives rise to additional requirements of \$56,200 for the implementation of the requested activities, including: (a) \$22,200 for interpretation and the translation of documentation under section 2, General Assembly and Economic and Social Council affairs and conference management; and (b) \$33,400 for return travel to Geneva and daily subsistence allowance for a one-day meeting for five international experts to participate in the panel discussion under section 24, Human rights; and (c) \$600 for conference support services under section 29E, Administration, Geneva, of the programme budget for the biennium 2012-2013 as detailed in table 34 below.

As the participation of such experts has usually resulted in the need for additional resources that could not easily be provided from within existing resources, clear guidance is sought from the General Assembly in this regard.

II. Resolution 21/16

The rights to freedom of peaceful assembly and of association

119. Under the terms of paragraph 8 of resolution 21/16, the Human Rights Council requested the Special Rapporteur on the rights to freedom of peaceful assembly and of association to present an annual report to the General Assembly.

120. The adoption of the resolution by the Human Rights Council gives rise to additional requirements of \$43,700 for the implementation of the requested activities, including: (a) \$35,900 for the conference services processing of the report and its translation into all official languages under section 2, General Assembly and Economic and Social Council affairs and conference management; and (b) \$7,800 for travel of the Special Rapporteur to New York to present a report at the annual session of the General Assembly under section 24, Human rights, of the programme budget for the biennium 2012-2013 as detailed in table 35 below.

While resources in the amount of \$87,400 for the presentation of the report of the Special Rapporteur to the Human Rights Council are included in the programme budget for the biennium 2012-2013, provisions for the presentation of the report to the General Assembly, as requested in resolution 21/16, are not. 122. Under the terms of paragraphs 1, 2, 4 and 6 of resolution 21/19, the Human Rights Council:

(a) Decided to establish an open-ended intergovernmental working group with the mandate of negotiating, finalizing and submitting to the Council a draft United Nations declaration on the rights of peasants and other people working in rural areas, on the basis of the draft submitted by the Advisory Committee, and without prejudging relevant past, present and future views and proposals;

(b) Decided that the working group would hold its first session for five working days in 2013, before the twenty-third session of the Council;

(c) Requested the President of the Council to invite the Rapporteur of the Advisory Committee drafting group on the draft declaration to participate in the first session of the working group;

(d) Requested the working group to submit a report on progress made to the Council for its consideration at its twenty-sixth session.

123. The adoption of the resolution by the Human Rights Council gives rise to additional requirements of \$767,600 for the implementation of the requested activities, including: (a) \$425,400 for interpretation for the first five-day annual session of the working group and the translation of documentation into all official languages, under section 2, General Assembly and Economic and Social Council affairs and conference management; (b) \$333,200 for general temporary assistance at the P-4 level for four months per year to serve as secretary of the working group, and at the General Service level for three months per year to assist with preparations for, the servicing of and follow-up to the session; and travel and daily subsistence allowance for the Rapporteur of the Advisory Committee drafting group to attend the first five-day session of the working group in Geneva, under section 24, Human rights; and (c) \$9,000 for conference support services under section 29E, Administration, Geneva, of the programme budget for the biennium 2012-2013 and the proposed programme budget for the biennium 2014-2015, as detailed in table 36 below.

(b) Requested the Office of the United Nations High Commissioner for Human Rights to organize the panel discussion and to liaise with States, relevant United Nations bodies, agencies, treaty bodies, special procedures and regional human rights mechanisms, as well as with civil society, including non-governmental organizations, and national human rights institutions, with a view to ensuring their participation in the panel discussion;

(c) Requested the Office of the High Commissioner to prepare a report on the panel discussion in the form of a summary.

126. The adoption of the resolution by the Human Rights Council gives rise to additional requirements of \$68,700 for the implementation of the requested activities, including: (a) \$28,700 for the translation of the report on the panel discussion into all official languages under section 2, General Assembly and Economic and Social Council affairs and conference management; and (b) \$40,000 for travel of one treaty body member and/or special procedures mandate holder and of five experts (one from each region) to Geneva to participate in the panel discussion, under section 24, Human rights, of the programme budget for the biennium 2012-2013, as detailed in table 37 below.

128. As regards the decision to convene a high-level panel discussion to commemorate the twentieth anniversary of the adoption of the Vienna Declaration and Programme of Action, the attention of the Human Rights Council was drawn to the provisions of Economic and Social Council resolution 1980/67 and General Assembly resolution 61/185, which provided that expenditures for the proclamation and celebration of international years and anniversaries, and activities connected with them, should normally be met from within existing resources.

LL. Resolution 21/21

Enhancement of technical cooperation and capacity-building in the field of human rights

129. Under the terms of paragraphs 3 and 4 of resolution 21/21, the Human Rights Council:

(a) Decided, in accordance with paragraphs 3 and 4 of its resolution 18/18, that the theme for an annual thematic panel discussion under agenda item 10, to be held during the twenty-second session of the Council, would be “Promoting technical cooperation for the strengthening of the judiciary system and administration of justice in order to ensure human rights and rule of law”;

(b) Requested the Office of the United Nations High Commissioner for Human Rights to prepare a report on activities undertaken by the Office, other

relevant United Nations agencies, in particular the United Nations Office on Drugs and Crime, and, where applicable, regional organizations to support efforts by States to strengthen their judiciary system and administration of justice, for submission to the Council at its twenty-second session, to serve as a basis for the thematic panel discussion, and to liaise with States, relevant United Nations bodies and agencies, relevant special procedures and other stakeholders, including, where applicable, those involved in technical cooperation projects that demonstrate best practices, constructive engagement and positive impact on the ground, with a view to ensuring their participation in the thematic panel discussion.

130. The adoption of the resolution by the Human Rights Council gives rise to additional requirements of \$65,200 for the implementation of the requested activities, including: (a) \$28,400 for the processing of the report and its translation into all official languages under section 2, General Assembly and Economic and Social Council affairs and conference management; and (b) \$36,800 for general temporary assistance at the P-4 level for two months for the collection of relevant information on technical cooperation projects and best practices under section 24, Human rights, of the programme budget for the biennium 2012-2013, as detailed in table 38 below.

The human rights of older persons

132. Under the terms of paragraphs 9 and 10 of resolution 21/23, the Human Rights Council requested the Office of the United Nations High Commissioner for Human Rights:

(a) To organize, in Geneva, an intersessional public consultation on the promotion and protection of the human rights of older persons, with the participation of States Members of the United Nations, relevant international organizations, United Nations agencies and stakeholders, in order to receive information and share good practices on the matter;

(b) To present a summary report on the consultation to the Council at its twenty-fourth session.

133. The adoption of the resolution by the Human Rights Council gives rise to additional requirements of \$55,300 for the implementation of the requested activities, including: (a) \$21,400 for interpretation during the one-day consultation and the translation and processing of the summary report under section 2, General Assembly and Economic and Social Council affairs and conference management; (b) \$33,300 for travel and daily subsistence allowance for five international experts to participate in the consultation in Geneva under section 24, Human rights; and (c) \$600 for conference support services under section 29E, Administration, Geneva, of the programme budget for the biennium 2012-2013, as detailed in table 39 below.

Human rights and indigenous peoples

135. Under the terms of paragraph 11 of resolution 21/24, the Human Rights Council decided to hold, from within existing resources, at its twenty-fourth session, a half-day panel discussion on the World Conference on Indigenous Peoples.

136. The adoption of the resolution by the Human Rights Council gives rise to additional requirements of \$21,000 for travel to and from Geneva and daily subsistence allowance for five panellists (one from each region) to participate in the session under section 24, Human rights, of the programme budget for the biennium 2012-2013, as detailed in table 40 below.

137. Provisions for the requested activities were not made in the programme budget for the biennium 2012-2013. Therefore, an additional appropriation of \$21,000 under section 24, Human rights, will be sought under the terms of the contingency fund for the biennium 2012-2013.

138. In this connection, it is emphasized that since the establishment of the Council, its working methods have implied that every panel discussion requested in the Council's resolutions must include the participation of several experts on the subject matter under consideration to provide substantive input. As the participation of such experts has usually resulted in the need for additional resources that could not easily be provided from within existing resources, clear guidance is needed from the General Assembly in this regard.

OO. Resolution 21/26

Situation of human rights in the Syrian Arab Republic

139. Under the terms of paragraphs 17, 18 and 22 of resolution 21/26, the Human Rights Council:

(a) Decided to extend the mandate of the independent international commission of inquiry on the Syrian Arab Republic established by the Council in its resolution S-17/1, and requested the commission to continue its work and to present a written report on the human rights situation in the Syrian Arab Republic at an interactive dialogue during the twenty-second session of the Council;

(b) Requested the commission of inquiry to continue to update its mapping exercise of gross violations of human rights in the Syrian Arab Republic since March 2011, including the assessment of casualty figures, and to publish it periodically;

(c) Decided to transmit all reports and oral updates of the commission of inquiry to all relevant bodies of the United Nations and the Secretary-General for appropriate action.

140. The adoption of the resolution by the Human Rights Council gives rise to additional requirements of \$2,920,200 for the implementation of the requested activities, including: (a) \$225,300 for interpretation and the translation of documentation under section 2, General Assembly and Economic and Social Council affairs and conference management; and (b) \$2,694,900 for general temporary assistance for a core secretariat to support the commission, including salaries and travel of 1 P-5 coordinator, 15 P-3 and/or P-4 officers (legal, investigative, analytical and archivist), 3 assistants and 5 seconded advisers on gender, child protection, the prevention of genocide and military matters for a period of between one and six months, depending on the responsibilities of the position (the proposed staff additional to the previous mandate (see Council resolution 19/22) are a Chief of Investigations, five additional investigators to enable the commission to conduct interviews with refugees in neighbouring countries and to meet with victims in the Syrian Arab Republic if access is granted, one additional analyst to support the review of interviews conducted by investigators along with an associate analyst, an archivist to ensure the comprehensive filing of the work of the commission of inquiry and three additional seconded experts, on sexual and gender-based violence, children in armed conflict and crimes against humanity (prevention of genocide)); consultancy and travel resources for a forensic pathologist for three months and a media adviser for one month; travel and accommodation for the commissioners to Geneva, New York, the Syrian Arab Republic and neighbouring countries, in addition to close protection detail and travel and accommodation for staff accompanying the commissioners; and local costs for transportation, communications, consumables and other operating costs, under section 24, Human rights, of the programme budget for the biennium 2012-2013, as detailed in table 41 below.

141. Of the total amount of \$2,920,200 required for the implementation of the activities requested in resolution 21/26, the related provision of \$225,300 is already included under section 2, General Assembly and Economic and Social Council affairs and conference management, of the programme budget for the biennium 2012-2013. Therefore, the net additional provision of \$2,694,900 will be sought under section 24, Human rights, under the terms of the contingency fund for the 2012-2013 biennium.

PP. Resolution 21/27

Technical assistance for the Sudan in the field of human rights

142. Under the terms of paragraphs 13 and 15 of resolution 21/27, the Human Rights Council:

(a) Requested the Office of the United Nations High Commissioner for Human Rights to provide the Sudan with the necessary technical support and training;

(b) Decided to renew the mandate of the Independent Expert on the situation of human rights in the Sudan under agenda item 10 for a period of one year, and

requested the Independent Expert to continue his engagement with the Government of the Sudan with a view to implementing the projects that would further help Sudan to fulfil its human rights obligations, and to submit a report to the Human Rights Council for consideration at its twenty-fourth session.

143. The mandate of the Independent Expert falls under the category of activities considered to be of a perennial nature. Resources for such activities are provided under section 2, General Assembly and Economic and Social Council affairs and conference management, and section 24, Human rights, of the programme budget for the biennium 2012-2013 for activities of the Independent Expert, in the total amount of \$239,400 per annum, including: (a) \$159,700 for conference services under section 2; and (b) \$79,700 for travel of the Independent Expert to Geneva for consultations, to present his report to the Human Rights Council and to participate in the annual meeting of special rapporteurs, for travel of the Independent Expert and accompanying staff to the Sudan, and for general operating expenses incurred during field missions, under section 24, as detailed in table 42 below.

144. No additional appropriation will be requested as a result of the adoption of the resolution. Owing to the perennial nature of the activities of the Independent Expert, the related requirements will continue to be considered in the context of proposed programme budgets.

QQ. Resolution 21/28
Technical assistance and capacity-building for South Sudan in the field of human rights

145. Under the terms of paragraphs 6 and 7 of resolution 21/28, the Human Rights Council requested the Office of the United Nations High Commissioner for Human Rights:

(a) To provide South Sudan with the necessary technical support and training;

(b) To submit a written report on the progress of technical assistance and capacity-building in the field of human rights for South Sudan to the Council at its twenty-third session.

146. The adoption of the resolution by the Human Rights Council gives rise to additional requirements of \$63,900 for the implementation of the requested activities, including: (a) \$24,700 for the conference services processing, translation and production of the report under section 2, General Assembly and Economic and Social Council affairs and conference management; and (b) \$39,200 for travel and daily subsistence allowance for one OHCHR staff member from Geneva to Juba for five days, and for operating costs for the organization of six training programmes and 12 workshops (with meeting facilities to be provided by the Government), under section 24, Human rights, of the programme budget for the biennium 2012-2013, as detailed in table 43 below.

147. Provisions for the requested activities are not included in the programme budget for the biennium 2012-2013. Therefore, additional appropriations of \$63,900, including \$24,700 under section 2, General Assembly and Economic and Social Council affairs and conference management, and \$39,200 under section 24,

Human rights, will be sought under the terms of the contingency fund for the biennium 2012-2013.

III. Conclusions and action required of the General Assembly

148. As reflected in the annex to the present report, the implications of the resolutions and decisions adopted by the Human Rights Council at its nineteenth, twentieth and twenty-first sessions, in 2012, give rise to total requirements of \$13,605,300 under the programme budget for the biennium 2012-2013.

149. Of those requirements of \$13,605,300, the amount of \$3,066,900 relates to activities of a perennial nature and therefore is already included in the programme budget for the biennium 2012-2013; it is proposed that an amount of \$3,076,600 be financed through the redeployment of existing resources; and the amount of \$7,461,800 represents additional requirements for the biennium 2012-2013, including \$2,130,900 under section 2, General Assembly and Economic and Social Council affairs and conference management, \$5,317,200 under section 24, Human rights, and \$13,700 under section 29E, Administration, Geneva, of the programme budget for the biennium 2012-2013. It is proposed that the additional requirements of \$7,461,800, which include resources for the establishment of a new P-3 post to support the activities of an Independent Expert, as provided for in Human Rights Council resolution 19/10, on human rights and the environment, be financed under the terms of the contingency fund for the biennium 2012-2013.

150. In summary, the General Assembly is requested:

(a) To approve additional appropriations, representing a charge against the contingency fund for the biennium 2012-2013, in the amount of \$7,461,800, including \$2,130,900 under section 2, General Assembly and Economic and Social Council affairs and conference management, \$5,317,200 under section 24, Human rights, and \$13,700 under section 29E, Administration, Geneva, of the programme budget for the biennium 2012-2013;

(b) To approve the establishment, as at 1 January 2013, of one new P-3 post under section 24, Human rights, of the programme budget for the biennium 2012-2013.

151. In connection with paragraph 150 above, the amount of \$70,200 will be required under section 37, Staff assessment, of the programme budget for the biennium 2012-2013, to be offset by an equivalent amount under income section 1, Income from staff assessment.
