Report of the Secretary-General on the United Nations Disengagement Observer Force for the period from 1 July to 31 December 2012 (S/2012/897)

The President (*spoke in Arabic*): The Security Council will now begin its consideration of the item on its agenda.

Members of the Council have before them document S/2012/935, which contains the text of a draft resolution submitted by France, the Russian Federation and the United States of America.

I wish to draw the attention of Council members to document S/2012/897, which contains the report

of the Secretary-General on the United Nations Disengagement Observer Force for the period from 1 July to 31 December 2012.

It is my understanding that the Council is ready to proceed to the vote on the draft resolution before it. I shall put the draft resolution to the vote now.

A vote was taken by show of hands.

In favour:

Azerbaijan, China, Colombia, France, Germany, Guatemala, India, Morocco, Pakistan, Portugal, Russian Federation, South Africa, Togo, United Kingdom of Great Britain and Northern Ireland and United States of America

The President (*spoke in Arabic*): There were 15 votes in favour. The draft resolution has been adopted unanimously as resolution 2084 (2012).

The Security Council has thus concluded the present stage of its consideration of the item on its agenda.
