Accreditation of private sector and civil society organizations to the Second United Nations Conference on Landlocked Developing Countries

Note by the Secretariat

1. General Assembly resolution 68/270, stresses the importance of the effective participation of relevant stakeholders, including the civil society and the private sector, in the Conference and all its preparatory processes. It is requested that in accordance with ECOSOC resolution (1996/31), the secretariat of the Conference shall be responsible for the receipt and preliminary evaluation of requests for accreditation to the Conference and furthermore the secretariat of the Conference shall work in close collaboration with the NGO Branch of the Secretariat to review the relevance of the work of the applicants on the basis of their background and involvement in all issues relevant to the Conference. It is requested that the Secretariat, publish the list of applications received and submit to the Preparatory Committee for a decision on such applications.
2. The Secretariat for the Conference has conducted a due diligence process and identified the attached list of such organisations to be invited to participate in the Second United Nations Conference on Landlocked Developing Countries (LLDC), see Annex I.
