Item 3**Strengthening subregional, regional and interregional dialogue and cooperation and their contributions to economic integration and development**

3. The third session of the Multi-year Expert Meeting on Promoting Economic Integration and Cooperation will be held in accordance with the terms of reference approved on 18 November 2013. The objective of this session is to discuss how strengthening subregional, regional and interregional dialogue and cooperation can contribute to economic integration and development of developing countries and transition economies.

4. Development-oriented economic integration of developing countries into the world economy can spur global growth and reduce poverty and inequality in the world. However, identifying successful ways and means of achieving this integration remains a daunting challenge. In an era of a less favourable trade environment, export-led strategies of developing countries and countries with transition economies are reaching their limits. Adjusting to the changing dynamics of the world economy will necessarily involve relying more on regional and domestic markets. Regional integration at various levels, however, faces different challenges, and solutions may involve diverse policies, mechanisms and instruments.

5. The third session of the multi-year expert meeting will explore under what conditions trade could become a growth engine in a process of regional integration. Participants will also discuss productive integration as the basis of development-oriented regional integration, given that the issue of infrastructure continues to be pivotal for a deeper regional productive integration. The potential role of regional value chains as a possible way forward for development-oriented regional integration will also be highlighted. Finally, the issues related to financing for development-oriented regional integration will be explored. Bridging the gap between the investment needs of developing countries and transition economies, in particular their infrastructure needs, and the current available finance will be critical for any form of deeper regional productive integration. Experts are expected to bring to the meeting their own perspectives and to highlight specific issues in connection with their areas of expertise.

6. To facilitate discussion, the UNCTAD secretariat has prepared a background note. In addition, experts are encouraged to prepare articles on the subject under discussion. These papers will be made available at the meeting in the form and language in which they are received.
