Transforming and strengthening the Multinational Programming and Operational Centres of the Economic Commission for Africa

At its second regular session of 1990, the Economic and Social Council took note of the report of the Review Team appointed by the Secretary-General, in which it is concluded that the structure, organization and operations of the Multinational Programming and Operational Centres of the Economic Commission for Africa should be maintained, transformed and strengthened; strongly supported the conclusions of the Review Team; adopted the new mandate of the Centres as proposed by the Review Team; strongly urged the General Assembly to provide the Centres with additional human and financial resources to enable them to respond more effectively to multinational and multisectoral programming requirements based on priorities identified by member States, and to provide immediately a minimum core of such resources; and urged the General Assembly and donor and technical assistance organizations to provide the Centres with sufficient resources for the formulation and implementation of programmes for the effective participation of women in the development process of their respective subregions (resolution 1990/76).

At its second regular session of 1990, the Economic and Social Council, noting with great distress that the persistent and substantial shortfall in the contributions of member States to the African Institute for Economic Development and Planning will inevitably force its closure in 1990 if no remedial action is taken, called upon the General Assembly, as a matter of urgency, to approve the inclusion of four key posts for the Institute in the United Nations regular budget, namely, the Director, the Chief of Administration and Finance and two senior lecturers, in line with the recommendation contained in Economic and Social Council resolution 1985/62 of 26 July 1985, to enable the Institute to carry out its approved work programme and functions on a continued and sustained basis as stipulated in its Statute (Economic and Social Council resolution 1990/72).

The General Assembly will need to fill the seats being vacated by the following States: Colombia, Cuba, France, Germany, Federal Republic of, Ghana, Greece, Guinea, India, Ireland, Japan, Lesotho, Liberia, Libyan Arab Jamahiriya, Portugal, Saudi Arabia, Trinidad and Tobago, Venezuela and Yugoslavia. As stipulated in rule 146 of the rules of procedure, a retiring member is eligible for immediate re-election.

(c) Election of five members of the International Court of Justice

In accordance with Articles 3 and 4 of its Statute, the International Court of Justice consists of 15 members elected by the General Assembly and the Security Council. Under Article 13 of the Statute, members of the Court are elected for a term of nine years and may be re-elected. A regular election of five judges is held every three years.

The General Assembly, along with the Security Council, will need to fill the seats to be vacated on 5 February 1991 by the following five members: Mr. Ruda, Mr. Mbaye, Sir Robert Jennings, Mr. Guillaume and Mr. Pathak.
