### Programme budget implications of draft resolution A/40/L.4

### Report of the Fifth Committee

Rapporteur: Mr. Falk MELTKE (German Democratic Republic)

- 1. At its 25th meeting, on 4 November 1985, the Fifth Committee, pursuant to rule 153 of the rules of procedure of the General Assembly, considered the statement by the Secretary-General (A/C.5/40/35) on the program budget implications of draft resolution A/40/L.4. The related report of the Advisory Committee on Administrative and Budgetary Questions was presented orally by its Chairman.
- 2. Statements and comments made in the course of the Committee's consideration of this item are reflected in the relevant summary record (A/C.5/40/SR.25).

#### DECISION OF THE FIFTH COMMITTEE

3. The Fifth Committee decided, by a recorded vote of 91 to 18, with 10 abstentions, to inform the General Assembly that, should it adopt draft resolution A/40/L.4, an additional appropriation of \$75,000 would be required under section 3B of the proposed programme budget for the biennium 1986-1987 in respect of the Ad Hoc Committee of the International Conference on Kampuchea.

## Against:

Afghanistan, Angola, Bulgaria, Byelorussian Soviet Socialist Republic, Congo, Cuba, Czechoslovakia, Democratic Yemen, Ethiopia, German Democratic Republic, Hungary, Lao People's Democratic Republic, Libyan Arab Jamahiriya, Mongolia, Poland, Ukrainian Soviet Socialist Republic, Union of Soviet Socialist Republics, Viet Nam.

Abstaining: Algeria, Benin, Finland, India, Iraq, Madagascar, Mexico, Uganda, United Republic of Tanzania, Zimbabwe.

5. The Fifth Committee then decided, without a vote, to inform the General Assembly that, should it adopt draft resolution A/40/L.4, a total additional appropriation of \$479,300 would be required in 1986 under section 3 (Political affairs, trusteeship and decolonization) of the proposed programme budget for the biennium 1986-1987 (\$75,000 under section 3B and \$404,300 under section 3E). In addition, an amount of \$112,800 would be required for staff assessment under section 31 (Staff assessment), to be offset by an increase of the same magnitude in the estimates of income under income section 1 (Income from staff assessment).
