PROVISIONAL AGENDA

Note by the Secretary-General

1. The thirty-sixth session of the Commission on Human Rights will be held at the United Nations Office at Geneva from 4 February to 14 March 1980. The first meeting of the thirty-sixth session will be convened at 11 a.m. on Monday, 4 February 1980.
2. At its 1523rd meeting on 14 March 1979, the Commission considered a draft provisional agenda for its thirty-sixth session prepared by the Secretary-General in compliance with Economic and Social Council resolution 1894 (LVII). By its decision 16 (XXXV) of the same date, the Commission took note of that draft as revised in the light of the discussion.
3. It is submitted herewith as the provisional agenda for the thirty-sixth session of the Commission drawn up in accordance with rule 5 of the Rules of Procedure of the Functional Commissions of the Economic and Social Council. It contains in addition an item entitled "Question of international legal protection of the human rights of individuals who are not citizens of the country in which they live" in accordance with Economic and Social Council decision 1979/36 of 10 May 1979 as item 24.
4. In connexion with item 10 (a) it may be mentioned that in conformity with Commission resolution 18 (XXXV) and with the approval of the Economic and Social Council a working group open to all members of the Commission is scheduled to meet for one week immediately before the thirty-sixth session of the Commission, from 28 January to 1 February 1979.
5. With reference to item 18 entitled "Draft declaration on the elimination of all forms of intolerance and of discrimination based on religion or belief", it may be recalled that the Commission, by its resolution 20 (XXXIV) decided to establish a working group open to all members of the Commission which would meet on a regular basis throughout the thirty-sixth session of the Commission to continue the elaboration of the draft declaration.
