INTERNATIONAL COVENANTS ON HUMAN RIGHTS

Report of the Third Committee

Rapporteur: Mr. Mario DE LEON (Philippines)

I. INTRODUCTION

- 1. At its 3rd plenary meeting, on 21 September 1990, the General Assembly, on the recommendation of the General Committee, decided to include in its agenda the item entitled "International Covenants on Human Rights" and to allocate it to the Third Committee.
- 2. The Third Committee considered the item jointly with items 89, 93, 97, 106, 109 and 110 at its 35th to 42nd, 49th, 51st, 55th, 57th, 59th, 61st and 62nd meetings, on 7 to 9, 12 to 14, 21, 23 and 28 to 30 November, and 3 and 4 December 1990. An account of the Committee's general discussion of the item is contained in the relevant summary records (A/C.3/45/SR.35-42).
- 3. For its consideration of the item, the Committee had before it the following documentation:

- (c) Report of the Secretary-General on the status of the International Covenant on Economic, Social and Cultural Rights, the International Covenant on Civil and Political Rights and the Optional Protocols to the International Covenant on Civil and Political Rights (A/45/403);

- 4. At the 35th meeting, on 7 November, the Director of the Implementation of International Instruments and Procedures Branch of the Centre for Human Rights made an introductory statement (see A/C.3/45/SR.35).

II. CONSIDERATION OF DRAFT RESOLUTION A/C.3/45/L.53

- 5. At the 49th meeting, on 21 November, the representative of Sweden, on behalf of Algeria, Australia, Austria, the Byelorussian Soviet Socialist Republic, Canada, Costa Rica, Denmark, Ecuador, El Salvador, Finland, Hungary, Iceland, Italy, the Netherlands, New Zealand, Norway, Peru, the Philippines, Poland, Senegal, Spain, Sweden and the Union of Soviet Socialist Republics, introduced a draft resolution (A/C.3/45/L.53), entitled "International Covenants on Human Rights". Subsequently, Cyprus joined in sponsoring the draft resolution.
- 6. At the 55th meeting, on 28 November, the Committee adopted the d.aft resolution without a vote (see para. 8 below).

7. After the adoption of the draft resolution, the representative of Saudi Arabia made a statement.

III. RECOMMENDATION OF THE THIRD COMMITTEE

8. The Third Committee recommends to the General Assembly the adoption of the following draft resolution:

International Covenants on Human Rights

The General Assembly,

Recalling its resolution 44/129 of 15 December 1989 and Commission on Human Rights resolution 1990/20 of 23 February 1990,

Mindful that the International Covenants on Human Rights 4/ constitute the first all-embracing and legally binding international treaties in the field of human rights and, together with the Universal Declaration of Human Rights, 5/ form the core of the International Bill of Human Rights,

Considering that the twenty-fifth anniversary of the adoption of the Covenants on 16 December 1991 provides an appropriate occasion to focus on the fundamental importance and special status of these basic human rights instruments of the United Nations,

Taking note of the report of the Secretary-General on the status of the International Covenant on Economic, Social and Cultural Rights, the International Covenant on Civil and Political Rights and the Optional Protocols to the International Covenant on Civil and Political Rights, 6/

Noting, in this regard, that a number of States Members of the United Nations have yet to become parties to the International Covenants on Human Rights,

Recalling the International Covenant on Economic, Social and Cultural Rights 4/ and the International Covenant on Civil and Political Rights, and reaffirming that all human rights and fundamental freedoms are indivisible and interrelated and that the promotion and protection of one category of rights should never exempt or excuse States from the promotion and protection of the other,

Recognizing the important role of the Human Rights Committee in the implementation of the International Covenant on Civil and Political Rights and the Optional Protocols thereto, 4/

Also recognizing the important role of the Committee on Economic, Social and Cultural Rights in the implementation of the International Covenant on Economic. Social and Cultural Rights,

Welcoming the submission to the General Assembly of the annual report of the Human Rights Committee $\frac{7}{2}$ and the report of the Committee on Economic, Social and Cultural Rights on its fourth session, $\frac{8}{2}$

Considering that the effective functioning of treaty bodies established in accordance with the relevant provisions of international instruments on human rights plays a fundamental role and hence represents an important continuing concern of the United Nations,

Noting with concern the critical situation with regard to overdue reports from States parties to the International Covenants on Human Rights,

Taking note with appreciation of the recommendations and conclusions of the meeting of persons chairing human rights treaty bodies, held at Geneva from 1 to 5 October 1990, 2/

- 1. Takes note with appreciation of the report of the Human Rights Committee on its thirty-seventh, thirty-eighth and thirty-ninth sessions, 4/ including the suggestions and recommendations of a general nature approved by the Committee;
- 2. <u>Also takes note with appreciation</u> of the report of the Committee on Economic, Social and Cultural Rights on its fourth session, including its suggestions and recommendations;
- 3. Expresses its satisfaction with the serious and constructive manner in which both Committees are carrying out their function;
- 4. Urges States parties to the International Covenants on Human Rights to pay active attention to the protection and promotion of civil and political rights, as well as economic, social and cultural rights, taking into consideration their indivisible and interrelated character and the fact that the promotion and protection of one category of rights should never exempt or excuse States from the promotion and protection of the other rights;

- 5. <u>Urges</u> those States parties to the International Covenant on Civil and Political Rights that have been requested by the Human Rights Committee to provide additional information to comply with that request;
- 6. <u>Also urges</u> States parties to fulfil their reporting obligations under the International Covenants on Human Rights;
- 7. Notes with satisfaction that the majority of States parties to the International Covenant on Civil and Political Rights and an increasing number of States parties to the International Covenant on Economic, Social and Cultural Rights have been represented by experts in the presentation of their reports, thereby assisting the respective monitoring bodies in their work, and hopes that all States parties to both Covenants will arrange such representation in the future;
- 8. Again urges all States that have not yet done so to become parties to the International Covenant on Economic, Social and Cultural Rights and the International Covenant on Civil and Political Rights, and to consider acceding to the Optional Protocols to the International Covenant on Civil and Political Rights;
- 9. <u>Invites</u> the States parties to the International Covenant on Civil and Political Rights to consider making the declaration provided for in article 41 of the Covenant;
- 10. <u>Emphasizes</u> the importance of the strictest compliance by States parties with their obligations under the International Covenant on Economic, Social and Cultural Rights and the International Covenant on Civil and Political Rights and, where applicable, the Optional Protocols to the International Covenant on Civil and Political Rights;
- 11. Stresses the importance of avoiding the erosion of human rights by derogation, and underlines the necessity of strict observance of the agreed conditions and procedures for derogation under article 4 of the International Covenant on Civil and Political Rights, bearing in mind the need for States parties to provide the fullest possible information during states of emergency, so that the justification for and appropriateness of measures taken in these circumstances can be assessed;
- 12. Appeals to States parties to the Covenants that have exercised their sovereign right to make reservations in accordance with relevant rules of international law to consider whether any such reservations should be reviewed;
- 13. <u>Urges</u> States parties to the International Covenant on Economic, Social and Cultural Rights, the specialized agencies and other relevant United Nations bodies to extend their full support and co-operation to the Committee on Economic, Social and Cultural Rights;

- 14. <u>Welcomes</u> the adoption by the Committee on Economic, Social and Cultural Rights of a general comment (No. 2) regarding international technical assistance measures in relation to article 22 of the Covenant;
- 15. Requests the Secretary-General to keep the Human Rights Committee and the Committee on Economic, Social and Cultural Rights informed of the relevant activities of the General Assembly, the Economic and Social Council, the Commission on Human Rights, the Commission on the Status of Women, the Sub-Commission on Prevention of Discrimination and Protection of Minorities, the Committee on the Elimination of Racial Discrimination, the Committee on the Elimination of Discrimination against Women, the Committee against Torture and, where appropriate, other functional commissions of the Economic and Social Council and the specialized agencies, and also to transmit the annual reports of the Human Rights Committee and the Committee on Economic, Social and Cultural Rights to those bodies;
- 16. Also requests the Secretary-General to ensure that the Centre for Human Rights of the Secretariat effectively assists the Human Rights Committee and the Committee on Economic, Social and Cultural Rights in the implementation of their respective mandates;
- 17. Again urges the Secretary-General, taking into account the suggestions of the Human Rights Committee, to take determined steps to give more publicity to the work of that Committee and, similarly, to the work of the Committee on Economic, Social and Cultural Rights;
- 18. Encourages all Governments to publish the texts of the International Covenant on Economic, Social and Cultural Rights, the International Covenant on Civil and Political Rights and the Optional Protocols to the International Covenant on Civil and Folitical Rights in as many languages as possible and to distribute them and make them known as widely as possible in their territories;
- 19. Requests the Secretary-General to submit to the General Assembly at its forty-sixth session, under the agenda item entitled "International Covenants on Human Rights", a report on the status of the International Covenant on Economic, Social and Cultural Rights, the International Covenant on Civil and Political Rights and the Optional Protocols to the International Covenant on Civil and Political Rights;
- 20. <u>Decides</u> to hold a commemorative meeting in honour of the Covenants on 16 December 1991, the twenty-fifth anniversary of their adoption.
