ANNEX

The United States of America has kidnapped five senior Libyan Officers who had been prisoners of war in Chad, and has removed them by force from Zaire territory to an unknown place. There is no doubt that the United States will endeavour to use them for ends hostile to their country, and perhaps for acts of sabotage that would serve its own interests.

The kidnapping and the related hostile, criminal and inhuman acts are a flagrant violation of the 1949 Geneva Convention relative to the Treatment of Prisoners of War, and are clearly incompatible with its provisions. Apart from the fact that the United States is neither a protecting Power under the Convention, nor a neutral Power, it is not a party to the conflict. The provisions of this Convention, or of any other convention, do not authorize it to take any action regarding the Libyan prisoners of war; any such action would therefore be devoid of legality.

By this action the United States has also failed to fulfil the contractual obligations of Contracting Parties under Article I to ensure respect for the provisions of the 1949 Geneva Convention relative to the Treatment of Prisoners of War.

These flagrant violations on the part of the United States Administration of the provisions of the 1949 Geneva Conventions, especially the third Convention, oblige us resolutely to call for action that would enable the Libyan prisoners of war to return home immediately. We also call upon the United States authorities to respect the international Covenants and Conventions already adopted by the international community.
