REPORT BY THE SECRETARY-GENERAL CONCERNING THE CREDENTIALS OF THE REPRESENTATIVES AND DEPUTY AND ALTERNATE REPRESENTATIVES OF THE MEMBERS OF THE SECURITY COUNCIL ELECTED FOR THE PERIOD 1986-1987

At its 38th meeting, on 17 October 1985, the General Assembly elected Bulgaria, the Congo, Ghana, the United Arab Emirates and Venezuela as non-permanent members of the Security Council for a term of two years, beginning on 1 January 1986.

Pursuant to rule 15 of the provisional rules of procedure of the Security Council, the Secretary-General wishes to report that, with regard to the representation of the members of the Security Council elected for the period 1986-1987, he has received the communications referred to hereunder.

<u>Bulgaria</u>. Credentials signed on 10 December 1985 by the Minister for Foreign Affairs of Bulgaria state that Mr. Boris Tzvetkov has been appointed representative of Bulgaria on the Security Council, Mr. Ivan Garvalov deputy representative and Mr. Evgueni Alexandrov alternate representative.

In the opinion of the Secretary-General, these credentials are in order.

<u>Ghana</u>. Credentials signed on 18 December 1985 by the Secretary responsible for Foreign Affairs of Ghana state that Mr. James Victor Gbeho has been appointed representative of Ghana on the Security Council, Mr. Kwesi Buegyam Sarsah Simpson deputy representative and Mr. Henry Mills-Lutterodt alternate representative.

In the opinion of the Secretary-General, these credentials are in order.

United Arab Emirates. Credentials signed on 9 December 1985 by the Minister of State for Foreign Affairs of the United Arab Emirates state that Mr. Mohammad Hussain Al-Shaali has been appointed representative of the United Arab Emirates on the Security Council.

In the opinion of the Secretary-General, these credentials are in order.

The Secretary-General has received a letter dated 31 December 1985 from the Permanent Representative of the United Arab Emirates to the United Nations stating

that Mr. Mohammad S. Al-Mosfir has been appointed deputy representative of the United Arab Emirates on the Security Council and Mr. Khalifa S. Al-Merree alternate representative.

In the opinion of the Secretary-General, these credentials are in order.

Venezuela. The Secretary-General has received a telegram dated
26 December 1985 from the Minister for Poreign Affairs of Venezuela stating that
Mr. José Francisco Sucre-Figarella has been appointed representative of Venezuela
on the Security Council and Mr. Reinaldo Pabon García deputy representative.

In the opinion of the Secretary-General, this communication constitutes adequate provisional credentials.
