After the heading relating to draft resolution A/C.2/44/L.11 add the following paragraphs:

48a. Mr. YENEL (Turkey) asked whether it might not be more appropriate from a procedural point of view for paragraph 2 of the draft resolution to read "Requests that the Ad Hoc Committee ...", rather than "Recommends that the Ad Hoc Committee ...".

48b. Mr. EL GHOUAYEL (Tunisia) said that it was legally impossible for the General Assembly to make a recommendation to one of its subsidiary organs.

48c. Mr. STORY (Secretary of the Committee) said that the General Assembly was the master of its own procedure. Consequently, if it wished to make a recommendation rather than a request to one of its subsidiary organs it could do so.

48d. Mr. DJOGHLAF (Algeria) noted that the draft resolution had been submitted by the Chairman following intensive consultations during which all delegations and regional groups had had an opportunity to state their positions. The text should not be changed, and it was in fact inappropriate to raise procedural issues at the current time.

48e. Mr. YENEL (Turkey) said that he had merely raised a question relating to the Committee's standard procedure, and had not requested a change in the text. He did wish to point out, however, that not all delegations had been privy to the negotiations conducted in connection with the informal consultations.
