#### I. INTRODUCTION

- 1. At its 3rd plenary meeting, on 21 September 1990, the General Assembly, on the recommendation of the General Committee, decided to include in its agenda the item entitled:
  - "Development and international economic co-operation:
  - "(a) International development strategy for the fourth United Nations development decade (1991-2000);
  - "(b) Trade and development;
  - "(c) Review and appraisal of the implementation of the Substantial New Programme of Action for the 1980s for the Least Developed Countries;
  - "(d) Food problems;
  - "(e) New and renewable sources of energy;
  - "(f) Development of the energy resources of developing countries"

and to allocate it to the Second Committee.

2.
