AMENDMENTS TO THE POISONS REGULATIONS OF 1973

Department of Health, Brisbane, 29th January, 1981

THE Deputy Governor, for and on behalf of His Excellency the Governor, acting by and with the advice of the Executive Council and in pursuance of the provisions of the <u>Health</u> <u>Act</u> 1937-1980, has approved of the following Regulations made by the Director-General of Health and Medical Services for the State of Queensland.

I, Peter Gordon Livingstone, Director-General of Health and Medical Services for the State of Queensland, by and with the approval of the Executive Council and in pursuance of the provisions of the <u>Health Act</u> 1937-1980, do hereby make the following amendments to the Regulations made under the said Act:-

"The Poisons Regulations of 1973" 1/ are amended as follows:-

1. Regulation 3 is amended by deleting the heading to Part D and inserting the following:

"Prohibitions and Authorities in respect of Dangerous Drugs, Restricted Drugs and Prohibited Plants."

2. Part D of the Regulations is amended by deleting the heading thereto and inserting the following:

"PROHIBITIONS AND AUTHORITIES IN RESPECT OF DANGEROUS DRUGS, RESTRICTED DRUGS AND PROHIBITED PLANTS"

3. Regulation D2 is amended by inserting the following as Regulation D2.18.:-

"D2.18. The Commissioner of Police or his nominee is hereby authorised subject to the provisions of these Regulations:

- (a) to acquire or obtain the prohibited plants or any species of a genus of such plants set out in the Schedule below; and
- (b) to have in or upon the premises of the Queensland Police Department the prohibited plants or any species of a genus of such plants set out in the said Schedule.

- (a) Indian Hemp (Cannabis Sativa);
- (b) Mushroom (Psilocybe Cubensis);
- (c) Opium Poppy (Papaver Somniferum)."

CUSTOMS (PROHIBITED IMPORTS) REGULATIONS

NOTICE UNDER REGULATION 5. NOTICE No. 1, 23 March 1981

I, John Colinton Moore, Minister of State for Business and Consumer Affairs, in pursuance of sub-regulation 5(3) of the Customs (Prohibited Imports) Regulations 2/ approve the importation into Australia of a drug specified in, or included in a class of drugs specified in, the Schedule to this notice.

The Schedule

Narcotic drugs

Preparations of:

Acetyldihydrocodeine Codeine Dihydrocodeine Ethylmorphine Nicocodine Nicodicodine Norcodeine Pholcodine 11 8 1 4 4 4

when compounded with one or more other ingredients (other than tabletting media) not being another drug listed in the Fourth Schedule other than those drugs listed above and containing not more than a total of 100 mg of the narcotic drugs per dosage unit (i.e. per tablet, ampoule etc.) and with a concentration of not more than 2.5 per cent in undivided preparations (liquid, or powder not made up into tablets or ampoules).

Cocaine in substances containing not more than the equivalent of 0.1 per cent of cocaine base.

'DF 118' - Dihydrocodeine bitartrate tablets and ampoules.

Difenoxin in substances containing, per dosage unit, not more than 0.5 mg of difenoxin and a quantity of atropine sulphate equivalent to at least 5 per cent of the dose of difenoxin.

Diphenoxylate in substances containing, per dosage unit, not more than 2.5 mg of diphenoxylate calculated as base and a quantity of atropine sulphate equivalent to at least 1 per cent of the dose of diphenoxylate.

'Dover's Powder' - Pulvis ipecacuanhae et opii compositus.

Morphine in substances containing not more than the equivalent of 0.2 per cent of anhydrous morphine.

Opium tinctures and extracts containing not more than 0.2 per cent of anhydrous morphine.

Propiram - preparations containing not more than 100 mg of propiram per dosage unit and compounded with at least the same amount of methylcellulose.

<u>Note</u>: The above exemptions apply to preparations compounded in such a way that the narcotic drug cannot be recovered by readily applicable means or in a yield which would constitute a risk to public health.

Provided that the product is for in vitro use only and is labelled prior to distribution, 'Caution - may be infectious'.

Drug Analytical Standards consisting of substances in Schedules II, III or IV of the Convention on Psychotropic Substances 1971 dissolved in methanol in single use vials with a concentration not exceeding 1 mg/ml and a maximum vial content of 1 ml.

Drug mixtures of two or more substances in Schedules II, III or IV of the Convention on Psychotropic Substances 1971 in a solvent and a strength not exceeding 0.2 mg/ml for individual substances and a total substance content of 1.0 mg/ml and a maximum vial content of 1 ml.

AMENDMENTS TO THE POISON ACT, 1962

PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

Whereas by section 4 of the <u>Poisons Act</u> 1962 <u>3</u>/ it is amongst other things enacted that the Governor in Council may, by Proclamation published in the Government Gazette, amend any of Schedules One, Two, Three, Four, Five, Six, Seven or Eight to such Act by adding to any such Schedule or removing therefrom any item:

Now therefore, I, the Governor of the State Victoria, in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State do by this my Proclamation:

1. Amend Schedule Two to the said Act by removing therefrom the following items:

Dihydrocodeine in substances containing 1 per centum or less of Dihydrocodeine.

3. Amend Schedule Three to the said Act by removing therefrom the following items:

Barbituric Acid and derivatives thereof in substances containing 0.2 per centum or less of Barbituric Acid or its derivatives.

4. Amend Schedule Three to the said Act by adding thereto the following items:

Dihydrocodeine in substances containing 1 per centum or less of Dihydrocodeine.

5. Amend Schedule Four to the said Act by removing therefrom the following items:

Barbituric Acid and substances containing more than 0.2 per centum of Barbituric Acid.

Pentazocine.

Phenmetrazine.

Propiram in substances containing not more than 100 milligrams of Propiram per dosage unit and compounded with at least the same amount of methyl cellulose.

10. Amend Schedule Seven to the said Act by adding thereto the following items: Section 3 Acetorphine. 153

11. Amend Schedule Eight to the said Act by removing therefrom the following items: Acetorphine. Acetyldihydrocodeine and preparations containing more than 2.5 per centum of acetyldihydrocodeine. Heptane derivatives having addiction properties, not specifically included in this Schedule. Levomethorphan. Levorphanol (Levorphan). Morphinan and derivatives of morphinan such as 3-hydroxy-N-phenethylmorphinan, morphinan, racemorphan. Morphine-N-Oxide and its derivatives. Morphinone and derivatives of morphinone such as methyldihydromorphinone, hydromorphone. Nicocodine and preparations containing more than 2.5 per centum of nicocodine. Nicodicodine (6-nicotinyl-dihydrocodeine or 6 (pyridine-3-carboxylic acid) codeine ester) and in preparations containing more than 2.5 per centum of nicodicodine except when included in Schedule Two or Schedule Four. Opium in any form except the alkaloid Papaverine. Pholcodine and preparations containing more than 2.5 per centum of Pholcodine. Piperidine derivatives with hypnotic properties such as allylprodine, alphaprodine, benzethidine, betaprodine, hydroxypethidine, ketobemidone, alphameprodine, betameprodine, etoxeridine, furethidine, morpheridine, phenampromide, phenoperidine, piminodine, trimeperidine; and their salt preparations, admixtures, extracts or other substances containing any proportion of such piperidine derivatives. Propiram except when included in Schedule Four. Pyrrolidine derivatives with hypnotic properties such as racemoramide, levomoramide, dextromoramide. Any active principle, any natural or synthetic derivative, any salt and any compound of the substances specified in this Schedule and any preparation or admixture of such substances, active principles, derivatives, salts or compounds unless otherwise provided for in this or any other Schedule. 12. Amend Schedule Eight to the said Act by adding thereto the following items: A substance specified in this Schedule includes: (a) any salt, active principle, derivative, compound, alkaloid, stereoisomer, ester and ether of the substance and any salt of such active principle, derivative, compound, alkaloid, stereoisomer, ester and ether; and (b) any preparation or admixture containing any proportion of the substance, salt, active principle, derivative, compound, alkaloid, stereoisomer, ester or ether, unless specifically exempted or specifically included in any other Schedule. Acetyldihydrocodeine except when included in Schedule Two or Schedule Four. Allylprodine. 5.35.35 Benzethidine. Betameprodine. Codeine-N-Oxide. Dextromoramide. Dihydrocodeine except when included in Schedule Three or Schedule Four. Ethylmorphine except when included in Schedule Two or Schedule Four. Etoxeridine. Furethidine. Heptane derivatives having addiction-inducing properties, not specifically included in this Schedule. Levomethorphan except its stereoisomers. - (c) with one or more other medicaments in undivided preparations with a concentration of not more than 0.5 per cent of codeine.

Explanatory Note

This order extensively alters the lists of substances set out in Schedules 2 to 8 of the <u>Poisons List Order</u> (S.R. 1975, No. 217).

Schedule 2 of the <u>Poisons List</u> specifies substances that are dangerous to life if misused or carelessly handled but that should, nevertheless, be available to the public without undue restriction.

Schedule 3 specifies substances that are designed for therapeutic use and which may require special advice as to their use.

Schedule 4 specifies substances the supply of which is permitted only by a medical practitioner, dentist, or veterinary surgeon, or by a pharmacist on the prescription of a medical practitioner, dentist, or veterinary surgeon. Amendment of Schedule 8 of the Schedule to Principal Order. Schedule 5 specifies substances that are commonly used for domestic purposes and which are of a dangerous nature but should be readily available to the public.

Schedule 6 specifies substances that are readily available to the public for industrial, agricultural, veterinary, and other purposes.

Schedule 7 specifies substances that are of an exceptionally dangerous nature and require special care in their manufacture and handling.

Schedule 8 specifies substances that are capable, or are potentially capable, of producing drug dependency in persons using them.

PROCLAMATION 25 NOVEMBER 1981

Pursuant to section 22 of the Poisons Act 1964-1978 I, the Governor, acting with the advice and consent of the Executive Council and on the recommendation of the Poisons Advisory Committee constituted under Part II of that Act, do hereby:

(a) cancel the proclamation made under that section and published in the <u>Government</u> <u>Gazette</u> on 21 December 1979 and every other proclamation previously so made; and

(b) prohibit the sale, supply or use:

- (i) of the substances referred to in Part A of the Schedule to this proclamation, except with the consent in writing of the Commissioner of Public Health;
- (ii) for human therapeutic use, of the substances referred to in Part B of the Schedule to this proclamation, except with the consent in writing of the Commissioner of Public Health; and
- (iii) of the substances referred to in Part C of the Schedule to this proclamation, except with the consent in writing of the Commissioner of Public Health, which consent shall not be given other than to the sale, supply or use of such a substance, for the purpose of the conduct of medical or scientific research (including clinical trials), in such quantity as may, in a particular case, be necessary for that purpose.
