

HEM Joint Resolution No. 1041

A HOUSE OF ELECTED MEMBERS JOINT RESOLUTION

To acknowledge that Bill No. 1134, DI, and Bill No. 1128, DI, have become Public Laws 6-8-15 and 6-8-16, respectively, by operation of Law.

WHEREAS, Bill No. 1134, DI, entitled: "To appropriate 4US 58,000.00 from the General Fund of the Palau Legislature for the acquisition and installation of 1,500 kilowatt generator on Malakal Island, Koror Municipality and for other purposes", was passed by the Palau Legislature on 25 June 1979: and

WHEREAS, Bill No. 1128, DI, entitled: "To appropriate the sum of ^cUS 50,000.00 from the General Fund of the Palau Legislature to purchase a haemodialysis unit and to cover the contingent expenses thereof for the first six months of 1980 and for other purposes", was bassed by the Palau Legislature on 25 June 1979; and

WHFREAS, Bill No. 1134, DI and Bill No. 1128, DI were transmitted and received by the Office of the High Commissioner of the Trust Territory of the Pacific Islands on 27 June 1979; and

WHEREAS, the High Commissioner has taken no action with regard to the bills in the 10-day review period allowed him by paragraph I, section 13, of Secretarial Order 2918, which is applicable to Palau by virtue of Secretarial Order 3027; now therefore,

EE IT RESOLVED by the Sixth Palau Legislature, eighth regular session, that Bill No. 1134, DI, has now become effective, and is Public Law 6-8-15; and

BE IT FURTHER RESOLVED that Bill No. 1128, DI, has also become effective, and is Public Law 6-8-16; and

BE IT FURTHER RESOLVED that certified copies of this joint resolution be transmitted to the High Commissioner, the District Administrator, the District Finance Officer, the Palau Treasurer, the Secretary of the Interior, the Director of Territorial Affairs, Ambassador Peter R. Rosenblatt, United States Ambassador Richard W. Petree, the President of the United Nations Trusteeship Council and the head of the United Nations Visiting Mission.
