HEM RESOLUTION NO. 004

A HOUSE OF ELECTED MEMBERS RESOLUTION

To repeal resolution No. 75(1)-2 1/ as amended by resolution No. 76(S)-4 and to dissolve the Palau Political Status Commission as established thereunder.

BE IT RESOLVED by the House of Elected Members of the Seventh Palau Legislature, first regular session, January 1980, that resolution No. 75(1)-2, which created an 11-member Palau Political Status Commission on 28 April 1975 and which was later amended by resolution No. 76(S)-4 by increasing its membership to 17, is hereby repealed in its entirety. The Palau Political Status Commission as established by said resolution No. 75(1)-2, as amended, is dissolved effective 3 January 1980; PROVIDED, HOWEVER, that the subject Commission, its officers and staff, shall not be relieved of their responsibility under law for proper accountability and return to the Seventh Palau Legislature any and all property, equipment, supplies, records and files acquired through use of public funds, and PROVIDED, FURTHER, that any outstanding obligations or existing liabilities of said Commission incurred during its existence shall not devolve upon nor be assumed by its successor commission or by the Seventh Palau Legislature; and

BE IT FURTHER RESOLVED, that certified copies of this resolution be transmitted to the United Nations Trusteeship Council, Ambassador Peter R. Rosenblatt, the President of the Federated States of Micronesia, President of the Government of the Marshall Islands, the High Commissioner of the Trust Territory of the Pacific Islands, the Acting District Administrator of Palau District, the Chairman of the House of Chiefs and the Speaker of the House of Elected Members of the Seventh Palau Legislature.
