Report of the Fifth Committee

Rapporteur: Mr. Falk MELTKE (German Democratic Republic)

1. At its 50th meeting, on 29 November 1985, the Fifth Committee, pursuant to rule 153 of the rules of procedure of the General Assembly, considered the statement by the Secretary-General (A/C.5/40/64) on the programme budget implications of draft resolutions A/40/L.21 and A/40/L.22. The related report of the Advisory Committee on Administrative and Budgetary Questions was presented orally by its Chairman.
2. Statements and comments made in the course of the Committee's consideration of this item are reflected in the relevant summary record (A/C.5/40/SR.50).

DECISION OF THE FIFTH COMMITTEE

3. The Fifth Committee decided, by a recorded vote of 98 to 3, with 8 abstentions to inform the General Assembly that, should it adopt draft resolutions A/40/L.21 and A/40/L.22, no additional appropriations would be required.

4. The voting was as follows:

In favour: Afghanistan, Algeria, Angola, Argentina, Austria, Bahrain, Bangladesh, Barbados, Benin, Botswana, Brazil, Brunei Darussalam, Bulgaria, Burkina Faso, Burma, Burundi, Byelorussian Soviet Socialist Republic, Cameroon, Chile, China, Congo, Cuba, Czechoslovakia, Democratic Kampuchea, Democratic Yemen, Denmark, Dominican Republic, Ecuador, Egypt, Ethiopia, Fiji, Finland, Gabon, German Democratic Republic, Ghana, Greece, Guinea-Bissau, Guyana, Honduras, Hungary, Indonesia, Iran (Islamic Republic of), Ireland, Ivory Coast (Côte d'Ivoire), Japan, Jordan, Kenya, Kuwait, Lebanon, Lesotho, Liberia, Libyan Arab Jamahiriya, Madagascar, Malaysia, Maldives, Mauritania, Mexico, Mongolia, Morocco, Nepal, New Zealand, Niger, Nigeria, Norway, Oman, Pakistan, Papua New Guinea, Peru, Philippines, Qatar, Romania, Rwanda, Saudi Arabia, Senegal, Singapore, Somalia, Spain, Sri Lanka, Sudan, Swaziland, Sweden, Syrian Arab Republic, Thailand, Togo, Trinidad and Tobago, Tunisia, Turkey, Uganda, Ukrainian Soviet Socialist Republic, Union of Soviet Socialist Republics, United Arab Emirates, United Republic of Tanzania, Venezuela, Viet Nam, Yugoslavia, Zaire, Zambia, Zimbabwe.

Against: Israel, United Kingdom of Great Britain and Northern Ireland, United States of America.

Abstaining: Australia, Belgium, Canada, France, Germany, Federal Republic of, Italy, Netherlands, Portugal.

5. Subsequently, the representatives of Guinea, India, Iraq, Mali and Yemen stated that, had their delegations been present during the vote, they would have voted in favour.
