- 23.1 The programme of work of the Economic Commission for Africa (ECA) is derived from Programme 30, Regional cooperation for development in Africa, of the medium-term plan for the period 1992-1997. The programme is aimed at facilitating concerted action for the economic development of Africa, including its social aspects, and maintaining and strengthening economic cooperation in the region and the cooperation of the African countries with other countries of the world. that context, the activities will continue to address the issues of sustainable African economic recovery, development and cooperation as mandated in various resolutions adopted by the General Assembly, the Economic and Social Council and the Commission itself. Specifically the activities will focus on promotion of policy reform measures to bring about structural changes in the region in line with the objectives of the Lagos Plan of Action, the United Nations Programme of Action for African Economic Recovery and Development 1986-1990 (UNPAAERD) and the African Alternative Framework to Structural Adjustment Programmes for Socio-Economic Recovery and Transformation. Particular attention will be paid to the economic development and integration of the least developed, land-locked and island countries, and the identification and formulation of subregional projects in such critical sectors as food and agriculture, industry, transport and communications, and energy.
- 23.2 The Commission provides overall direction to the work of its secretariat, which has primary responsibility for the implementation of activities programmed under this section. The Commission is a subsidiary body of the Economic and Social Council, established by Council resolution 671 (XXV) of 25 April 1958. The Commission meets annually for five days. Its principal policy-making organ is the Conference of Ministers. In the organization of its work, the Conference is supported by its Technical Preparatory Committee of the Whole. The Commission has a number of principal subsidiary bodies: the Conferences of African Ministers of Tourism; Environment; Social Affairs; Industry; Finance; Transport and Communications and Planning; Human Resources Planning, Development and Utilization; Least Developed Countries; Trade and their subsidiary bodies; The Joint Conference of African Planners; Statisticians and Demographers; the Intergovernmental Committee for Human Settlement and Environment; the African Regional Coordinating Committee for the Integration of Women in Development; the Technical Committee on Nuclear Science and Technology; the Regional Conference on Development and Utilization of Mineral Resources in Africa; the Committees of Intergovernmental Experts of the multinational programming and operational centres (MULPOCs), the Conference of Vice-Chancellors, Presidents and Rectors of Institutions of Higher Learning in Africa, the Committee of Nile Basin Countries and the Technical Committee for Pan-African Development Information System.
- 23.3 The secretariat of the Commission will provide substantive and technical services to the Conference of Ministers and its subsidiary machinery, including economic and social analyses and research of specific issues, organization of seminars and other events in member countries and for groups of countries, technical cooperation activities in the region, dissemination of information and advisory assistance to Member States.
- 23.4 In the course of the implementation of its programme of work, ECA will continue to collaborate with relevant specialized agencies and United Nations programmes, including subsidiary organs of the Economic and Social Council. It will also maintain close coordination with intergovernmental and non-governmental organizations and institutions of the region on issues related to its programme of work.

Subprogramme 1. Development issues and policies in the ECA region*

23.9 The subprogramme addresses the need for the continuous promotion of the process of economic and social development and growth in Africa and the encouragement of a regional approach to development and social analysis and planning in the context of the Lagos Plan of Action and the African Alternative Framework for Structural Adjustment Programmes for Socio-Economic Recovery and Transformation through support to countries and subregions. In particular, the subprogramme will aim at: the elaboration of long-term perspectives and plans, the formulation of long-term, medium-term and short-term strategies and policies, and the development and strengthening of national capacities in short-term and medium-term forecasting, planning and modelling for better integration and coordination of short-term and medium-term objectives. Within this scope, the subprogramme will assist in the planning, management, monitoring and evaluation of human resources development and utilization. It will also focus on policy and institutional development for enhancing the capability of Member States to collect, store, retrieve and disseminate information on issues of African development.

Activities:

1. Parliamentary services

Parliamentary documentation: five reports to the Conference of Ministers (seventeenth and eighteenth sessions) on: economic reports for Africa (2);* progress in implementation of activities on the operationalization of regional development strategies (2); social situation in the region; two reports to the Conference of the African Ministers of Social Affairs on social development and policy challenges in Africa; and on the progress of the implementation of the African Charter for Social Action; three reports to the Joint Conference of African Planners, Statisticians and Demographers on short-term forecasting and outlook for some individual African countries;* on the future role of planning in Africa's development and socio-economic transformation; and on the structure of African markets in the perspectives of the African Common Market.

2. Published materials

coordination with the United Nations Educational, Scientific and Cultural Organization (UNESCO) on human resources planning, development and utilization; contribution in activities of the Inter-agency Task Force meeting on human resources development and utilization in Africa.

Resource requirements (at revised 1991 rates)

Redeployment of posts

23.10 The redeployment of one P-3 post from subprogramme 6, Public administration and fiscal affairs, and one P-2 and one General Service (Local level) posts from subprogramme 7, Social development, is proposed. At the same time, one P-4 post is proposed for redeployment from this subprogramme to subprogramme 6.

Temporary assistance

23.11 The requirements of \$22,100 are for engaging national experts to collect information in connection with the preparation of the annual <u>Survey of Economic and Social Conditions in Africa</u>.

Consultants

23.12 The estimated requirements of \$43,100 relate to specialized expertise required for conducting studies and research for reports and publications to be issued in the context of the work programme.

Ad hoc expert groups

23.13 The estimated requirements of \$55,500, involving a resource growth of \$10,000, relate to the convening of two expert group meetings to study performance of the African economies in the light of social and economic conditions in the region and to assess confidence-building factors in school curricula.

Travel of staff

23.14 The requirements under this heading of \$148,200 relate to attendance at meetings, seminars and other activities to be organized in the region in the context of the work programme and trips for collection of data and information for the preparation of reports and other documents.

External printing and binding

23.15 The requirements of \$44,800 relate to the publishing of the <u>Annual Survey of</u> Economic and Social Conditions in Africa.

Grants

23.16 A non-recurrent provision of \$850,000 relates to a grant to the African Institute for Economic Development and Planning (IDEP) to finance the posts of the Director (D-1), Chief of Administration (P-5) and two senior lecturers (P-4). It would be recalled that following a request by the Economic and Social Council that the General Assembly approve the inclusion of four posts of IDEP in the United Nations regular budget, the Assembly in section V of its resolution 45/248 A, upon

recommendation by the Advisory Committee on Administrative and Budgetary Questions, approved, as an interim measure, a subvention from the regular budget for 1990-1991 to finance four posts of IDEP and at the same time requested the Governing Council of UNDP to urge the Administration of UNDP to give full backing to the short-term training programme and the research and advisory services of IDEP and to continue its support for the activities of the Institute. The action taken by the Governing Council on this request will be reported to the General Assembly at its forty-sixth session. In the meantime, a subvention for 1992-1993 is proposed.

Subprogramme 2. Economic cooperation and integration in Africa*

23.17 The activities planned under this subprogramme comprise those of five MULPOCs located in Niamey, Tangier, Gisenyi, Yaoundé and Lusaka and related subregional activities of a coordinating nature by ECA, the secretariat in Addis Ababa. The activities during the biennium 1992-1993 will be aimed at making the integration process in Africa more operational. To this end, special attention will be paid to making more effective the instruments for economic cooperation and integration of the Africa region. At the subregional level, the subprogramme aims strengthening the capacity of intergovernmental organizations as effective instruments of self-sustaining and self-reliant development; assisting African countries and their intergovernmental organizations in the identification and implementation of integration projects; advancing proposals for the harmonization and rationalization of the integration projects; advancing proposals for the harmonization and rationalization of the integration activities of various intergovernmental organizations; reviewing and appraising the integration activities planned and undertaken by intergovernmental organizations. At the regional level, the subprogramme will continue to identify and promote South-South cooperation activities in order to enhance economic cooperation and integration in It will also provide assistance to the secretariat of the Organization of African Unity (OAU) in the creation of an African economic community. subprogramme will also assist African countries and their intergovernmental organizations in the identification of projects and areas suitable for cooperation between two or more subregions especially in the context of the future African economic community.

Activities:

1. International cooperation

External relations: assistance by MULPOCs to regional and subregional intergovernmental and non-governmental organizations towards the harmonization and coordination of their activities in their respective fields of responsibility; consultations within the Joint OAU/ECA/African Development Bank secretariat as regards the establishment, functioning of and assistance to the African Economic Community.

2. Parliamentary services

Parliamentary documentation: Tangier-based MULPOC: a report to the Commission through the Committee of Intergovernmental Experts of the Tangier-based MULPOC on preventive measures against locusts and grasshoppers invasion in North Africa.

3. Published materials

(a) Nine recurrent publications: bulletin of ECA-sponsored institutions; pamphlet on activities of Lusaka MULPOC (2); women and development (2) (Gisenyi-based MULPOC); small-scale food industry technologies and their use in rural areas of the Economic Community of the Great Lakes Countries (2)

Three ad hoc expert group meetings on: interlinking post-apartheid South Africa economy with those of other subregions (XB); the establishment of multinational enterprises (to be organized by the Lusaka-based MULPOC) (XB); the impact of currency exchange rate fluctuations on economic cooperation and integration process in Central Africa (to be organized by the Yaoundé-based MULPOC) (XB).
 - 5. Operational activities
 - (a) Advisory services to be provided by:
- (i) The Commission's secretariat to: Federation of Chambers of Commerce and Industry for the promotion and establishment of multinational ventures and for developing technical cooperation projects which can be implemented with other developing countries;* Member States on regional approach to maritime environment for fight against pollution, desertification, deforestation and protection of maritime resources;
- (ii) <u>Lusaka-based MULPOC</u>: mining and mineral resources development and utilization; human resources capacity and capability development;*
- (iii) <u>Gisenyi-based MULPOC</u>: the Economic Community of Central African States, the Economic Community of the Great Lakes Countries and the Kagera Basin Organization in selection, formulation and programming of economic integration projects;*
- (iv) <u>Niamey-based MULPOC</u>: the Economic Community of West African States, the Economic Community of West Africa and subregional organizations in selection, formulation and programming of economic integration projects;

- (v) Yaoundé-based MULPOC: two workshops: the establishment of an agricultural research network in Central Africa; transit facilitation for customs and transport officials and operators in countries of Central Africa; subregional symposium on intermediate food technologies for women in Central Africa;
 - (c) Field projects
- (i) <u>Lusaka-based MULPOC</u>: operationalization of Eastern and Southern Africa Development Information System; development and implementation of common policies and programmes for achieving food self-sufficiency in Eastern and Southern Africa, including maize research network; feasibility study on local production of school and university textbooks; development of food-processing projects aimed at promoting women's entrepreneurship;
- (ii) <u>Gisenyi-based MULPOC</u>: production and marketing of embroidery products in the Economic Community of the Great Lakes Countries;
- (iii) Yaoundé-based MULPOC: establishment of an agricultural research network for the Yaoundé-based MULPOC subregion; cooperation between the Member States of the subregion in deep-sea fishing, fish conservation and processing technologies.
- 6. Coordination, harmonization and liaison: liaison with the specialized agencies (Food and Agriculture Organization of the United Nations (FAO), United Nations Industrial Development Organization (UNIDO), International Telecommunication Union (ITU), International Trade Centre (ITC), United Nations Conference on Trade and Development (UNCTAD), United Nations Environment Programme (UNEP)) and beneficiary organizations in connection with management of multisectoral projects.

Resource requirements (at revised 1991 rates)

New posts

23.18 It is proposed to establish five new Professional posts (two P-5, two P-4 and one P-3) in order to strengthen the capacity of MULPOCs in the promotion of the subregional economic cooperation and integration in Africa. The above posts would be distributed as follows:

- Two P-5 posts to accommodate an agronomist (Niamey) and a transport economist (Yaoundé);
- Two P-4 posts to accommodate a mining engineer (Lusaka) and an agronomist (Tangier);
- One P-3 post to accommodate an agronomist (Gisenyi).

It will be recalled that in a report concerning the functioning of MULPOCs (A/C.5/45/57), it was indicated that the staff resources of the MULPOCs would need to be increased by eight additional Professional posts and by 10 General Service posts and that this would be dealt with in the context of the 1992-1993 proposed programme budget. At this stage, the establishment of five posts is proposed and possibilities for redeployment within the secretariat of the Commission will be explored.

Temporary assistance

23.19 The requirements of \$377,000 will be utilized to recruit temporary staff (interpretation, translation and short-term conference personnel) required to service MULPOCs-related meetings and to obtain support services such as cleaning and security.

Consultants

23.20 The estimated requirements of \$12,000 relate to specialized expertise required for the preparation of reports.

Travel of staff

23.21 The estimated requirements of \$293,800 relate to travel of staff: (a) to service MULPOCs-related meetings; (b) consultations with and participation in activities of various subregional intergovernmental organizations in Africa; and (c) collection of data in preparation of reports and publications by and in support of the work of MULPOCs.

Operating expenses

23.22 The estimated requirements (contractual services, \$115,800; general operating expenses, \$386,600; supplies and materials, \$100,100; and furniture and equipment, \$74,900) relate to the maintenance and operating costs of the MULPOC offices.

Subprogramme 3. Agricultural and rural development*

23.23 During the biennium 1992-1993, emphasis will be placed on assisting ECA members in formulating and implementing appropriate policies and strategies, with a view to attaining self-sufficiency in food and enhancing national and regional capabilities and the capacity for self-sustaining in the production systems of African agriculture. This subprogramme will be implemented by the Joint ECA/FAO Agriculture Division.

Activities:

1. Parliamentary services

Subprogramme 4. Marine affairs

23.27 During the biennium 1992-1993, emphasis under the subprogramme will be given to development of capabilities in African Member States for effective exploration, exploitation and utilization of vast living and non-living resources known to exist in African seas. Efforts will be made to provide assistance to Member States in elaborating appropriate policies, legislation and strategies to develop capabilities in enhancing productivity and to adopt new and appropriate technologies in developing resources of the sea. Assistance will be provided in promoting subregional and regional cooperation in the implementation of the provisions of the United Nations Convention on the Law of the Sea.

Activities:

1. Published material

Two non-recurrent publications: current development status, policies, strategies and legal frameworks for developing marine resources in selected African Member States;* study on current status of awareness, ratification and progress in the implementation of the provisions of the United Nations Convention on the Law of the Sea in selected African Member States.

Subprogramme 5. Least developed, land-locked and island countries

23.29 The subprogramme aims at being a focal point in developing strategies and programmes for enhancing the regional cooperation in the interests of African least developed, land-locked and island countries. It will assess international efforts as they relate to the promotion of the necessary structural changes and transformation required to overcome the extreme economic difficulties of the least developed, land-locked and island countries, through the improvement of aid modalities. Studies will also be undertaken on efficient macro-economic management, developing structural adjustment and stabilizing programmes of the economies, including effective mobilization and efficient utilization of domestic and human resources.

Activities:

1. Parliamentary services

Parliamentary documentation: two reports to the Conference of Ministers of African least developed, land-locked and island countries on review of economic and social conditions in African least developed, land-locked and island countries;* and on review and appraisal of the implementation of the New Programme of Action for the least developed, land-locked and island countries.*

Three non-recurrent publications: critical evaluation of trade and balance of payments problems of African least developed, land-locked and island countries; food (including fisheries and livestock) and agricultural policies in the least developed, land-locked and island African countries: retrospect and prospects;** role of financial intermediaries in the mobilization and utilization of household savings in the African least developed, land-locked and island countries: interlinks between organized and informal circuits.

Subprogramme 6. Public administration and fiscal affairs

23.31 The subprogramme will aim at improving the performance of public services and financial management systems. Assistance will be provided to Member States in the formulation of fiscal policies and development of measures for mobilizing and allocating resources to development programmes. Assistance will also be provided for the strengthening of capabilities of national and subregional training and research institutions and associations dealing with improvement in public administration and management, budgetary and taxation systems, policies and administration.

Activities:

23.35 During the biennium 1992-1993, the activities of the subprogramme will focus on assistance to Member States, related social development institutions, organizations and agencies for providing expert advice in the design and evaluation of appropriate policies, programmes, strategies and services for the effective integration and participation of youth, disabled persons and the aged in the social and economic mainstream for the prevention of criminal and juvenile delinquency.

Subprogramme 8. Advancement of women

23.39 Emphasis will be given to the enhancement of women's skills that would enable them to play a more effective role in the productive sectors: agriculture and agro-industries, formal and informal sectors of the economy both as producers and decision makers. Particular attention will be paid to the improvement of the position of women for the control of production and distribution services through training seminars, workshops, meetings and studies. In addition, overall analysis on emerging socio-economic trends and their impact on African women will continue to be carried out.

Activities:

Subprogramme 9. Environment and development

23.44 During the biennium 1992-1993, the subprogramme will be oriented to the development and strengthening of national, subregional and regional capabilities needed for environment management, assessment and conservation. Emphasis will be placed on the development of institutional and manpower capabilities and providing policy and administrative guidelines for ensuring sound management of environmental programmes.

Activities:

Subprogramme 10. Human settlements

23.48 The subprogramme will focus on redressing the rural/urban imbalance through formulation and implementation of policies, programmes and projects, in particular by identifying settlement policy issues, and developing and promoting guidelines for the formulation and implementation of national settlements policies aimed at balanced spatial distribution of population and economic activities within the context of a sound environment along with land reforms and the promotion of rural townships; strengthening the indigenous construction sector through the development of indigenous skills, low-cost building materials and small-scale production units and transfer of appropriate technology.

Activities:

Parliamentary documentation: two reports to the Joint Intergovernmental Regional Committee on Human Settlements and Environment on integration of human settlements planning with the overall economic development planning process;* and on implementation of the regional project for the development of building materials industries in Africa.**

Subprogramme 11. Industrial development in Africa*

23.52 The focus will be on research studies that would assist member countries to formulate appropriate industrial policies and to more effectively implement industrial programmes that would bring about the revitalization and restructuring of the industrial sector; promotions of industrial programmes and projects by supporting national and multinational resource-based and core industries, including small-scale industries (agro-based, chemical, metal, engineering, and electrical/electronics). In the context of the United Nations Second Industrial Development Decade for Africa, emphasis will be placed on strengthening the technological and entrepreneurial capabilities of African countries at national, subregional and regional levels. In this regard particular attention will be paid to small-scale, cottage and rural industries. The subprogramme will also assist Member States in building and strengthening subregional and regional institutions for industrial development in the fields of technology, standardization, production and management.

Activities:

1. Parliamentary services

Parliamentary documentation:* three reports to the Conference of African Ministers of Industry on problems, policies, issues and prospects by the year 2000 of Africa's basic industries, namely: chemical, metal, engineering industries; on assessment of policies and strategies for the rehabilitation and revitalization of selected industrial subsectors; and on progress made in the implementation of the programme for the second Industrial Development Decade for Africa.

Published materials

- (a) Two recurrent publications: focus on African industry, including review of progress on the Second Industrial Development Decade (annual);* directory of project profiles on small-scale industries (two issues);

African countries in the context of the Second Industrial Development Decade; the role of industrial free zones in the industrialization of the African countries in the context of the Second Industrial Development Decade; technical handbook on composite and non-wheat flours in the context of the Second Industrial Development Decade.

3. Four ad hoc expert groups on: the promotion of investment in industrial projects in the context of the Second Industrial Development Decade (two meetings);* the possibility of production of basic chemicals from natural gas (two meetings).

- (c) Eight field projects: survey of the industrial sector in the Economic Community of the West African States; engineering design and manufacturing of equipment for processing of agricultural products; strengthening the African Regional Center for Engineering Design and Manufacturing capacity in African countries; development of the Engineering Industrial Development Programme in Central and West African subregions with special emphasis on agricultural machinery and equipment, low-cost transport equipment, machine tools and spare parts; establishment of pilot demonstration plan on composite flour to serve as a model for the neighbouring countries; promotion and development of small-scale industries in the African region with special consideration of women employment; identification and pre-feasibility studies of selected multinational industrial core projects within the framework of the second Industrial Decade; application of the compact mini-plants technology for the manufacturing of steel products in African countries.
- 5. <u>Coordination, harmonization and liaison</u>: liaison with organizations of the United Nations system on the follow-up to the United Nations Second Industrial Development Decade for Africa.

Subprogramme 12. Trade development and cooperation

23.56 The strategy for the biennium 1992-1993 will be significantly different from that elaborated in the present period. The institution-building process for trade promotion and cooperation is about to be completed and new efforts will be directed towards the strengthening of operational capabilities of those institutions. In that context, priority will be given to supporting the development of import-substitution policies, market research, demand and supply analysis and trade facilitation at the country, regional and interregional levels. The secretariat will disseminate the findings of studies and analyses. The secretariat will assist the Commission in developing trade promotion strategies and mechanisms and their coordination with activities of UNCTAD, GATT, OAU and the Group of 77 to improve the export performance of the African countries and improve the foreign exchange capabilities, strengthening existing trade institutions at the national and subregional level through, inter alia, specific-targeted training and skills upgrading programmes in the field of trade.

Subprogramme 13. External debt crisis

23.60 The focus will be on practical solutions to Africa's mounting external debt burden. In that context, efforts concentrate on in-depth and extensive research and analysis of the structures and magnitudes of Africa's debt problem with a view to identifying the root causes of the debt crisis as well as the possibilities of linking of debt management programmes at all levels with the overall financial and monetary objectives of Member States. The ECA secretariat will organize workshops, meetings, advisory missions and studies, with emphasis placed on: assessing the impact of the developments in the international economic environment on the reduction of Africa's debt stock and debt-servicing; elaborating more intensive programmes and policies for both external and internal debt and resources management; assessing, in cooperation with other organizations and financial institutions, the appropriateness or adequacy of the initiatives taken so far in solving the African debt problem in view of defining a new approach placing the debt in a growth context.

Activities:

1. <u>International cooperation</u>

External relations: missions of liaison and consultations with regional and interregional intergovernmental organizations and financial and monetary institutions, including OAU, the African Development Bank and the African Centre for Monetary Studies, on issues of external debt crisis in Africa.

2. Published materials

- (a) Three non-recurrent publications: effective strategies for the alleviation of Africa's external debt burden; review of Africa's external debt situation and the impact of declining commodity prices on Africa's capacity to service its external debt; analysis of the impact on Africa's external debt of initiatives so far taken to alleviate the continent's external debt burden (2 issues);**

Subprogramme 14. Monetary and financial policies and strategies

23.63 Activities will focus on measures to be elaborated for halting or reversing the downward trends in resource inflows, especially on concessional terms. New practical solutions will be sought to deal with the problems of inadequacy of financing, including low domestic savings. Through research, studies and analyses of developments and trends in that sector of the African economy, the measures will be devised for assessing the impact of external development on the African economies, particularly of the new monetary arrangements within the European Monetary System; strengthening of existing institutions for regional monetary and financial cooperation and the establishment and operationalization of the African Monetary Fund; reversing the flight of capital and attracting direct foreign investments, especially in subregional and regional projects and programmes and fostering increased self-reliance in financing development through more intensive programmes for domestic savings and resources mobilization.

Activities:

External relations: liaison and cooperation with intergovernmental organizations and global, regional and subregional monetary and financial institutions, such as OAU, IMF, the African Development Bank and others on issues of monetary and financial policies and strategies in Africa.

Subprogramme 15. Natural resources

23.66 Activities will focus on the establishment and strengthening of institutions for utilization of mineral resources at subregional level, the building up of Member States' knowledge on minerals development and utilization and the development, analysis and streamlining of minerals development policies and the impact of mining activities and minerals utilization on the environment. In the field of cartography and remote sensing, the activities will be oriented towards the development and strengthening of institutional, technological and human capabilities in data acquisition, its analysis and utilization for natural resources and environmental management as well as streamlining policies and strategies in surveying, mapping and remote sensing in Africa. Substantive and technical services will be provided to the Eighth United Nations Regional Cartographic Conference for Africa including commemorative activities for the International Space Year (1992),* the intergovernmental meeting of Senior Officials of the Nile River Basin countries and the Fifth Regional Conference on the Development and Utilization of Mineral Resources in Africa.

External relations: cooperation and liaison with regional and subregional intergovernmental organizations and institutions on issues of natural resources development activities, including mineral and water resources and integrated river basins development.

Subprogramme 16. Energy including new and renewable*

23.70 Emphasis will be placed on assisting Member States in undertaking a systematic and comprehensive inventory of conventional and renewable sources of energy in Africa and monitoring and analysis of African energy situation with the emphasis on energy supply, use and related energy policies; eliminating a lack of adequate energy policy and strengthening planning research capacity and management in African countries; furthering the development and efficient use of new and renewable sources of energy in Africa and study on their contribution to the Africa energy supply; strengthening the institution and capacity-building through training of African researchers, engineers and technicians and support to the African Regional Centre for Solar Energy and to the Technical Committee of Nuclear Science and Technology.

Activities:

Subprogramme 18. Population

23.76 The work programme will address population issues dealing with facilitating the integration of population factors into socio-economic development planning in the region; assisting in formulating and implementing relevant population programmes and policies, in evaluating family planning programmes, in establishing or strengthening national population information systems, and in analysing and utilizing demographic data, as well as in training of related personnel. Moreover, studies, research and/or training workshops will be undertaken on the evaluation of family planning and birth spacing programmes, fertility, mortality, population distribution and urbanization.

Subprogramme 19. Transport and communications*

23.79 Activities under the subprogramme will be oriented towards the facilitation and promotion of regional cooperation for the development of transport, telecommunications and postal services. Particular attention will be paid to the promotion of inter-country traffic networks; the improvement of manpower planning, development and management for the provision of better transport, telecommunications and postal services; the facilitation of rehabilitation and maintenance programmes of transport infrastructures; the extension of transport, telecommunications and postal networks; the promotion of transport safety, particularly in roads and road transport; promotion of technologies development in the fields of transport and communications; development of manufacturing capability for the production of transport and communication equipment.

Activities:

1. International cooperation

External relations: liaison with regional intergovernmental organizations such as OAU, the Economic Community for West African States, the Preferential Trade Area, governmental organizations and regional transport and financial institutions, such as the African Civil Aviation Commission, the African Airlines Association, the Union of African Railways, on various issues of transport and communications development in Africa.

Parliamentary services

23.80 The reclassification of the post of the Chief of the Transport Operations Section in the Transport, Communications and Tourism Division from P-4 to the P-5 level is proposed in view of the supervisory responsibilities attached to the post.

Consultants

23.81 The estimated requirements of \$18,400 relate to specialized expertise required in preparation of publications under the work programme.

Ad hoc expert group

23.82 The proposed provision (\$19,500) is for the ad hoc group meeting to review guidelines on development of subregional cooperation in shipping in Africa.

Travel of staff

23.83 The estimated requirements of \$118,900 relate to travel to service meetings of intergovernmental organs under the programme (\$29,200), participation in activities and consultations with regional intergovernmental transport and financial institutions and organizations (\$37,000) and collecting data for preparation of reports and publication and providing advisory services to Member States (\$52,700).

Subprogramme 20. Tourism

23.84 Activities will be oriented towards improving the systems and facilities for increasing tourism in Africa. Specific attention will be paid on strengthening intra-African cooperation in this field through the collection and dissemination of information on policies and practices of Member States in developing of tourism industry.

Activities:

1. Parliamentary services

Parliamentary documentation: two reports to the Conference of African Ministers of Tourism on the implementation of Conference resolutions adopted at its third session, and on the development of tourism in Africa.

2. Published material

Three non-recurrent publications: vocational training in the field of tourism; tourism product management in Africa; ** the promotion of integrated tourist circuits in Africa.

3. Operational activities: advisory services in the field of tourism.

Resource requirements (at revised 1991 rates)

Consultants

23.85 The estimated requirements of \$18,000 is for obtaining specialized expertise in preparation of non-recurrent publications under the programme of work.

Travel of staff

23.86 The estimated requirements of \$10,100 relate to trips to collect supplementary information in the preparation of reports and to advisory missions under the programme of work.

Subprogramme 21. Statistical development

23.87 Activities will be designed to assist African countries in establishing and/or developing a durable infrastructure for the collection, processing, analysis and dissemination of integrated demographic, social, economic and environment statistics; to develop the statistical data required for planning, monitoring and evaluating social and economic development; to provide continuous support for developing national data-processing capabilities, especially by enhancing the utilization of micro-computers; and, to promote the improvement of the quality, relevance, timeliness and intercountry comparability of the data being collected.

Activities:

1. Parliamentary services

Parliamentary documentation: seven reports to the Joint Conference of African Planners, Statisticians and Demographers on: ECA statistical activities during 1990-1991 and future work programme;* statistical requirements for monitoring and evaluating short-term policy reforms and long-term development programmes;* progress and problems in the implementation of the Plan of Action for Statistical Development in Africa in the 1990s;* progress made in the revision of the United Nations system of national accounts;* the implementation of International Trade Commodity Classifications in African countries; integration of economic, social and environment statistics: sources and methods; priorities for energy statistics in Africa, with special emphasis on new and renewable sources of energy.

External printing and binding

23.90 The estimated requirements under this heading (\$44,800) relate to the publication of African Statistical Yearbook and Foreign Trade Statistics for Africa.

23.91 This subsection encompasses information services, conference and library services, management of technical cooperation and administration and common services.

Activities:

1. <u>Information services</u>

Services to be provided relate to ECA activities, as well as those undertaken jointly with the Department of Public Information of the Secretariat (DPI), including issuance of: (i) ECA at a Glance; (ii) weekly Africa Hall News; (iii) ECA Quarterly; (iv) booklet: ECA Today; (v) information sheets; (vi) press releases, and organizing exhibits (23 each year); film and video cassette shows, guided tours, lectures, seminars and commemorative programmes on special events. Other activities to be undertaken are liaison with the news media (including press conferences and interviews), governmental and non-governmental organizations, educational institutions, libraries and other local redisseminators of information as well as provision of information on ECA activities for inclusion in regular worldwide United Nations programmes and regional media channels.

2. Conference and library services

Activities will include the provision of conference services to meetings of the policy-making bodies of ECA, their subsidiary bodies, and other intergovernmental meetings to be held under ECA auspices; the editing, translation, and printing of documents and publications; and the provision of library services to be provided by the Division of Administration and Conference Services.

The following policy-making organs and their subsidiary bodies will receive services:

- (i) Conference of Ministers $\underline{1}$ / (seventeenth and eighteenth sessions, 1992, 1993);
 - (ii) Technical Preparatory Committee of the Whole (1992, 1993);
- (iii) Joint Conference of African Planners, Statisticians and Demographers (1992), preceded by its Committee of Planners, Statisticians and Demographers (1992);
- (iv) Intergovernmental Meeting of Planners, Statisticians and Demographers (1993);
 - (v) Conference of African Ministers of Finance (1992 and 1993);
- (vi) Joint Intergovernmental Regional Committee on Human Settlements and Environment (1993);
- (vii) Technical Advisory Committee for the Development of Nuclear Science and Technology in Africa (1992, 1993);

- (xxii) African Regional Coordinating Committee for the Integration of Women in Development (1992 and 1993);
- (xxiii) Conference of Ministers of African Least Developed Countries (1992), preceded by its Committee of Experts of African Least Developed Countries (1992).
 - 3. Management of technical cooperation activities

Services to be provided include the formulation and management and preparation of reports on projects financed from extrabudgetary sources (some 160 projects), promotion of horizontal cooperation activities among African countries, and coordination of relevant interregional activities.

Four reports would be submitted to the ECA Conference of Ministers as follows: ECA as an Executive Agency (annual), utilization of resources of the Trust Fund for African Development, resource requirements under the Trust Fund for

African Development for the biennium 1994-1995. An annual booklet "ECA as an Executing Agency" would be issued.

Advisory services will be provided to Member States and to groups of countries on the identification of opportunities and preparation of project proposals for promoting regional cooperation.

4. Administration and common services

The Division of Administration and Conference Services would provide services in connection with human resources management, financial administration and resource planning, and use of common services to support the implementation of the work programme. Activities will include: (a) recruitment, placement, career development, staff training and staff administration; (b) financial management, control and treasury services; (c) programme planning, budgeting and monitoring; (d) general services, including security and safety, communications, procurement, transportation, management of construction of new ECA facilities, etc.; and (e) electronic data processing.

Resource requirements (at revised 1991 rates)

New posts

- 23.92 In line with provisions of section II of resolution 45/248 B on strengthening of the ECA Conference Services, it is proposed to establish a new post at the P-4 level for an editor. The incumbent would assume functions of editing ECA documents in its official languages.
- 23.93 It is proposed to establish one P-3 post within the Division of Administration and Conference Services for a system analyst in connection with the newly established ECA automation system. The incumbent would also assist the Chief of the ECA Automation Unit in managing the system and ensuring its further development.

Redeployment of posts

23.94 In line with provisions of section II of resolution 45/248 B on strengthening of the ECA Conference Services, it is proposed to redeploy to that organizational unit a P-5 post from subprogramme 7, Social development, and one P-2 post within the Division of Administration and Conference Services. The incumbent of the P-5 post would assume responsibilities for planning and organizing ECA meetings and conferences and would also exercise supervisory functions over the newly established Editorial Unit within the Conference Services. The P-2 post would be for editorial functions.

Temporary assistance

- 23.95 The estimates of \$1,479,600 relate to the following activities:
- (a) Temporary assistance for meetings (\$807,600), which would be required for the servicing of intergovernmental meetings of the Commission and its subsidiary bodies listed in paragraph 23.91 above;

(b) General temporary assistance (\$672,000), involving negative growth of \$75,000 is for the whole of ECA and will provide for replacement of staff on extended leave and for additional assistance during peak workload periods.

Consultants

23.96 The requested provision under this heading (\$6,700) will cover the cost of obtaining outside expertise to teach specialized drafting courses in the context of the staff training programme.

Overtime

23.97 The amount requested (\$183,400) relate to work in connection with the servicing of intergovernmental meetings, as well as additional requirements during peak workload periods.

Travel of staff

23.98 The requested provision (\$294,000) relates to the substantive servicing of intergovernmental meetings and to travel of administrative staff within and outside the region for coordination and consultations.

Staff training

23.99 The estimated requirements of \$970,300 relate to: (a) provision of language training for the ECA staff (\$259,600), which comprises a resource growth of \$50,000 due to the need to recruit four additional part-time French language teachers; (b) provision for the reviving of training programme for translators/interpreters at ECA in accordance with requirements of section II of resolution 45/248 B (\$710,700); this provision comprises costs for contractual training of 15 trainees in educational institutions within Africa, including related travel costs (\$86,700), stipends (\$459,000) and education fees to be paid to the institutions (\$165,000).

External printing and binding

23.100 The provision (\$35,400) will cover the publications programme of ECA as a whole.

General operating expenses

23.101 The requirements (\$3,517,200), involving negative growth of \$325,000, have been estimated on the basis of current experience and past expenditure patterns. They relate to rental and maintenance of premises and equipment, including the newly installed electronic equipment, communications, official functions and other operational requirements of ECA under the programme.

Supplies and materials

23.102 The requirements (\$1,670,800) will provide for the purchase of stationery and other expendable and non-expendable office supplies and materials for electronic and data-processing equipment operations, internal reproduction, public information and training; it will also provide for library books and supplies and subscriptions to publications and technical periodicals.

Furniture and equipment

23.103 The estimated requirements (\$556,900) will provide for replacement of existing furniture and office equipment in accordance with the normal replacement schedule. The increase of \$200,000 relate to a need for new office furniture.
