

PROPOSED ADDITIONAL ACTIVITIES FOR 1992-1993

Summary

The Executive Director reports on the implementation of the supplementary programme for the biennium 1990-1991, as approved by Governing Council decision 15/1, section VI, of 25 May 1989, and proposes a few adjustments to the allotted figures in order to assign resources to the highest priority activities.

On the basis of the possibility of additional contributions over and above the target of \$110 million for 1993, the Executive Director proposes an additional appropriation of \$25 million for Fund programme activities.

I. SUPPLEMENTARY PROGRAMME OF ENVIRONMENT FUND ACTIVITIES
FOR THE BIENNIUM 1990-1991

1. In the last few years, it has become evident that the resources available to the Environment Fund have been insufficient to meet the ever-increasing environmental challenges and the corresponding requests for action that UNEP received from the Governing Council and the General Assembly. At the fifteenth session of the Governing Council the Executive Director drew up a list of the additional tasks that UNEP was called upon to undertake as a result of the growing international awareness of environmental problems, and asked the Council to approve an appropriation of \$35 million for additional activities to carry out these tasks, over and above the level required to finance programme activities in 1990-1991.
2. In its decision 15/1, section VI, the Council confirmed that the programme of activities approved within the appropriation of \$68 million for Fund programme activities for the biennium 1990-1991 did not cover all of the urgent environmental activities that it wished the programme to undertake during that biennium, and approved a supplementary appropriation of \$35 million for Fund programme activities. This appropriation, as presented in the annex to the decision, was to "become effective only as and when contributions become available to the Fund above the level required to finance the whole of the programme of activities within the previously approved appropriation of \$68 million". In that same decision, the Executive Director was requested "to consult with the Committee of Permanent Representatives on the implementation of the supplementary programme as and when the additional resources become progressively available".
3. In 1990, a total of approximately \$19 million became available over and above the approved appropriation of \$68 million for the biennium 1990-1991. Accordingly, in consultation with the Committee of Permanent Representatives, two tranches of additional expenditures totalling \$14.2 million were approved in 1990 on the basis of the list of activities contained in the annex to decision 15/1.
4. An analysis of how the two tranches were allocated to activities as set out in decision 15/1 is included in the Executive Director's Annual Report for 1990 (see UNEP/GC.16/3, annex III, B). Annex I to the present report shows the financial status of implementation of the supplementary programme. Annex II indicates the proposed adjustments, new titles and use of the balance of appropriations and annex III provides information on the use of these resources. In spite of some delays due to the uncertainties resulting from the conflict between Iraq and Kuwait, good progress was made in implementing the supplementary programme.

II. PROPOSED ADJUSTMENT OF THE SUPPLEMENTARY PROGRAMME
FOR THE BIENNIUM 1990-1991

5. At the time the Council meets for its sixteenth regular session, there will remain a balance of \$20.8 million from the total appropriation of \$35 million approved by the Governing Council. Should additional contributions be received in 1991, the Executive Director, in consultation with the Committee of Permanent Representatives will approve new sets of allocations from the supplementary programme.

6. The Executive Director would like to propose a few adjustments to the figures approved by the Council. The proposed adjustments are shown in the last column of annex I to the present report. Resources would be re-allocated from several activities to highest-priority activities, with a total amount of \$6.0 million distributed as follows:

- (a) Activity 1. Studies on the implications of climate changes and rising sea-level in coastal areas: \$0.5 million;
- (b) Activity 8. Preparation of a framework convention on conservation and rational use of biological diversity. The holding of two more meetings of the Intergovernmental Negotiating Committee during 1991; meetings of the Bureau; meetings of experts to advise the secretariat; the initiation of country case studies on biological diversity: \$4 million;
- (c) Activity 20. Contribution to the preparations for the 1992 United Nations Conference on Environment and Development: \$1.5 million.

III. PROPOSED SET OF ADDITIONAL ACTIVITIES FOR THE BIENNIUM 1992-1993

7. In its decision 15/1 the Council also agreed to set a target of \$100 million for contributions to the Environment Fund by the year 1992, and authorized the Executive Director, in decision 15/46, to draw up a programme for Fund activities and Fund reserve activities in 1992-1993 of \$180 million (see UNEP/GC.15/12 and Corr.2). At that time, estimated contributions for the 1992-1993 biennium were \$210 million, i.e. the targeted \$100 million for 1992 plus \$110 million for 1993. This latter figure takes into account a 5 per cent increase in real terms and a 5 per cent increase due to the inflation rate over the two years of the biennium.

8. In his report to the second special session of the Governing Council in August 1990, (see UNEP/GCSS.II/2, paras. 158-161) the Executive Director suggested that the \$100 million target be attained at an earlier date, i.e. 1991, and that the Council consider setting a target for annual contributions of approximately \$250 million by the year 1995, which would mean a 35 per cent annual increase in contributions. The Council in its decision SS.II/1 requested, inter alia, that a detailed report explaining the basis of the recommendations for a substantially increased fund target for 1995 be submitted to the Council at its sixteenth regular session. The report is to be found in documents UNEP/GC.16/23 and Add.1 and UNEP/GC.16/4/Add.5.

9. The proposed 35 per cent increase in contributions, if adopted by the Council, would imply an increase in the target for the 1993 contributions, which would reach \$135 instead of \$110 million. This means that \$25 million in additional activities would have to be programmed for 1992-1993. Further details on the planned use of resources in 1992-1993 are found in document UNEP/GC.16/23.

10. Accordingly, the Council is invited to consider an additional appropriation for Fund programme activities for the biennium 1992-1993 of \$25 million, over and above the \$180 million planned for the programme budget during the biennium, on the understanding that this additional appropriation will be used only as and when additional resources become available after the whole of the core and supplementary programme of \$180 million has been initiated, and after consultation with the Committee of Permanent Representatives. A list of proposed additional activities is contained in annex IV to the present report.

The total cost to UNEP of its support to UNCED is estimated at over US\$2 million, including the cost of preparation of the 1992 State-of-the-Environment report. This leaves a balance of US\$0.5 million to meet other requests of the Preparatory Committee.
