Note verbale dated 21 April 1986 from the Chargé d'affaires of the Permanent Mission of Afghanistan to the United Nations addressed to the Secretary-General

The Chargé d'affaires of the Democratic Republic of Afghanistan to the United Nations presents his compliments to the Secretary-General of the United Nations and has the honour to inform that the Chargé d'affaires of the Pakistan Embassy at Kabul was summoned to the Ministry of Foreign Affairs of the Democratic Republic of Afghanistan on the morning of 18 April 1986 and the following was conveyed to him by the Director of the First Political Department:

On 11 April 1966, two groups of military aircraft of Pakistan, each comprising two aircraft, made reconnaissance flights at 5.30 a.m. and 12 noon to a depth of 5 kilometres and 8 kilometres at Zhawra area on the security posts of Khost Division and then returned to Pakistan.

The Government of the Democratic Republic of Afghanistan once again denounces this aggressive act of the Pakistani military régime; lodges its protests with the Government of Pakistan and demands that the Pakistani military authorities put an end to their provocative actions, which will lead to nothing but a deterioration of the situation in the borders.

In order to camouflage their provocative and aggressive actions against the Democratic Republic of Afghanistan, the Pakistani authorities have alleged that the armed forces of the Democratic Republic of Afghanistan made aggressions against Chamarkand region, around Chaman Nishter and Garket on 3, 4 and 5 April 1986.

After making a thorough investigation of the matter, the Government of the Democratic Republic of Afghanistan declares the claim to be false and decisively rejects it.
