ANNEX I

STATEMENT OF THE SUPREME NATIONAL COUNCIL OF CAMBODIA

The Supreme National Council of Cambodia (SNC) met in Pattaya (Thailand), on the afternoon of 24th June 1991, under the very high chairmanship of H.R.H. Samdech Norodom Sihanouk and unanimously adopted the following points; while waiting for the examination of the other points inscribed in the Agenda:

I. To request H.R.H. Samdech Norodom Sihanouk to write on behalf of the SNC:

- 1. To the United Nations Secretary-General requesting the inscription of the Monuments of Angkor in the UNESCO World Heritage List;
- 2. To the Executive Agent of the Mekong Committee requesting the resumption of membership of Cambodia to the Mekong Committee;
- 3. To the World Bank and the International Monetary Fund for the sending of a SNC delegation to attend the next meeting of the World Bank and IMF in Bangkok (Thailand);
- 4. To the United Nations Secretary-General asking for humanitarian assistances and for the vocational training of Cambodians.

II. To set up an SNC Secretariat.

MANEX II

STATEMENT OF THE SUPREME NATIONAL COUNCIL OF CAMBODIA

The Supreme National Council of Cambodia met in Pattaya (Thailand) in the afternoon of 25th June 1991, under the very high chairmanship of H.R.H. Samdech Norodom Sihanouk and unanimously adopted the following points:

1. To set up the SNC headquarters in Phnom Penh, with the following facilities and guarantees:

- Members of the SNC from each party have their own residence protected by that party's forces. The forces of members of the SNC ensure the security within the compound of their residence, while the forces of the host party ensure the security outside the compound;
- The representatives of the two Co-Chairmen of the Paris International Conference on Cambodia (PICC) have their permanent mission accredited to the SNC;
- The Special Representative of the UN Secretary-General or his representative has his own permanent mission to the SNC;
- The representatives of countries participating in the PICC or the representatives of the Perm-Five as well as the representatives of the ASEAN countries have their permanent missions accredited to the SNC;

2. Pending the setting up of the SNC headquarters in Phnom Penh, to hold the next meetings of the SNC at the former Embassy of Cambodia in Bangkok (Thailand).
