State of preparedness of documentation for the session

Note by the Secretariat

1. By Economic and Social Council resolutions 1979/1 and 1979/69 on the control and limitation of documentation, the Council reiterated that the Secretariat should circulate the relevant documentation in all working languages six weeks before the opening of the sessions of the Council and its subsidiary organs, and invited the Secretariat to take steps to ensure effective compliance with rule 13, paragraph 4, of the rules of procedure of the Council. By resolution 1979/69, the Council requested the Secretariat to inform the Council and its subsidiary bodies, in the relevant annotated agenda, which documents had not been issued in accordance with the six-week rule, with a full explanation of the reasons which prevented their circulation. At its thirty-fourth session, the General Assembly, by paragraph 2 of resolution 34/50, decided that the aforementioned resolutions should be applied to the Assembly and its subsidiary organs as well.

2. Since the Committee on Crime Prevention and Control is scheduled to meet at Vienna from 5 to 14 March 1986, the documentation for that session should have been submitted to the Office of Secretariat Services for Economic and Social Matters by 8 January 1986 and circulated by 29 January 1986. The documents to be issued for the session are listed in the annex below. The submitting Department has informed the Office of Secretariat Services for Economic and Social Matters that the delay in submitting the documents for the Committee on Crime Prevention and Control was due to the multidisciplinary nature of the subject, calling for consultations with many offices in order to obtain the appropriate clearances in accordance with established procedures.
