Afghanistan to the United Nations addressed to the Secretary-General

The Permanent Representative of the Democratic Republic of Afghanistan to the United Nations presents his compliments to the Secretary-General of the United Nations and has the honour to inform him that the Chargé d'affaires of the Pakistan Embassy at Kabul was summoned to the Ministry of Foreign Affairs of Afghanistan at 10 a.m., on 3 June 1986, and the following was brought to his attention by the Director of the First Political Department:

The Government of Pakistan has once again asserted that the armed forces of the Democratic Republic of Afghanistan have allegedly attacked Domandi area of Chaman on 10 May, Teri Mangal and Paywar Kotal on 13 May, Balahesar of Kurram Agency on 14 and 17 May, Mardar Baghcha of Chaman on 14 and 15 May, Koteri frontier post and Shadalsar of Kurram Agency on 17 May and Alizay village of Kurram Agency on 19 May 1986.

After thorough investigations and assessment, the Government of the Democratic Republic of Afghanistan considers these charges as totally baseless and void of reality and categorically rejects them. It is further mentioned that Pakistani authorities put an end to such insinuations which have no other result but the aggravation of the situation in the frontier areas.

The Permanent Representative of Afghanistan has further the honour to request the circulation of this note as a document of the General Assembly, under items 70, 71, 127, 132, and 136 of the preliminary list, and of the Security Council.
