REPORT OF THE ECONOMIC AND SOCIAL COUNCIL

Status of the Convention on the Prevention and Punishment of the Crime of Genocide

Report of the Secretary-General

- 1. The General Assembly, by its resolution 260 A (III) of 9 December 1948, adopted and opened for signature, and ratification or accession the Convention on the Prevention and Punishment of the Crime of Genocide. The Convention entered into force on 12 January 1951 in accordance with its article XIII.
- 2. By its resolution 40/142 of 13 December 1985, the General Assembly, mindful of the fact that the year 1986 marked the thirty-fifth anniversary of the entry into force of the Convention, urged those States that had not yet become parties to the Convention to ratify it or accede thereto without further delay; and invited the Secretary-General to submit to it at its forty-first session a report on the status of the Convention. It further requested the Commission on Human Rights to consider at its forty-second session the question of promoting the full implementation of the Convention and to submit its considerations and proposals on that question, through the Economic and Social Council, to the General Assembly at its forty-first session.
- 3. By its resolution 1986/18 of 10 March 1986, the Commission on Human Rights strongly condemned once again the crime of genocide; reaffirmed the necessity of international co-operation in order to liberate mankind from such an odious scourge and also urged "those States that have not yet become parties to the Convention to ratify it or accede thereto without further delay".

- 4. The Economic and Social Council, by its resolution 1986/42 of 23 May 1986, reaffirmed the provisions of the resolution of the Commission on Human Rights mentioned above.
- 5. As at 1 August 1986, the Convention had been ratified or acceded to by 96 States. In addition, four States had signed the Convention. The list of States that have signed, ratified, acceded or succeeded to the Convention, as well as the dates of their signature, ratification, accession or succession is contained in the annex to the present report.
