REVISED PROGRAMME OF WORK

Note by the Secretariat

1. The General Assembly has postponed consideration of the question of the curtailment of the forty-first session by three weeks and decided to draw the attention of the Chairmen of the Main Committees to the desirability of sufficient flexibility in the programmes of work of the respective Committees to allow for an orderly shortening of the session, if the Assembly should so decide.
2. In adopting a programme of work, at its 2nd meeting, on 22 September 1986, the Committee decided to review it when more was known about the closing date for the forty-first session. If the session was shortened, the officers would propose to the Committee a revised programme of work, taking into account the views of all regional groups and the availability of documents. If cuts had to be made, all items on the agenda would be affected as far as possible on a pro rata basis.
3. Subsequently, in response to an appeal by the President of the General Assembly and on the proposal of the Chairman, the Committee, at its 4th meeting, on 6 October 1986, approved a revised programme of work which would enable it to conclude its tasks by the end of November, at the latest, on the understanding that the Committee's decision did not prejudice the closing date of the Assembly.
