23. In Paris, Brussels and Bonn, the mission had extensive exchanges of views with the Governments concerned on the recent Declaration on the Formation of the Coalition Government of Democratic Kampuchea and on the results of the Ho Chi Minh City Conference of 6 and 7 July 1982. By the time the missions to Bangkok and to Stockholm and Vienna took place, the Government of Democratic Kampuchea under the presidency of Prince Norodon Sihanouk had been established. The relevant agenda items of the thirty-seventh session of the General Assembly were also discussed and, in this connection, the Governments concerned reiterated their support for the principles and objectives laid down by the International Conference on Kampuchea and the United Nations resolutions.

24. In Bangkok, after a review of recent developments related to Kampuchea, the discussions focused on the status of relations between ASEAN countries and Viet Nam. Air Chief Marshal Siddhi Savetsila, Minister for Foreign Affairs of Thailand and current Chairman of the ASEAN Standing Committee, briefed the mission on the visits of the Vietnamese Minister for Foreign Affairs, Mr. Nguyen Co Thach, to Singapore, Burma and Malaysia in July 1982. The mission was also briefed on the meeting of 29 July 1982 between the Foreign Ministers of Thailand and Viet Nam. It was pointed out to the mission that, during these exchanges, no substantive progress had been made towards a narrowing of differences on the settlement of the Kampuchean question. The ASEAN countries, had, nevertheless, expressed their willingness to have further dialogue and consultations with Viet Nam.

During its visit to Vienna, the mission reported to the Minister for Foreign Affairs of Austria, Dr. Willibald Pahr, President of the International Conference on Kampuchea, on the Ad Hoc Committee's activities and on its visits to France, Belgium, the Federal Republic of Germany, Thailand and Sweden. For his part, Mr. Pahr briefed the mission on his contacts and consultations with the parties concerned and other interested Governments. He also discussed with the mission the future work of the Committee.

26. In this context, the Ad Hoc Committee wishes to stress that, in accordance with its mandate, it is determined to continue its efforts towards the implementation of the Declaration of the International Conference on Kampuchea and the relevant General Assembly resolutions. It will seek, in particular, to develop further consultations in order to contribute to the initiation of a negotiating process leading to the peaceful resolution of the Kampuchean problem and creating the conditions for a lasting peace, stability and co-operation in the whole region. The Committee expresses the hope that all parties concerned will co-operate towards the early achievement of this goal.
