DRAFT BIENNIAL PROGRAMME OF WORK FOR THE SECOND COMMITTEE FOR 1987-1988

Note by the Secretariat

The General Assembly, in resolution 39/217 of 18 December 1984, paragraph 5, requested the Secretary-General to submit to the Second Committee for consideration and approval each year a proposed biennial programme of work. Owing to constraints of time, the draft biennial programme of work of the Second Committee for 1987-1988, which is annexed to the present document, has been prepared on the basis of existing legislative authority. It also takes into account the draft proposals on which the Second Committee has taken a decision and the draft proposals which are pending action by the Committee. The information contained in the annex, including that on documentation, will be updated orally by the Secretariat when the draft biennial programme of work for 1987-1988 is considered by the Committee.
